- 20 where he was hired by KIKK in Houston; in addition to earning a wide
- 21 following, he was awarded many honors, including the title of
- 22 Number One Country Music Broadcaster in a Major Market by Billboard

- WHEREAS, Mr. Bailey has pursued another interest with equal

- 1 passion; his love of horses and the outdoors, coupled with his
- 2 experience in radio, has made him a natural fit as a rodeo
- 3 announcer; from the early 1970s until the mid 1980s, he was a
- 4 commentator at the annual Texas Prison Rodeo, and his impressive
- 5 work in that role led to a part in the movie Stir Crazy; moreover, he
- 6 has been a dedicated volunteer with the Houston Livestock Show and
- 7 Rodeo since 1992; and
- 8 WHEREAS, In all of his endeavors, Bill Bailey enjoys the love
- 9 and support of his wife, Janis, as well as the couple's two
- 10 daughters; and
- 11 WHEREAS, This esteemed Texan's devotion to duty and
- 12 commitment to excellence have greatly contributed to the betterment
- 13 of Precinct 8 for nearly three decades, and Mr. Bailey may indeed
- 14 reflect with pride on a career well spent as he embarks on the next
- 15 exciting chapter of his life; now, therefore, be it
