

HOUSE CONCURRENT RESOLUTION

1 WHEREAS, The late Dr. Bob Glaze demonstrated a deep
2 commitment to public health during his six terms in the Texas House
3 of Representatives and as a longtime member of the Texas Board of
4 Health, and it is most fitting that he be recognized with the naming
5 of the Department of State Health Services Laboratory Services
6 Section building in his honor; and

7 WHEREAS, Born in Smith County on November 20, 1927, Dr. Glaze
8 was the son of Ben and Erin Glaze; he served his country in the
9 United States Merchant Marine and earned a bachelor's degree in
10 agriculture from Sam Houston State University and a doctor of
11 chiropractic degree from Texas Chiropractic College; and

12 WHEREAS, Dr. Glaze represented House District 5 from 1991 to
13 2002, during which time he played a key role in securing funding for
14 the new DSHS laboratory as a member of both the house appropriations
15 committee and the public health committee, ultimately allowing
16 state employees to move out of a substandard temporary facility;
17 and

18 WHEREAS, In addition, Dr. Glaze served the Texas Board of
19 Health as chair of its legislative committee, and he worked
20 diligently at the state and federal levels to obtain funding for
21 public health initiatives and health care services; he continued to
22 strive to improve health care and health education as a private
23 citizen, and he benefited the medical profession as president of
24 the Texas Chiropractic Association and in other leadership roles;


1 Dr. Glaze passed away on June 25, 2010, at the age of 82; and

6 lasting tribute to his exceptional contributions; now, therefore,

8 RESOLVED, That the 82nd Legislature of the State of Texas
9 hereby recommend the Texas Facilities Commission name the
10 Department of State Health Services Laboratory Services Section
11 building at 1100 West 49th Street in Austin the Dr. Bob Glaze
12 Laboratory Services Section building; and, be it further


13 RESOLVED, That the secretary of state forward an official
14 copy of this resolution to the chair and executive director of the
15 Texas Facilities Commission.




