- 7 SECTION 1. Chapter 5, Education Code, is amended by adding
- 8 Section 5.002 to read as follows:
- 9 Sec. 5.002. REFERENCES TO TEXTBOOK. In this title, a
- 10 reference to a textbook means instructional material, as defined by
- 11 Section 31.002.
- SECTION 2. Subdivision (28), Subsection (b), Section 7.055,
- 13 Education Code, is amended to read as follows:
- 14 (28) The commissioner shall perform duties relating to
- 15 the funding, adoption, and purchase of instructional materials
- 16 [textbooks] under Chapter 31.
- 17 SECTION 3. Subsection (f), Section 7.056, Education Code,
- 18 is amended to read as follows:
- 19 (f) A school district or campus that is required to develop
- 20 and implement a student achievement improvement plan under Section
- 21 39.102 or 39.103 may receive an exemption or waiver under this
- 22 section from any law or rule other than:
- 23 · · (1) a prohibition on conduct that constitutes a
- 24 criminal offense;

- 1 (2) a requirement imposed by federal law or rule;
- 2 (3) a requirement, restriction, or prohibition
- 3 imposed by state law or rule relating to:
- 4 (A) public school accountability as provided by
- 5 Subchapters B, C, D, E, and J, Chapter 39; or
- 6 (B) educator rights and benefits under
- 7 Subchapters A, C, D, E, F, G, and I, Chapter 21, or under Subchapter
- 8 A, Chapter 22; or
- 9 (4) [textbook] selection of instructional materials
- 10 under Chapter 31.
- SECTION 4. Subdivision (23), Subsection (c), Section 7.102,
- 12 Education Code, is amended to read as follows:
- 13 (23) The board shall adopt and purchase or license
- 14 instructional materials [textbooks] as provided by Chapter 31 and
- 15 adopt rules required by that chapter.
- 16 SECTION 5. Subsections (a) and (c), Section 7.108,
- 17 Education Code, are amended to read as follows:
- 18 (a) A person interested in selling bonds of any type or a
- 19 person engaged in manufacturing, shipping, selling, or advertising
- 20 instructional materials [textbooks or otherwise connected with the
- 21 textbook business] commits an offense if the person makes or
- 22 authorizes a political contribution to or takes part in, directly
- 23 or indirectly, the campaign of any person seeking election to or
- 24 serving on the board.
- 25 (c) In this section:
- 26 (1) "Instructional material" has the meaning assigned
- 27 by Section 31.002.

- 1 (2) "Political contribution" has the meaning assigned
- 2 by Section 251.001, Election Code.
- 3 [(2) "Textbook" has the meaning assigned by Section
- 4 31.002.
- 5 SECTION 6. The heading to Section 7.112, Education Code, is
- 6 amended to read as follows:
- 7 Sec. 7.112. REPRESENTATION OF [TEXTBOOK] PUBLISHER OF
- 8 INSTRUCTIONAL MATERIALS BY FORMER MEMBER OF BOARD.
- 9 SECTION 7. Subsection (a), Section 7.112, Education Code,
- 10 is amended to read as follows:
- (a) A former member of the State Board of Education who is
- 12 employed by or otherwise receives compensation from a [textbook]
- 13 publisher of instructional materials may not, before the second
- 14 anniversary of the date on which the person last served as a member
- 15 of the State Board of Education:
- 16 (1) confer with a member of the board of trustees of a
- 17 school district concerning <u>instructional materials</u> [a textbook]
- 18 published by that [textbook] publisher; or
- 19 (2) appear at a meeting of the board of trustees on
- 20 behalf of the [textbook] publisher.
- 21 SECTION 8. Subdivision (2), Subsection (c), Section 7.112,
- 22 Education Code, is amended to read as follows:
- 23 (2) "Instructional material" and "publisher"
- 24 ["Publisher" and "textbook"] have the meanings assigned by Section
- 25 31.002.
- 26 SECTION 9. Subsection (b), Section 11.158, Education Code,
- 27 is amended to read as follows:

- 1 (b) The board may not charge fees for:
- 2 (1) <u>instructional materials</u> [<del>textbooks</del>], workbooks,
- 3 laboratory supplies, or other supplies necessary for participation
- 4 in any instructional course except as authorized under this code;
- 5 (2) field trips required as a part of a basic education
- 6 program or course;
- 7 (3) any specific form of dress necessary for any
- 8 required educational program or diplomas;
- 9 (4) the payment of instructional costs for necessary
- 10 school personnel employed in any course or educational program
- 11 required for graduation;
- 12 (5) library <u>materials</u> [books] required to be used for
- 13 any educational course or program, other than fines for lost,
- 14 damaged, or overdue materials [books];
- 15 (6) admission to any activity the student is required
- 16 to attend as a prerequisite to graduation;
- 17 (7) admission to or examination in any required
- 18 educational course or program; or
- 19 (8) lockers.
- SECTION 10. Subsection (a), Section 11.164, Education Code,
- 21 is amended to read as follows:
- 22 (a) The board of trustees of each school district shall
- 23 limit redundant requests for information and the number and length
- 24 of written reports that a classroom teacher is required to prepare.
- 25 A classroom teacher may not be required to prepare any written
- 26 information other than:
- 27 (1) any report concerning the health, safety, or

- 1 welfare of a student;
- 2 (2) a report of a student's grade on an assignment or
- 3 examination;
- 4 (3) a report of a student's academic progress in a
- 5 class or course;
- 6 (4) a report of a student's grades at the end of each
- 7 grade reporting period;
- 8 (5) a [textbook] report on instructional materials;
- 9 (6) a unit or weekly lesson plan that outlines, in a
- 10 brief and general manner, the information to be presented during

- 12 the elementary level;
- 13 (7) an attendance report;
- 14 (8) any report required for accreditation review;
- 15 (9) any information required by a school district that
- 16 relates to a complaint, grievance, or actual or potential
- 17 litigation and that requires the classroom teacher's involvement;
- 18 or
- 19 (10) any information specifically required by law,
- 20 rule, or regulation.
- 21 SECTION 11. Subsection (e), Section 19.007, Education Code,
- 22 is amended to read as follows:
- 23 (e) The district may participate in the <u>instructional</u>
- 24 <u>materials</u> [textbook] program under Chapter 31.
- SECTION 12. Subsections (a) and (c), Section 26.006,
- 26 Education Code, are amended to read as follows:
- 27 (a) A parent is entitled to:

- 1 (1) review all teaching materials, <u>instructional</u>
- 2 materials [textbooks], and other teaching aids used in the
- 3 classroom of the parent's child; and
- 4 (2) review each test administered to the parent's
- 5 child after the test is administered.
- 6 (c) A student's parent is entitled to request that the
- 7 school district or open-enrollment charter school the student
- 8 attends allow the student to take home any instructional materials
- 9 [textbook] used by the student. Subject to the availability of the
- 10 instructional materials [a textbook], the district or school shall
- 11 honor the request. A student who takes home instructional
- 12 <u>materials</u> [<del>a textbook</del>] must return the <u>instructional materials</u>
- 13 [textbook] to school at the beginning of the next school day if
- 14 requested to do so by the student's teacher. In this subsection,
- 15 "instructional material" ["textbook"] has the meaning assigned by
- 16 Section 31.002.
- SECTION 13. Subsections (a), (c), (h), and (n), Section
- 18 28.002, Education Code, are amended to read as follows:
- 19 (a) Each school district that offers kindergarten through
- 20 grade 12 shall offer, as a required curriculum:
- 21 (1) a foundation curriculum that includes:
- 22 (A) English language arts;
- 23 (B) mathematics;
- 24 (C) science; and
- (D) social studies, consisting of Texas, United
- 26 States, and world history, government, economics, with emphasis on
- 27 the free enterprise system and its benefits, and geography; and

1	(2) an enrichment curriculum that includes:
2	(A) to the extent possible, languages other than
3	English;
4	(B) health, with emphasis on the importance of
5	proper nutrition and exercise;
6	(C) physical education;
7	(D) fine arts;
8	(E) [economics, with emphasis on the free
9	enterprise-system and its benefits;
10	[ <del>(F)</del> ] career and technology education;
11	(F) [(G)] technology applications; and
12	$\underline{\text{(G)}}$ [ $\frac{\text{(H)}}{\text{H}}$ ] religious literature, including the
13	Hebrew Scriptures (Old Testament) and New Testament, and its impact
14	on history and literature.
15	(c) The State Board of Education, with the direct
16	participation of educators, parents, business and industry
17	representatives, and employers shall by rule identify the essential
18	knowledge and skills of each subject of the required curriculum
19	that all students should be able to demonstrate and that will be
20	used in evaluating <u>instructional materials</u> [textbooks] under
21	Chapter 31 and addressed on the assessment instruments required
22	under Subchapter B, Chapter 39. As a condition of accreditation,
23	the board shall require each district to provide instruction in the
24	essential knowledge and skills at appropriate grade levels.
25	(h) The State Board of Education and each school district
26	shall foster the continuation of the tradition of teaching United
27	States and Texas history and the free enterprise system in regular

- 1 subject matter and in reading courses and in the adoption of
- 2 <u>instructional materials</u> [textbooks]. A primary purpose of the
- 3 public school curriculum is to prepare thoughtful, active citizens
- 4 who understand the importance of patriotism and can function

- 6 basic democratic values of our state and national heritage.
- 7 (n) The State Board of Education may by rule develop and
- 8 implement a plan designed to incorporate foundation curriculum
- 9 requirements into the career and technology education curriculum
- 10 under Subsection (a)(2)(E)[(a)(2)(F)].
- SECTION 14. Subsections (a) and (d), Section 28.0022,
- 12 Education Code, are amended to read as follows:
- 13 (a) Not later than November 1, 2007, the agency shall
- 14 establish a panel under this section to:
- 15 (1) review and recommend revisions to the career and
- 16 technical education curriculum under Section 28.002(a)(2)(E)
- 17  $\left[\frac{28.002(a)(2)(F)}{2}\right]$ ; and
- 18 (2) review and recommend revisions for the program in
- 19 which high schools and articulated postsecondary institutions
- 20 allow high school students to take advanced technical credit
- 21 courses.
- 22 (d) Not later than November 1, 2008, the panel shall:
- 23 (1) complete the review as required by this section
- 24 of:
- 25 (A) the career and technical education
- 26 curriculum; and
- 27 (B) the program under which high schools and

- 1 articulated postsecondary institutions allow high school students
- 2 to take advanced technical credit courses; and
- 3 (2) make recommendations to the State Board of
- 4 Education as necessary to:
- 5 (A) increase the academic rigor of the career and
- 6 technical education curriculum under Section 28.002(a)(2)(E)
- 7  $\left[\frac{28.002(a)(2)(F)}{2}\right]$ ; and
- 8 (B) improve and increase participation in the
- 9 program under which high schools and articulated postsecondary
- 10 institutions allow high school students to take advanced technical
- 11 credit courses.
- 12 SECTION 15. Subsection (b), Section 28.003, Education Code,
- 13 is amended to read as follows:
- (b) In this section, "educational program" means a course or
- 15 series of courses in the required curriculum under Section 28.002,
- 16 other than a fine arts course under Section 28.002(a)(2)(D) or a
- 17 career and technology course under Section 28.002(a)(2)(E)
- 18  $\left[\frac{28.002(a)(2)(F)}{F}\right]$ .
- 19 SECTION 16. Subsection (c), Section 28.011, Education Code,
- 20 is amended to read as follows:
- 21 (c) A student may not be required to use a specific
- 22 translation as the sole text of the Hebrew Scriptures or New
- 23 Testament and may use as the basic instructional material
- 24 [textbook] a different translation of the Hebrew Scriptures or New
- 25 Testament from that chosen by the board of trustees of the student's
- 26 school district or the student's teacher.
- 27 SECTION 17. The heading to Chapter 31, Education Code, is

- 1 amended to read as follows:
- 2 CHAPTER 31. <u>INSTRUCTIONAL MATERIALS</u> [TEXTBOOKS]
- 3 SECTION 18. Section 31.001, Education Code, is amended to
- 4 read as follows:
- 5 Sec. 31.001. FREE INSTRUCTIONAL MATERIALS [TEXTBOOKS].
- 6 Instructional materials [Textbooks] selected for use in the public
- 7 schools shall be furnished without cost to the students attending
- 8 those schools. Except as provided by Section 31.104(d), a school
- 9 district may not charge a student for instructional material or
- 10 technological equipment purchased by the district with the
- 11 <u>district's instructional materials allotment</u>.
- 12 SECTION 19. Subdivisions (1), (1-a), (2), and (4), Section
- 13 31.002, Education Code, are amended to read as follows:
- 14 (1) "Instructional material" ["Electronic textbook"]
- 15 means content that conveys the essential knowledge and skills of a
- 16 <u>subject in the public school curriculum through a medium or a</u>
- 17 combination of media for conveying information to a student. The
- 18 term includes a book, supplementary materials, a combination of a
- 19 book, workbook, and supplementary materials, computer software,
- 20 [interactive videodise,] magnetic media, DVD, CD-ROM, computer
- 21 courseware, on-line services, or an electronic medium, or other
- 22 means of conveying information to the student or otherwise
- 23 contributing to the learning process through electronic means,
- 24 including [an] open-source instructional material [textbook].
- 25 (1-a) "Open-source <u>instructional</u> <u>material"</u>
- 26 [textbook"] means [an] electronic instructional material
- 27 [textbook] that is available for downloading from the Internet at

- 1 no charge to a student and without requiring the purchase of an
- 2 unlock code, membership, or other access or use charge, except for a
- 3 charge to order an optional printed copy of all or part of the
- 4 instructional material [textbook]. The term includes [a]
- 5 state-developed open-source <u>instructional material</u> [textbook]
- 6 purchased under Subchapter B-1.
- 7 (2) "Publisher" includes an on-line service or a
- 8 developer or distributor of [an] electronic instructional
- 9 materials [textbook].
- 10 (4) "Technological equipment" means hardware, a
- 11 device, or equipment necessary for:
- 12 (A) instructional use in the classroom,
- 13 including to gain access to or enhance the use of [an] electronic
- 14 instructional materials [textbook]; or
- 15 (B) professional use by a classroom teacher.
- 16 SECTION 20. Subchapter A, Chapter 31, Education Code, is
- 17 amended by amending Sections 31.003 and 31.004 and adding Section
- 18 31.005 to read as follows:
- 19 Sec. 31.003. RULES. The State Board of Education may adopt
- 20 rules, consistent with this chapter, for the adoption, requisition,
- 21 distribution, care, use, and disposal of instructional materials
- 22 [textbooks].
- 23 Sec. 31.004. CERTIFICATION OF PROVISION OF [TEXTBOOKS,
- 24 ELECTRONIC TEXTBOOKS, AND INSTRUCTIONAL MATERIALS. (a) Each
- 25 school district and open-enrollment charter school shall annually
- 26 certify to the State Board of Education and the commissioner that,
- 27 for each subject in the required curriculum under Section 28.002,

- 1 other than physical education, and each grade level, the district
- 2 provides each student with [textbooks, electronic textbooks, or]

- 15 eligible institutions and adopted by the State Board of Education
- 16 <u>under Section 31.0241;</u>
- 17 (4) open-source instructional materials made
- 18 available by other public schools; and
- 19 <u>(5) instructional materials developed or purchased by</u>
- 20 the school district or open-enrollment charter school.
- 21 Sec. 31.005. FUNDING FOR OPEN-ENROLLMENT CHARTER SCHOOLS.
- 22 An open-enrollment charter school is entitled to the instructional
- 23 materials allotment under this chapter and is subject to this
- 24 chapter as if the school were a school district.
- 25 SECTION 21. The heading to Section 31.021, Education Code,
- 26 is amended to read as follows:
- 27 Sec. 31.021. STATE INSTRUCTIONAL MATERIALS [TEXTBOOK]

- 1 FUND.
- 2 SECTION 22. Section 31.021, Education Code, is amended by
- 3 amending Subsections (a) and (d) and adding Subsection (c) to read
- 4 as follows:
- 5 (a) The state <u>instructional materials</u> [textbook] fund
- 6 consists of:
- 7 (1) an amount set aside by the State Board of Education
- 8 from the available school fund, in accordance with Section
- 9 43.001(d); and
- 10 (2) [all funds accruing from the state's sale of
- 11 disused textbooks; and
- 12 [<del>(3)</del>] all amounts lawfully paid into the fund from any
- 13 other source.
- (c) Money in the state instructional materials fund shall be
- 15 <u>used to:</u>
- 16 (1) <u>fund the instructional materials allotment, as</u>
- 17 provided by Section 31.0211;
- 18 (2) <u>purchase special instructional materials for the</u>
- 19 education of blind and visually impaired students in public
- 20 schools;
- 21 (3) pay the expenses associated with the instructional
- 22 materials adoption and review process under this chapter;
- 23 (4) pay the expenses associated with the purchase or
- 24 <u>licensing of open-source instructional material;</u>
- 25 (5) pay the expenses associated with the purchase of
- 26 instructional material, including intrastate freight and shipping
- 27 and the insurance expenses associated with intrastate freight and

- 1 shipping;
- 2 (6) fund the technology lending grant program
- 3 established under Section 32.201; and
- 4 (7) provide funding to the Texas School for the Blind
- 5 and Visually Impaired, the Texas School for the Deaf, and the Texas
- 6 Youth Commission.
- 7 (d) Money transferred to the state instructional materials
- 8 [textbook] fund remains in the fund until spent and does not lapse
- 9 to the state at the end of the fiscal year.
- 10 SECTION 23. Subchapter B, Chapter 31, Education Code, is
- 11 amended by adding Sections 31.0211, 31.0212, 31.0213, and 31.0214
- 12 to read as follows:
- 13 Sec. 31.0211. INSTRUCTIONAL MATERIALS ALLOTMENT. (a) A
- 14 school district is entitled to an annual allotment from the state
- 15 <u>instructional materials fund for each student enrolled in the</u>
- 16 district on a date during the preceding school year specified by the
- 17 commissioner. The commissioner shall determine the amount of the
- 18 allotment per student each year on the basis of the amount of money
- 19 available in the state instructional materials fund to fund the
- 20 allotment. An allotment under this section shall be transferred
- 21 from the state instructional materials fund to the credit of the
- 22 <u>district's instructional materials account as provided by Section</u>
- 23 31.0212.
- (b) A juvenile justice alternative education program under
- 25 Section 37.011 is entitled to an allotment from the state
- 26 instructional materials fund in an amount determined by the
- 27 commissioner. The program shall use the allotment to purchase

4	(c) Subject to Subsection (d), funds allotted under this
5	section may be used to:

9	(B) instructional materials, regardless of
10	whether the instructional materials are on the list adopted under
11	Section 31.024;
12	(C) consumable instructional materials,

16	(E) supplemental instructional materials, as

27	(2) pay:

- 19 (b) The commissioner shall pay the cost of instructional
- 20 materials requisitioned by a school district under Section 31.103
- 21 using funds from the district's instructional materials account.
- 22 (c) A school district may also use funds in the district's
- 23 account to purchase electronic instructional materials or
- 24 technological equipment. The district shall submit to the
- 25 commissioner a request for funds for this purpose from the
- 26 <u>district's account.</u> The commissioner shall adopt rules regarding
- 27 the documentation a school district must submit to receive funds

- 2 (d) Money deposited in a school district's instructional
- 3 materials account during each state fiscal biennium remains in the
- 4 account and available for use by the district for the entire
- 5 biennium. At the end of each biennium, a district with unused money
- 6 in the district's account may carry forward any remaining balance
- 7 to the next biennium.
- 8 (e) The commissioner shall adopt rules as necessary to
- 9 implement this section. The rules must include a requirement that a
- 10 school district provide the title and publication information for
- 11 any instructional materials requisitioned or purchased by the
- 12 district with the district's instructional materials allotment.
- 13 Sec. 31.0213. CERTIFICATION OF USE OF INSTRUCTIONAL
- 14 MATERIALS ALLOTMENT. Each school district shall annually certify
- 15 to the commissioner that the district's instructional materials
- 16 allotment has been used only for expenses allowed by Section
- 17 31.0211.
- 18 Sec. 31.0214. ADJUSTMENT FOR HIGH ENROLLMENT GROWTH
- 19 DISTRICTS. (a) Each year the commissioner shall adjust the
- 20 instructional materials allotment of school districts experiencing
- 21 high enrollment growth. The commissioner shall establish a
- 22 procedure for determining high enrollment growth districts
- 23 eligible to receive an adjustment under this section and the amount
- 24 of the instructional materials allotment those districts will
- 25 receive.
- 26 (b) The commissioner may adopt rules as necessary to
- 27 <u>implement this section</u>.

- 1 SECTION 24. Section 31.022, Education Code, is amended to
- 2 read as follows:
- 3 Sec. 31.022. <u>INSTRUCTIONAL MATERIALS</u> [TEXTBOOK] REVIEW AND
