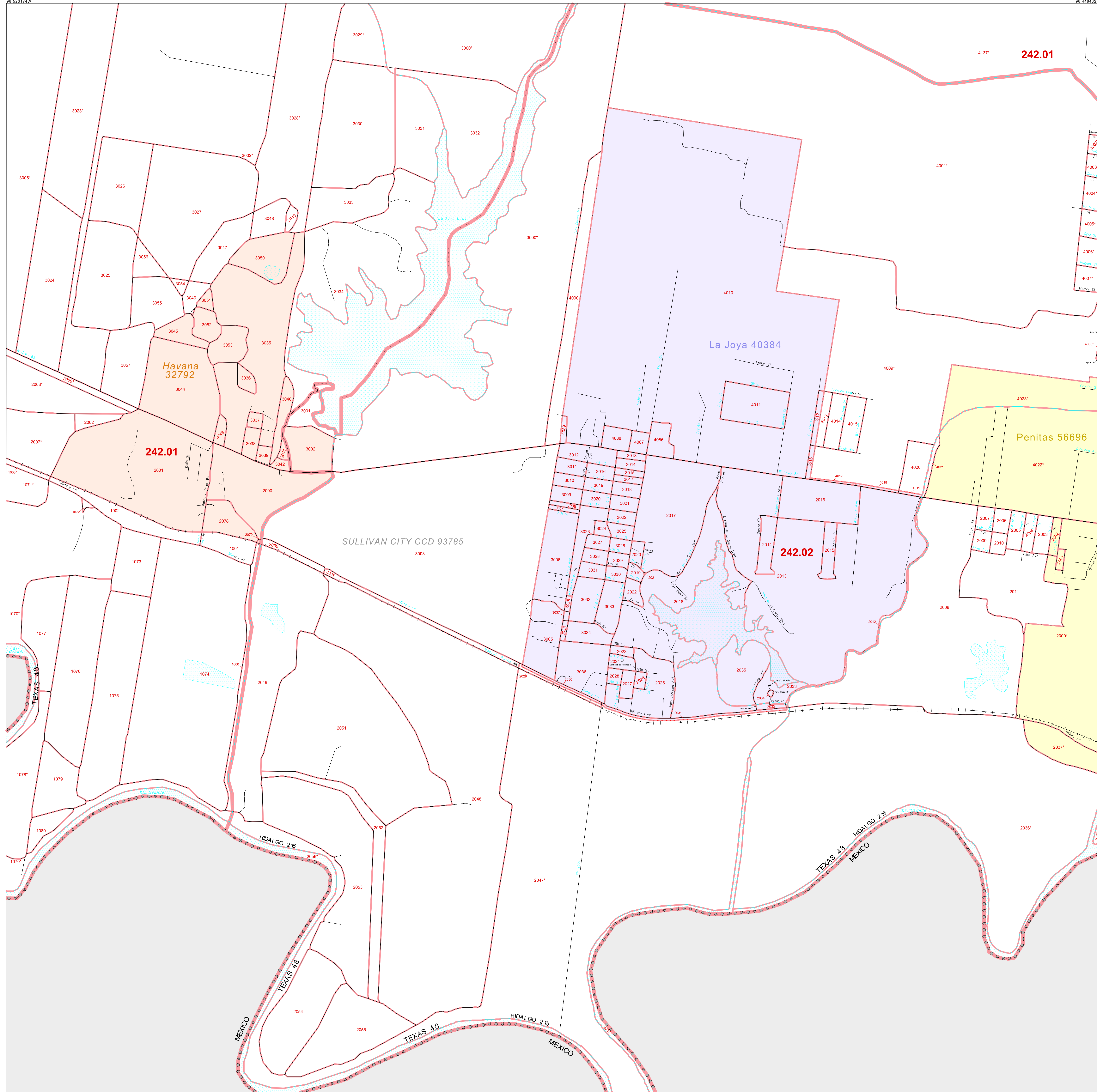


CENSUS 2000 BLOCK MAP: HIDALGO County

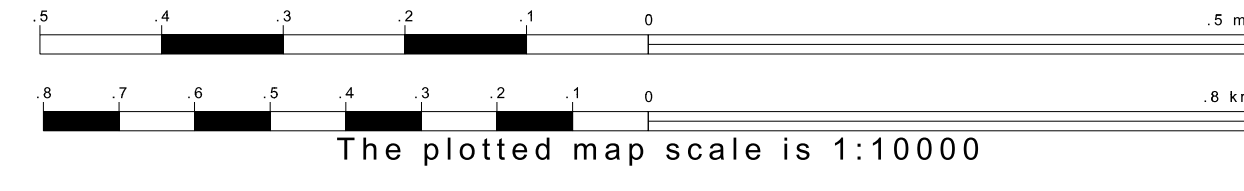
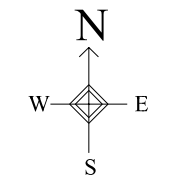

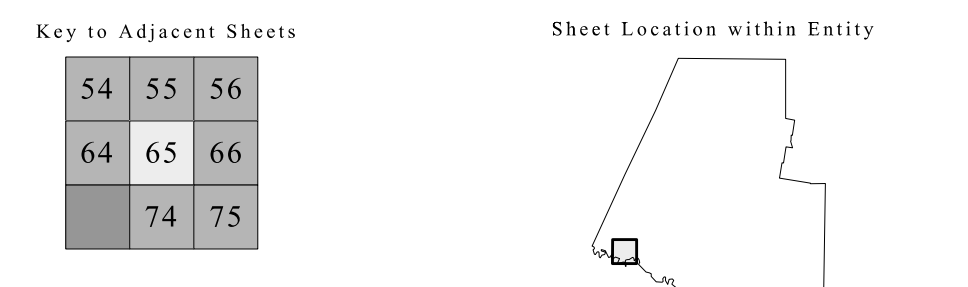
