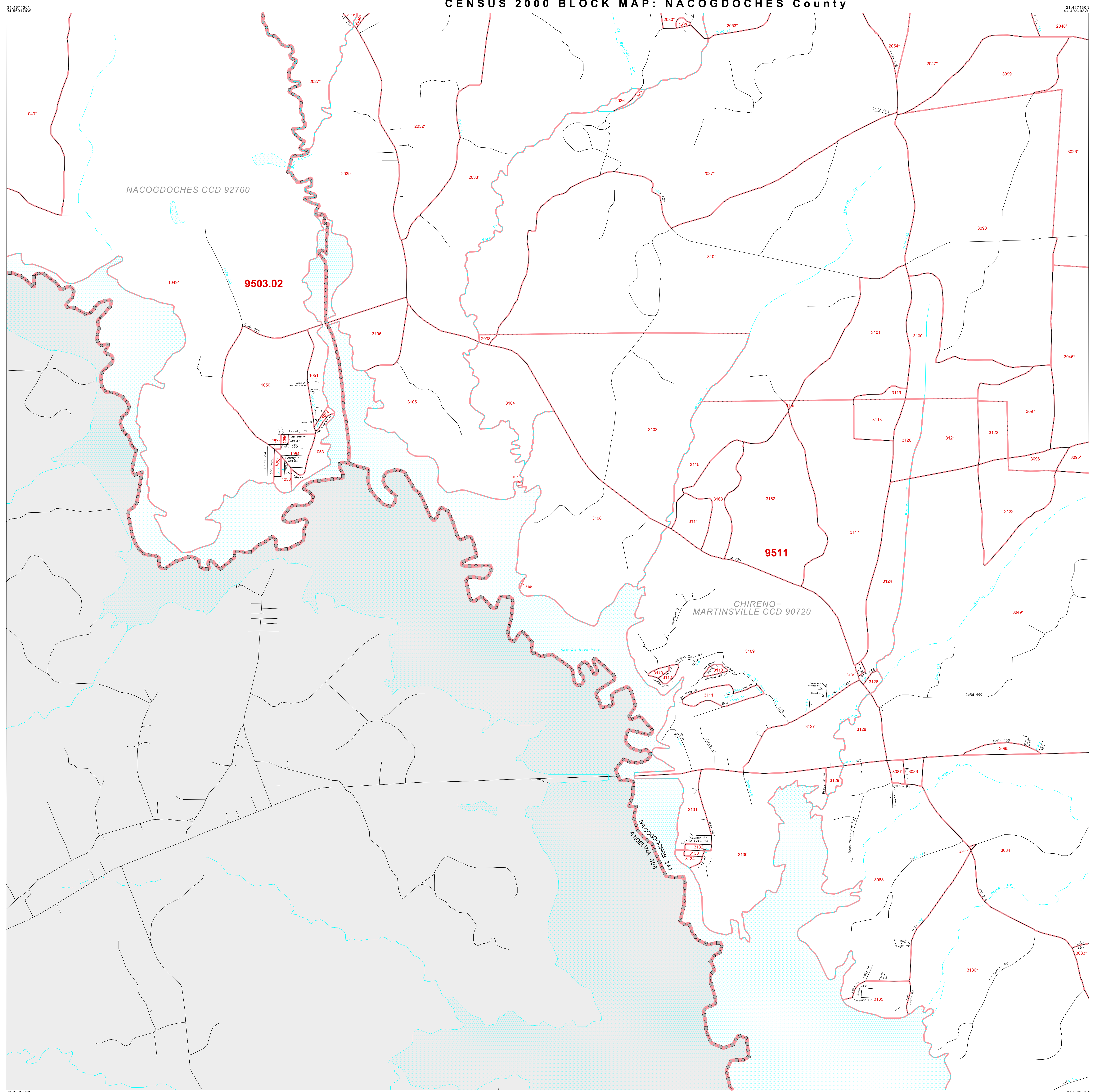


CENSUS 2000 BLOCK MAP: NACOGDOCHES County
