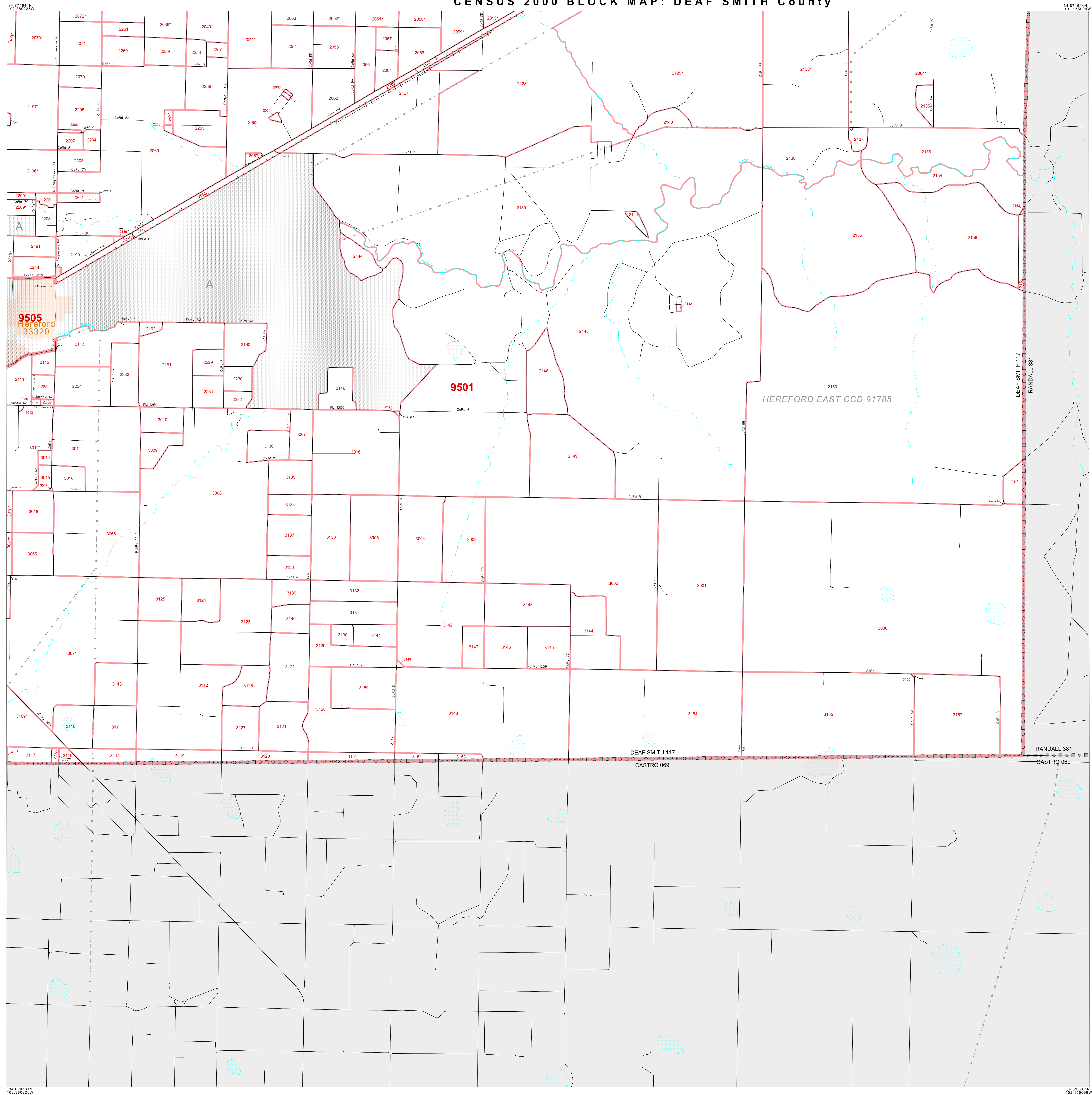


CENSUS 2000 BLOCK MAP: DEAF SMITH County
