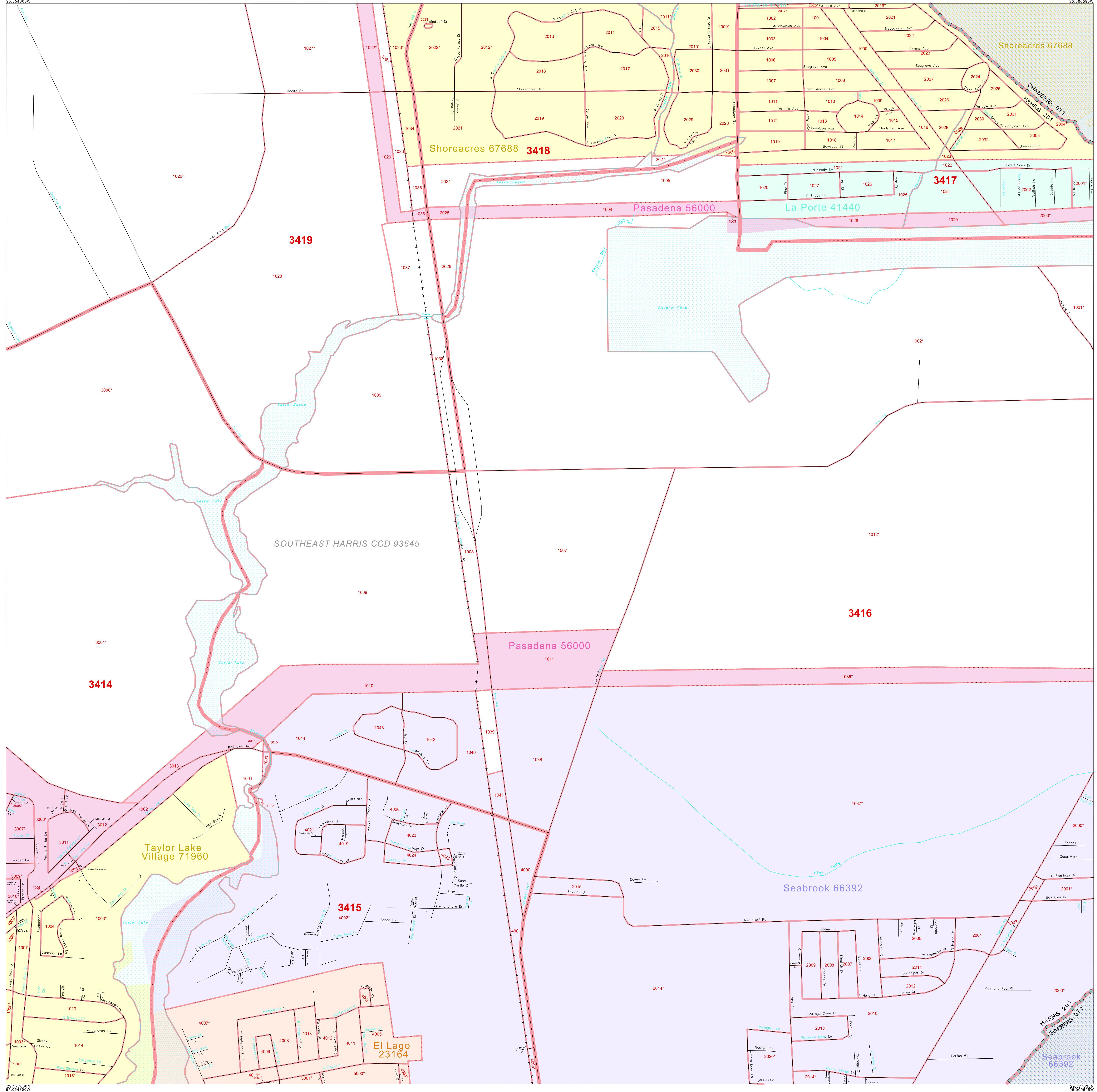


CENSUS 2000 BLOCK MAP: HARRIS County

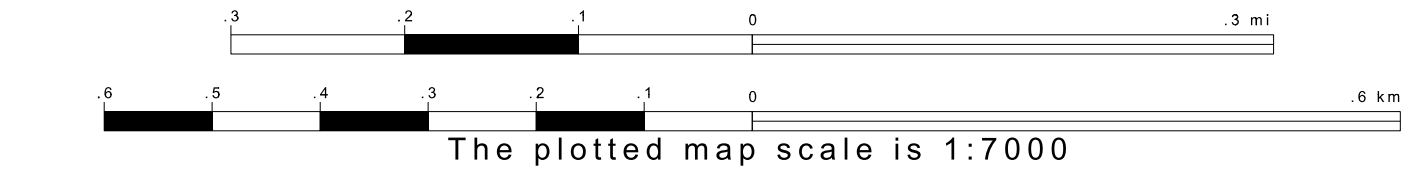
