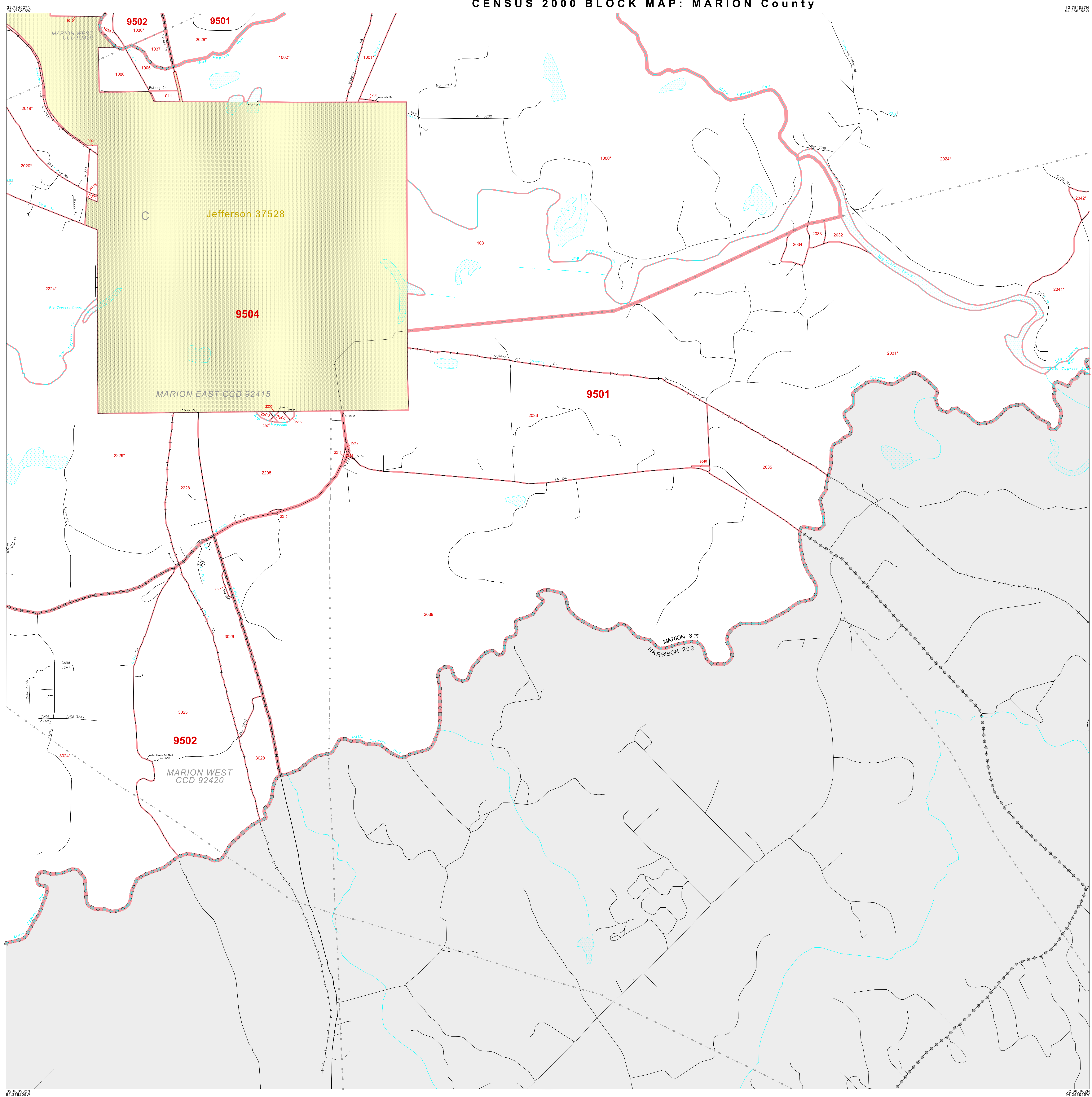


CENSUS 2000 BLOCK MAP: MARION County
