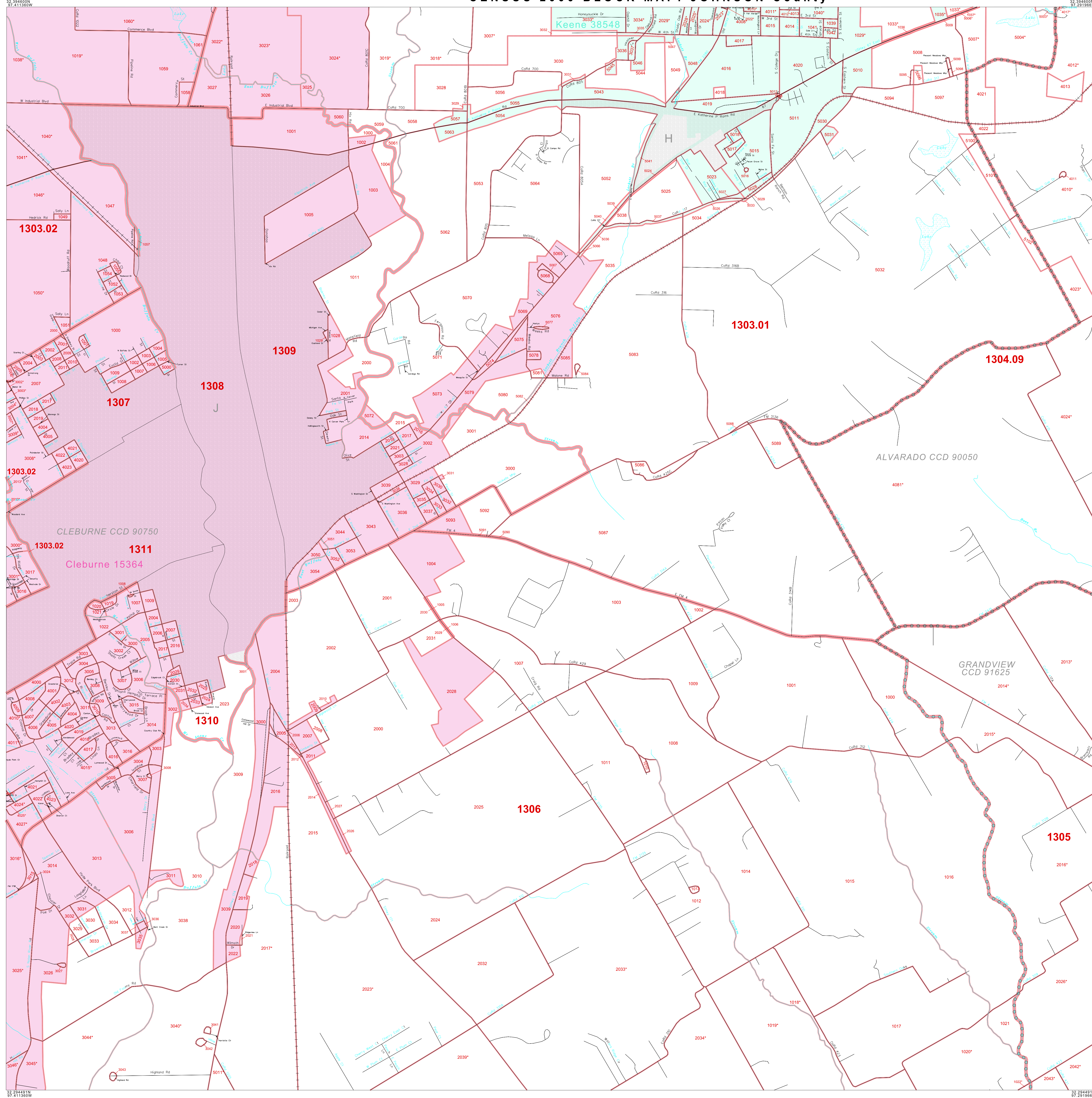


CENSUS 2000 BLOCK MAP: JOHNSON County
