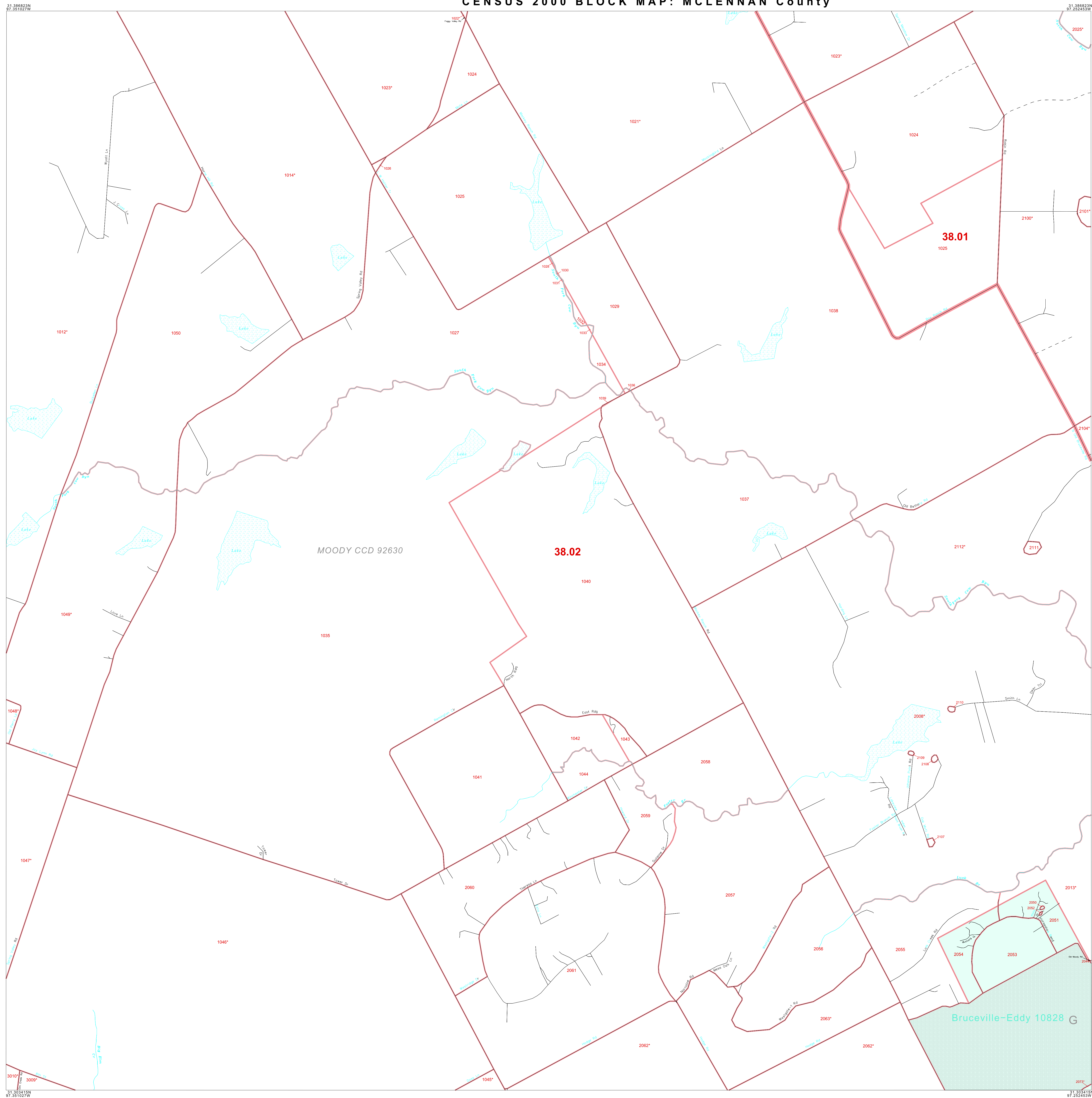


CENSUS 2000 BLOCK MAP: MCLENNAN County
