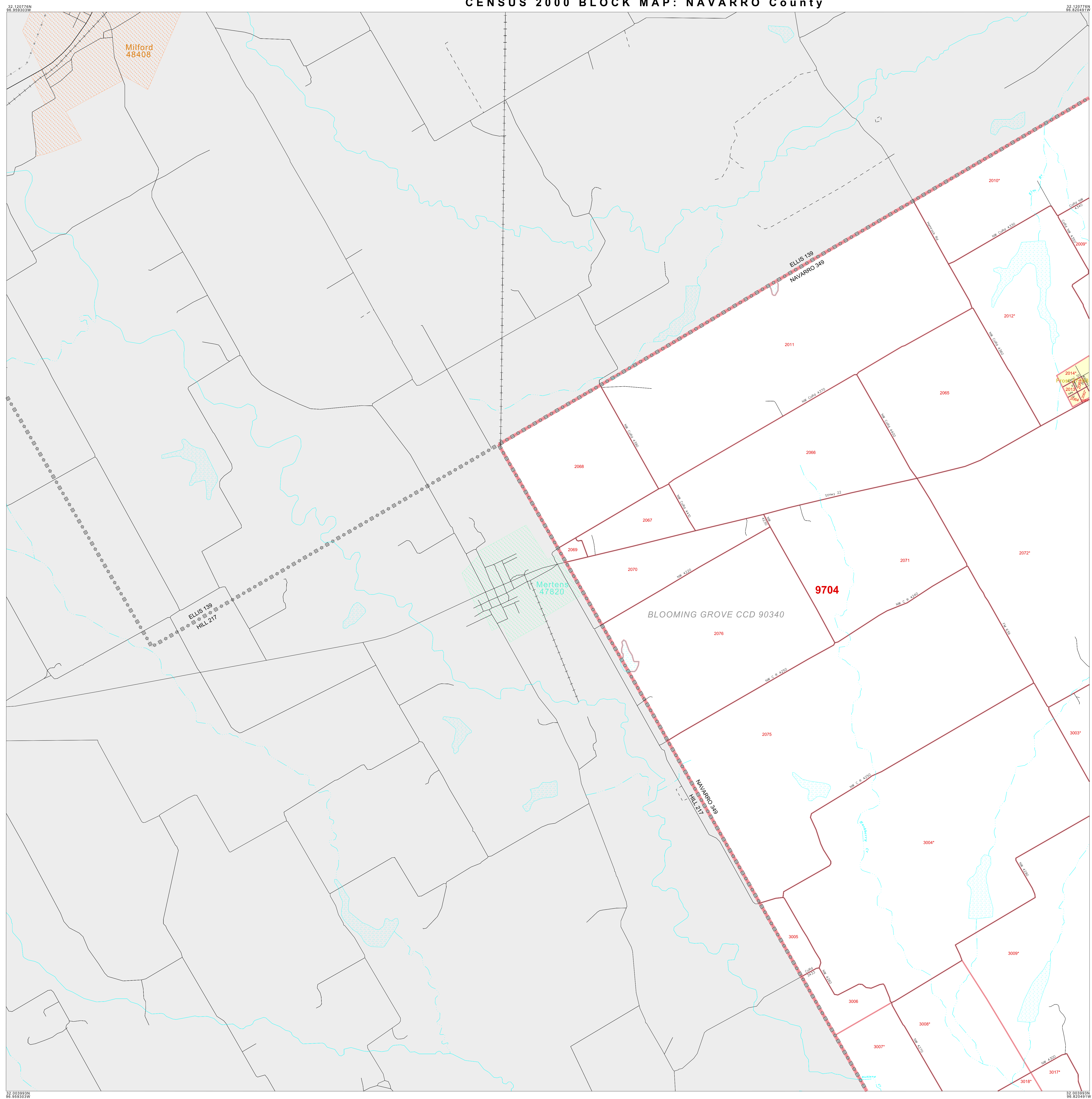


CENSUS 2000 BLOCK MAP: NAVARRO County
