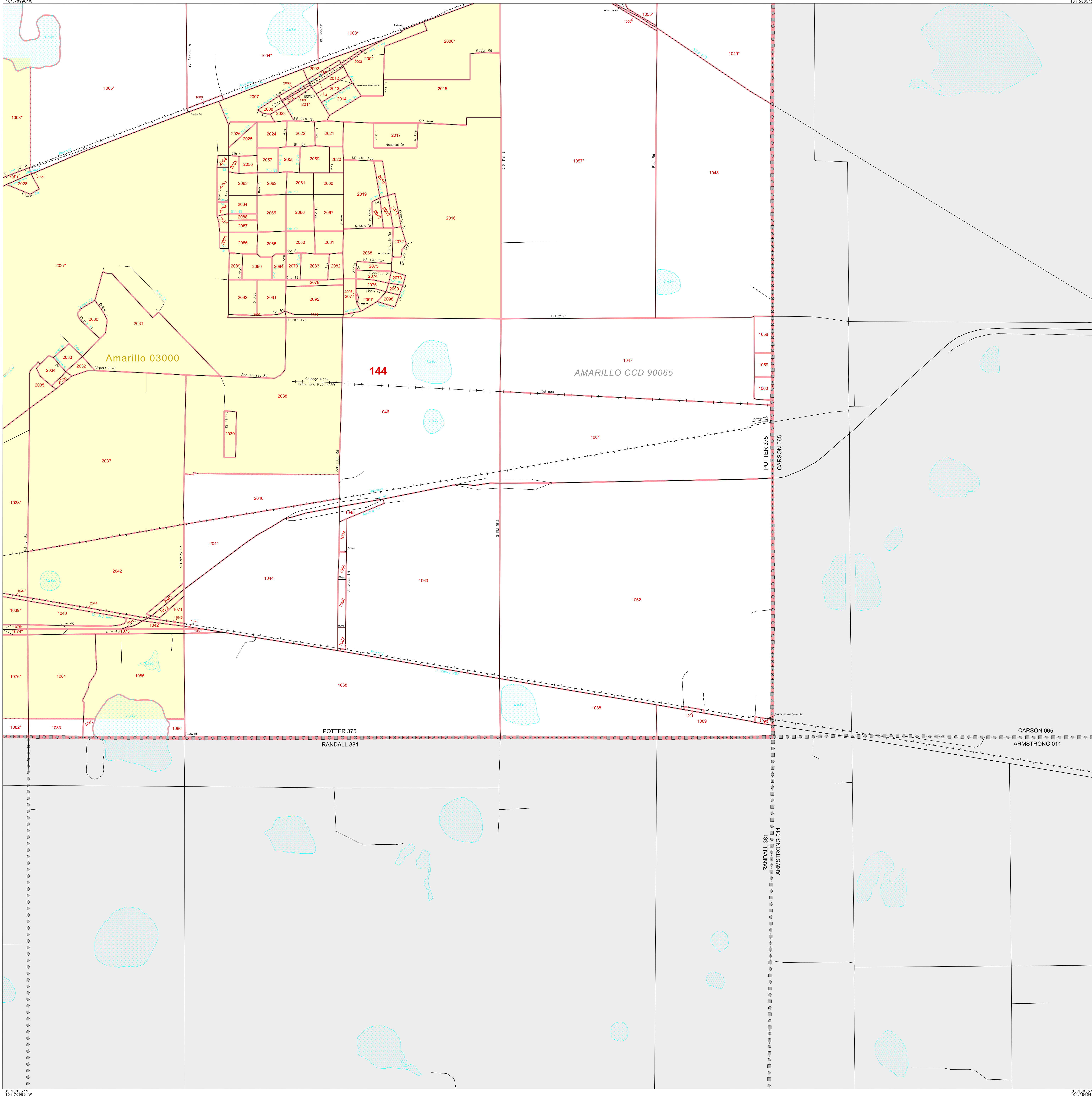


CENSUS 2000 BLOCK MAP: POTTER County

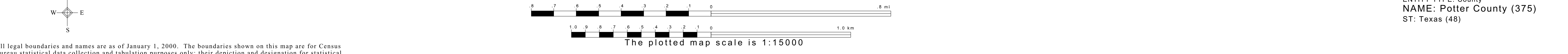
