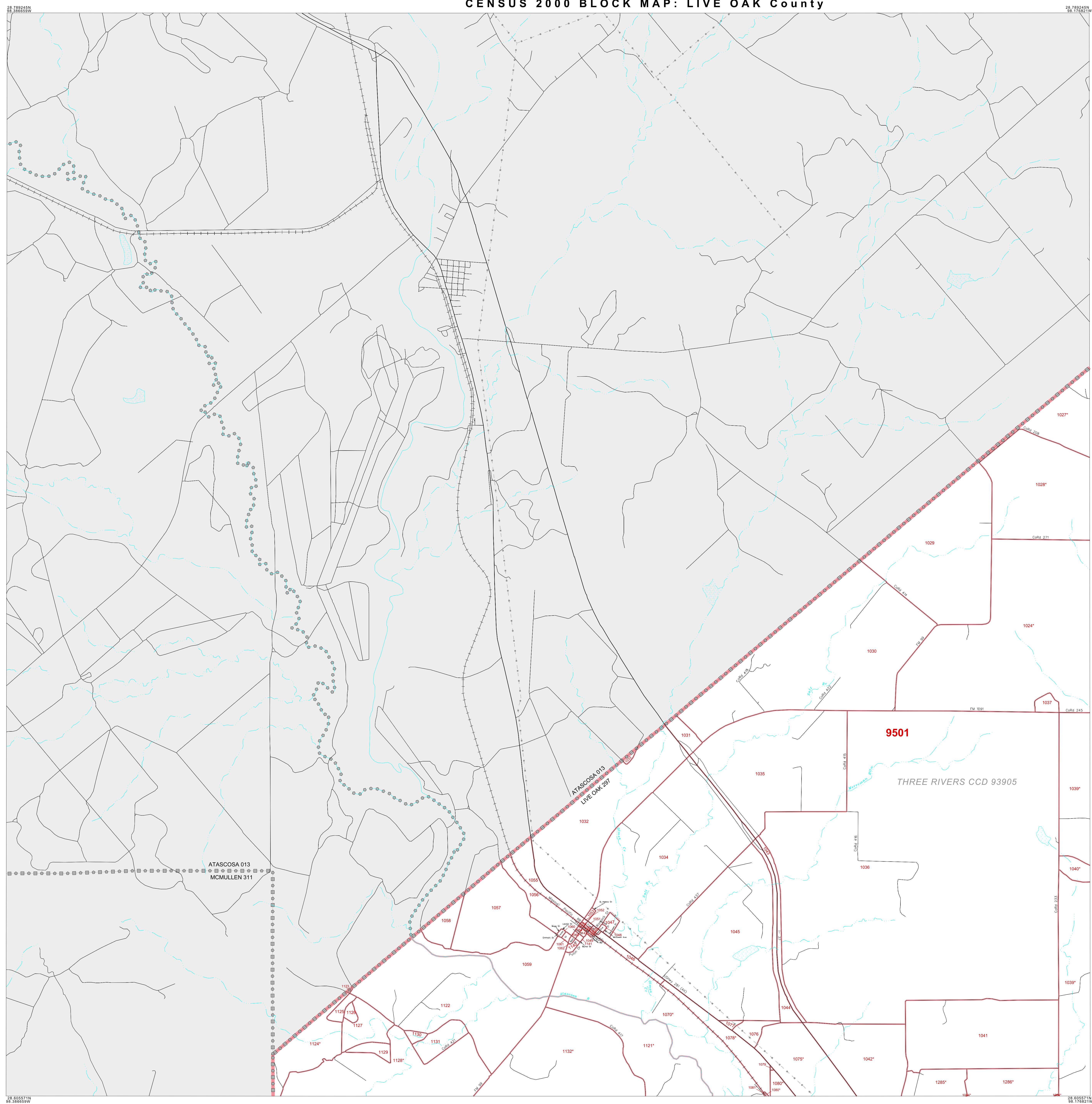


CENSUS 2000 BLOCK MAP: LIVE OAK County

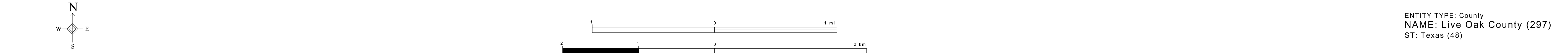
