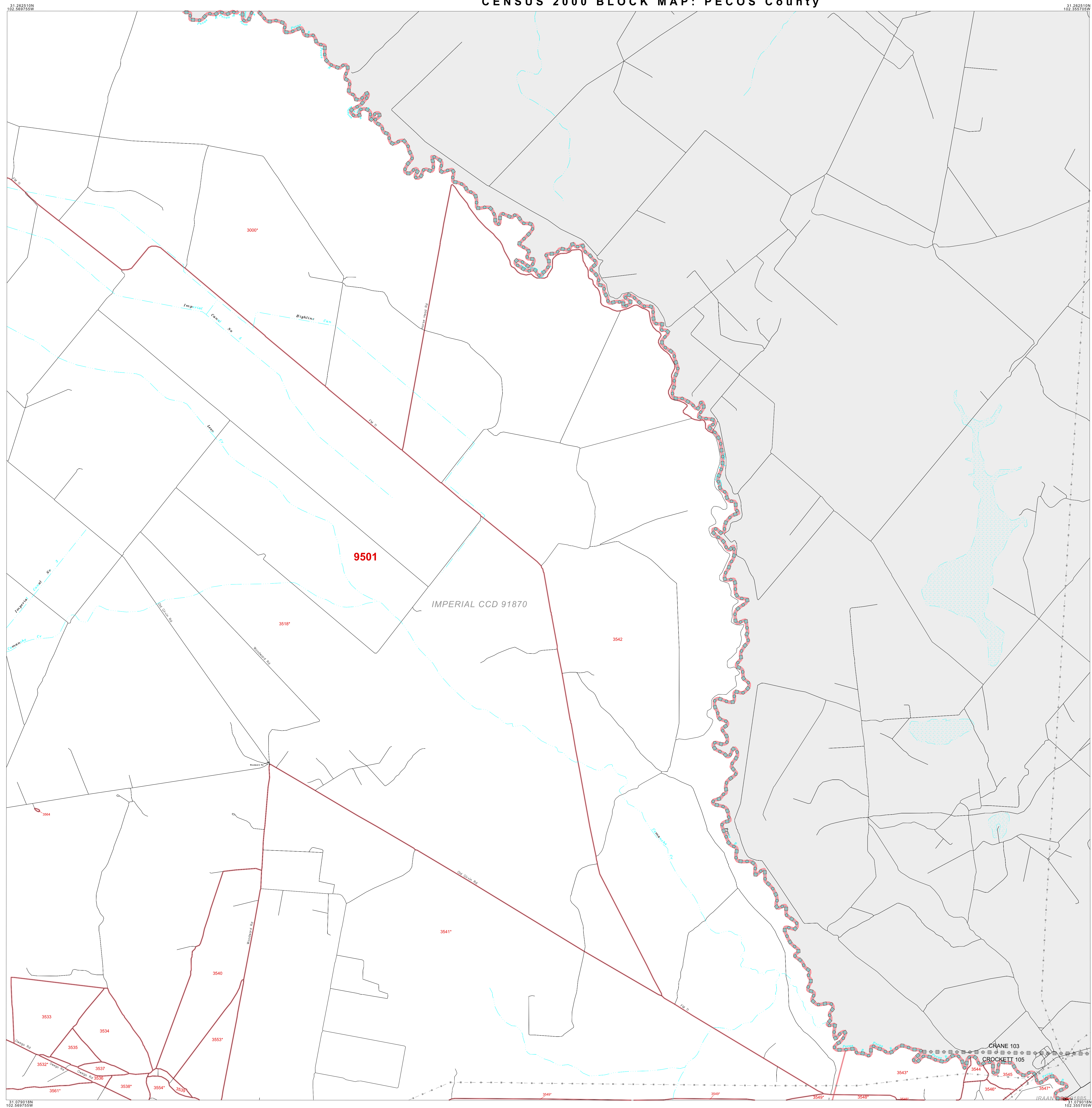


CENSUS 2000 BLOCK MAP: PECOS County
