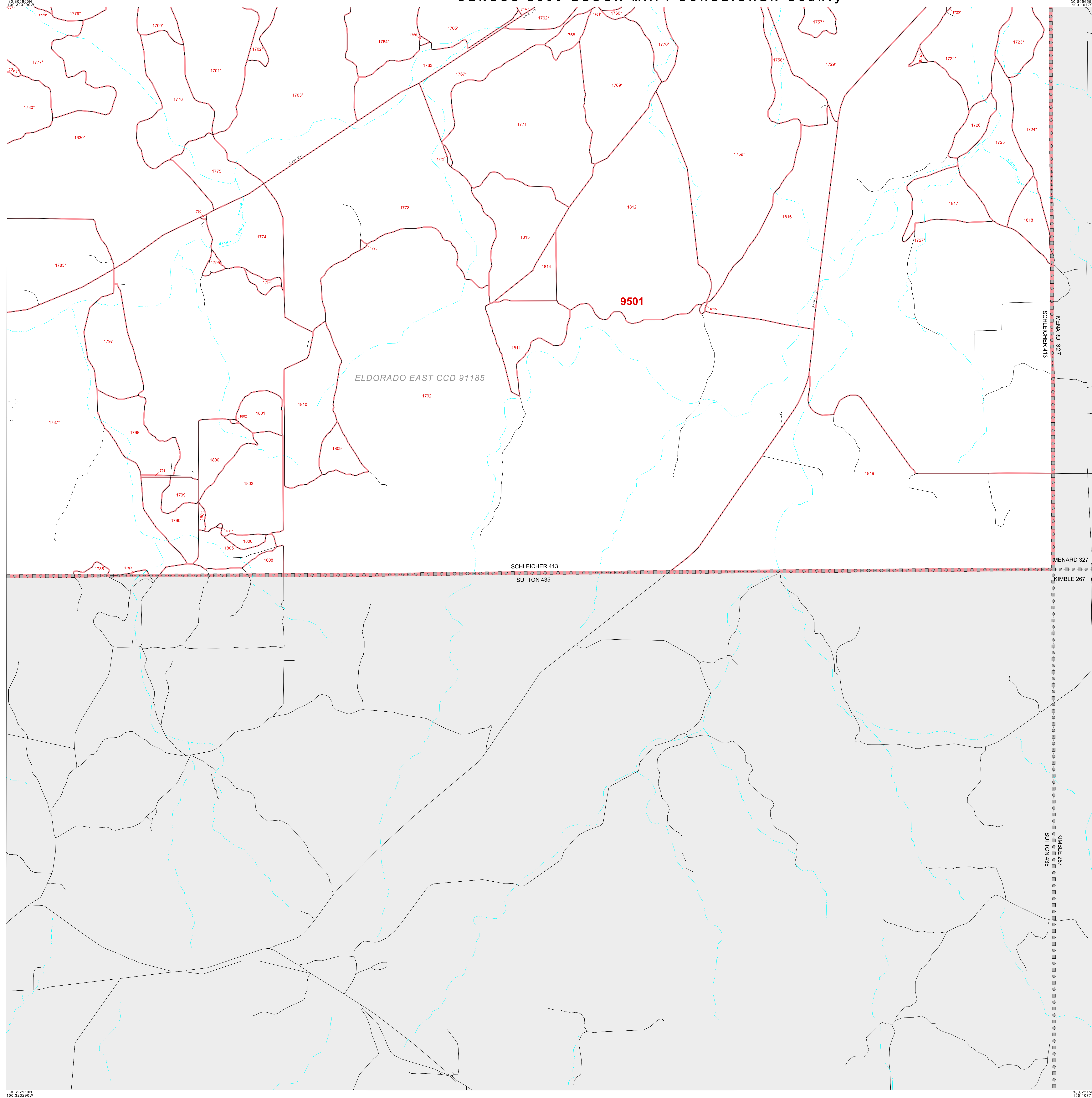


CENSUS 2000 BLOCK MAP: SCHLEICHER County
