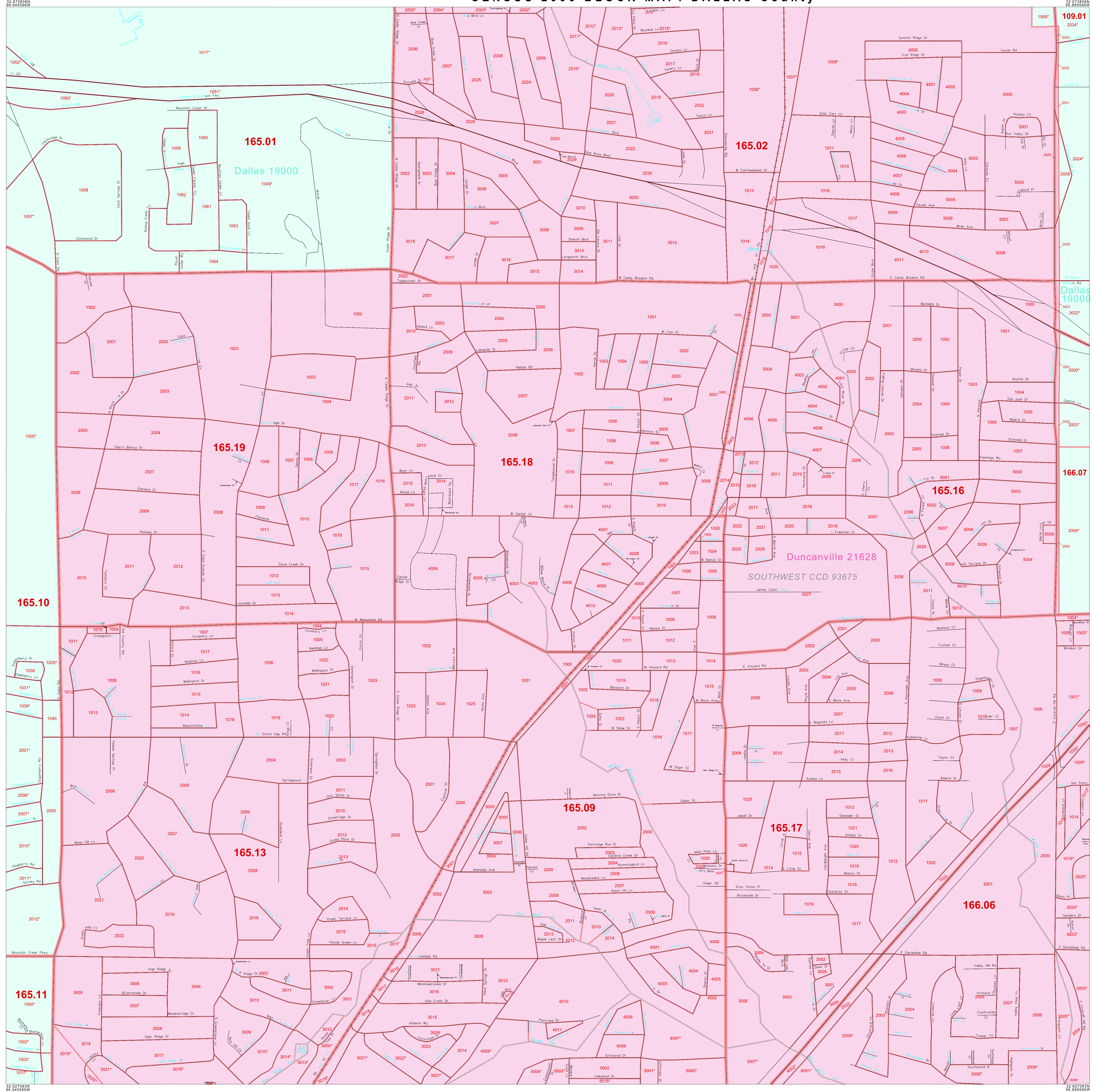


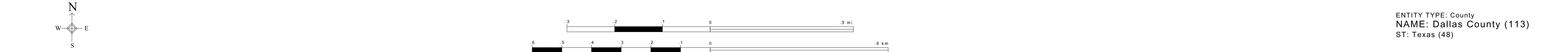
CENSUS 2000 BLOCK MAP: DALLAS County
