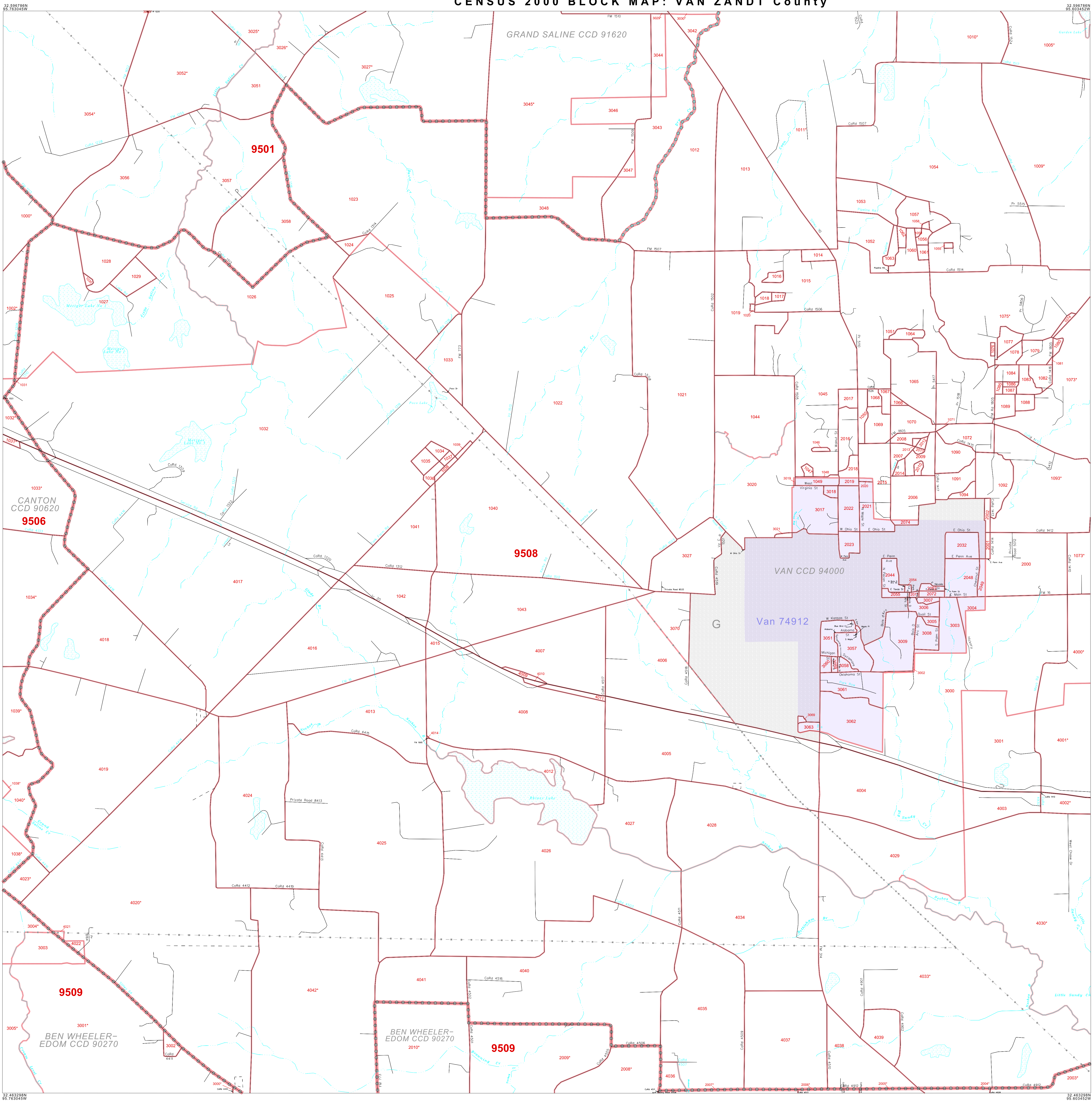


CENSUS 2000 BLOCK MAP: VAN ZANDT County

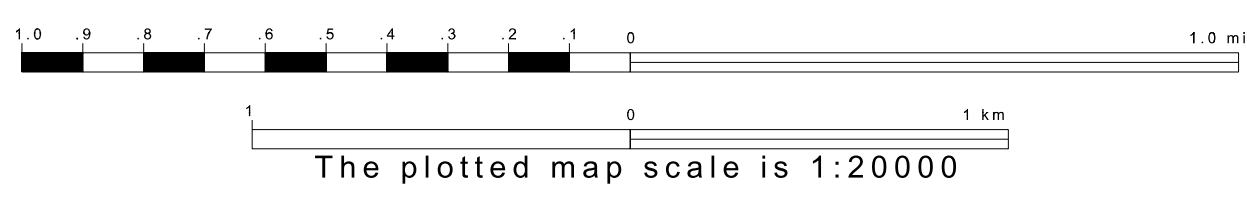
