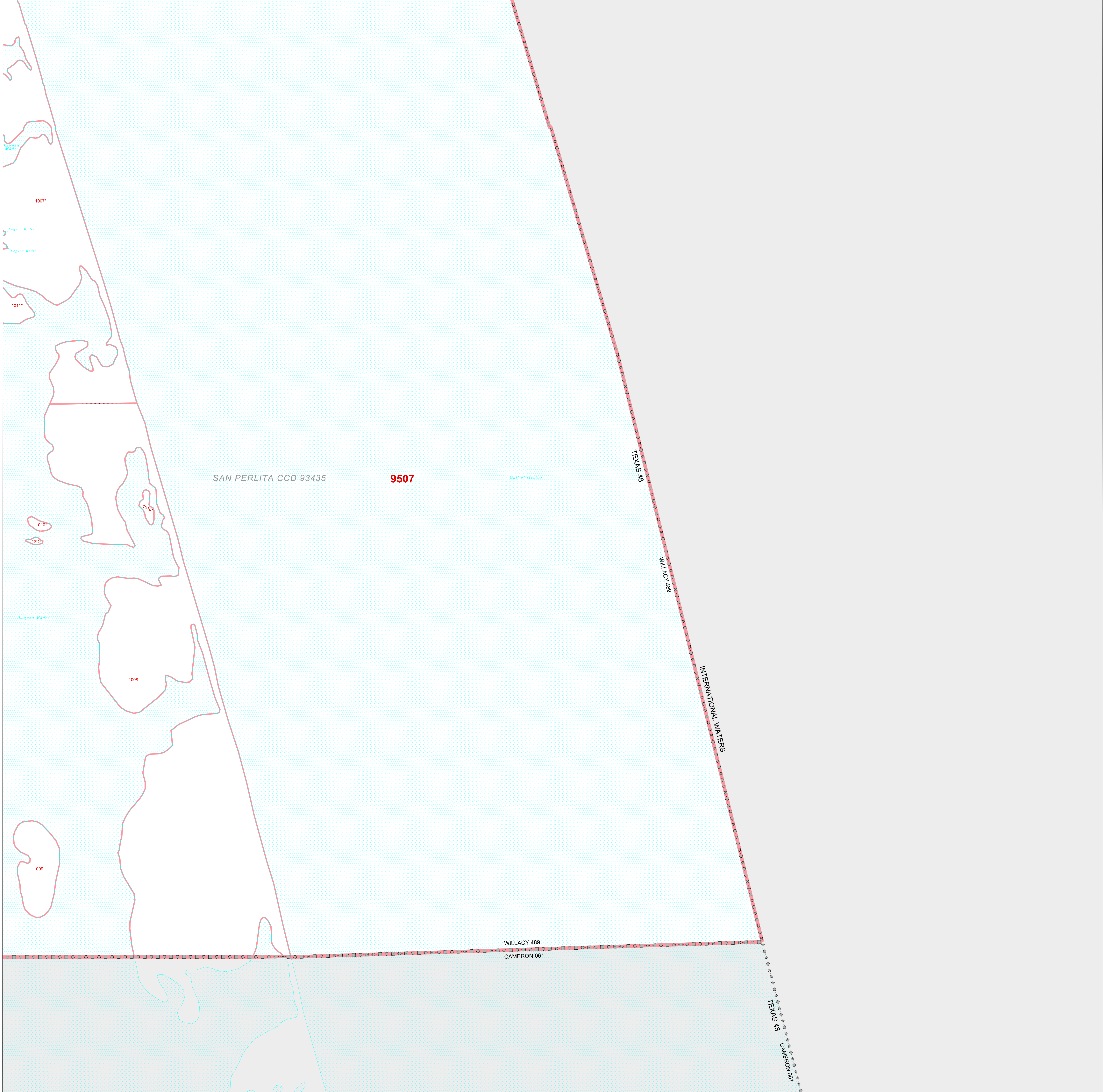


CENSUS 2000 BLOCK MAP: WILLACY County

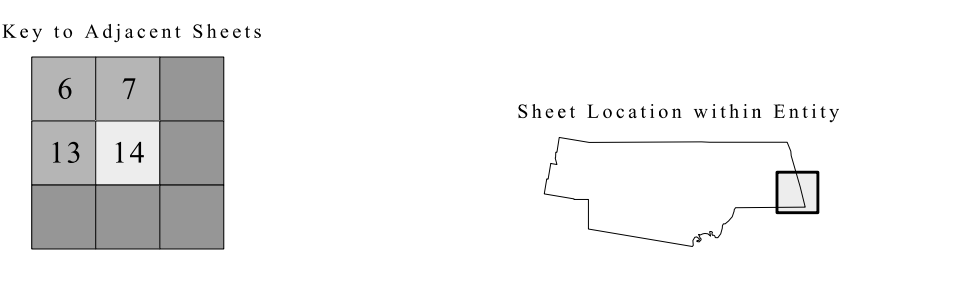
