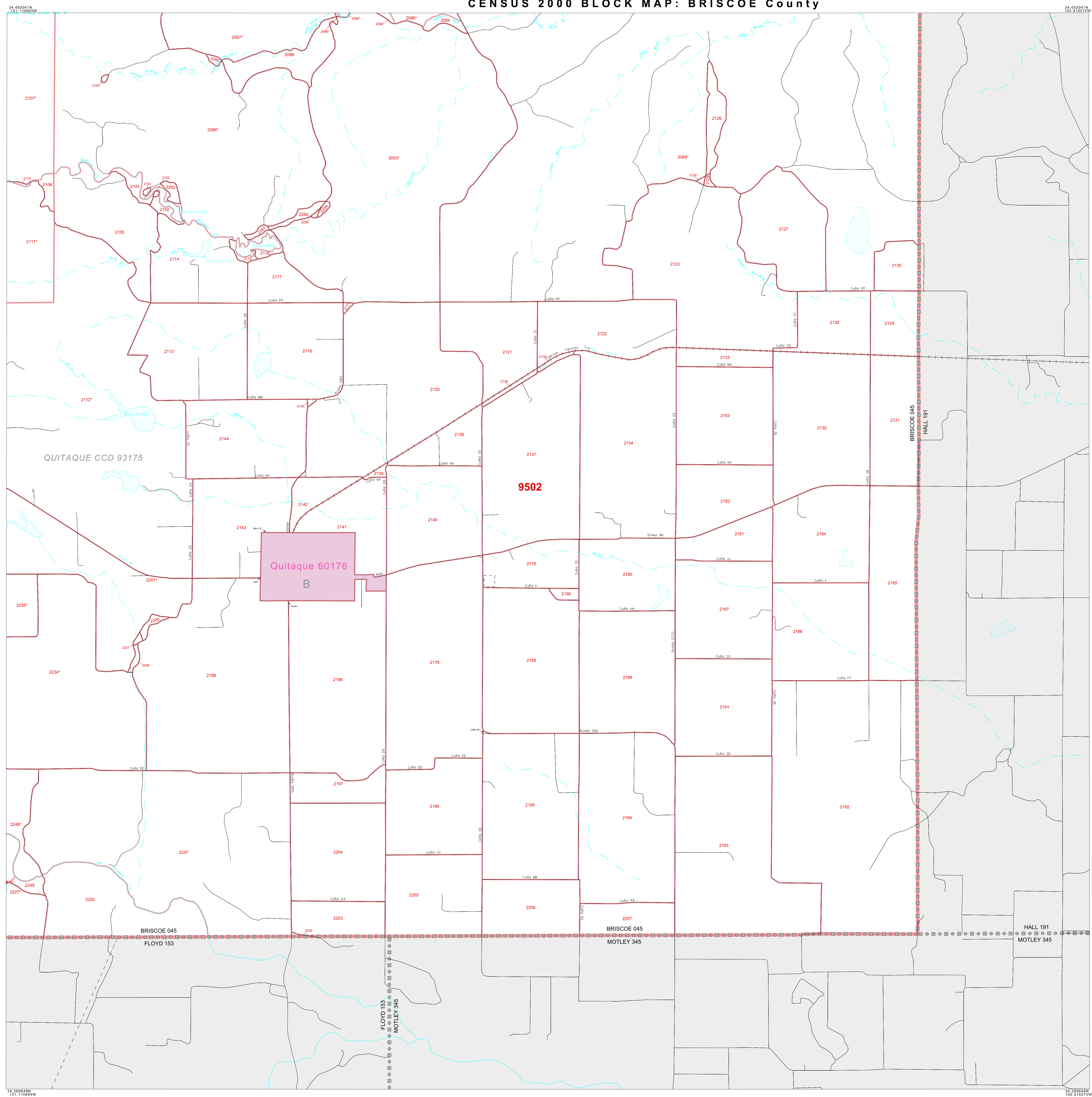


CENSUS 2000 BLOCK MAP: BRISCOE County
