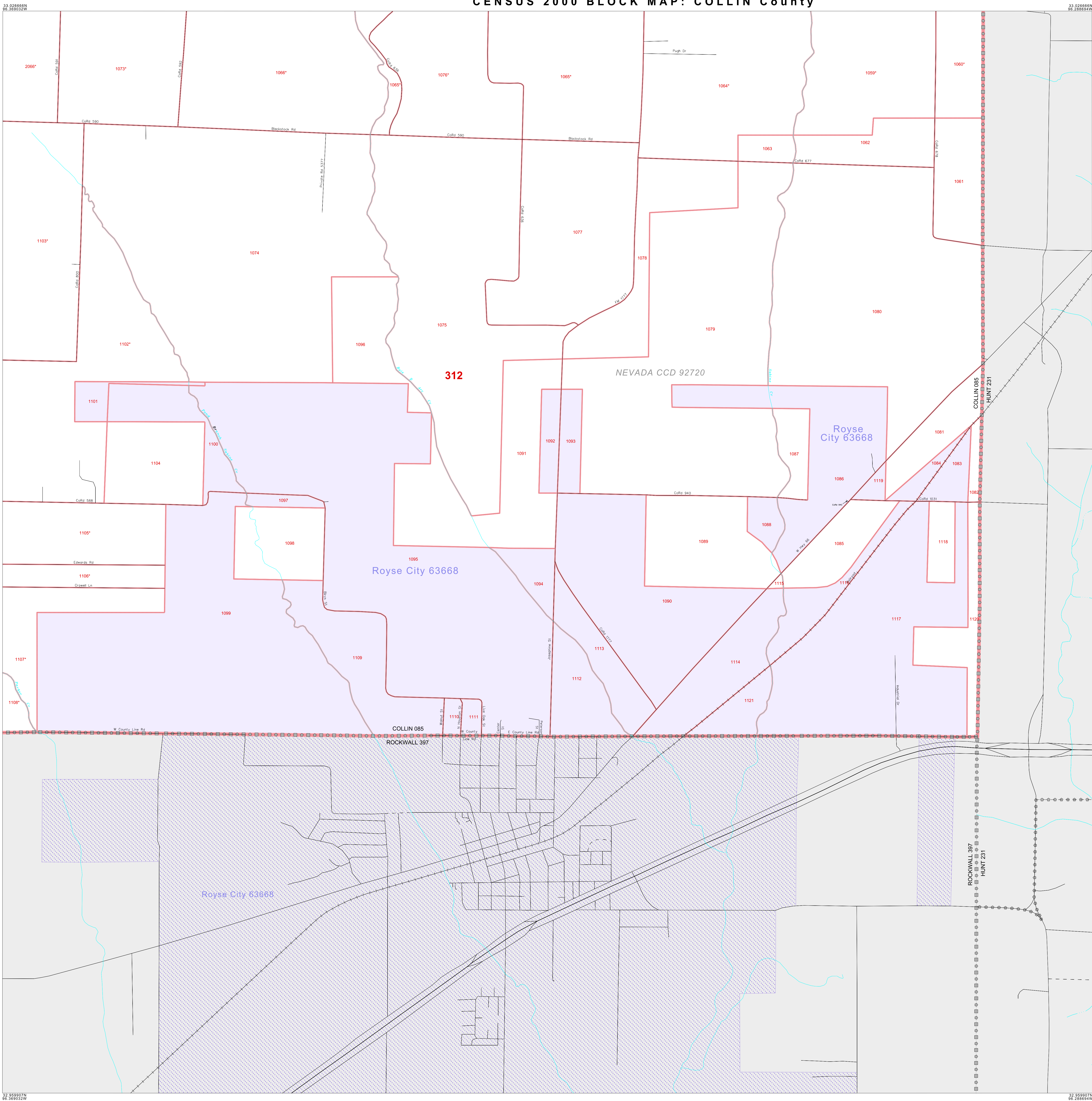


CENSUS 2000 BLOCK MAP: COLLIN County
