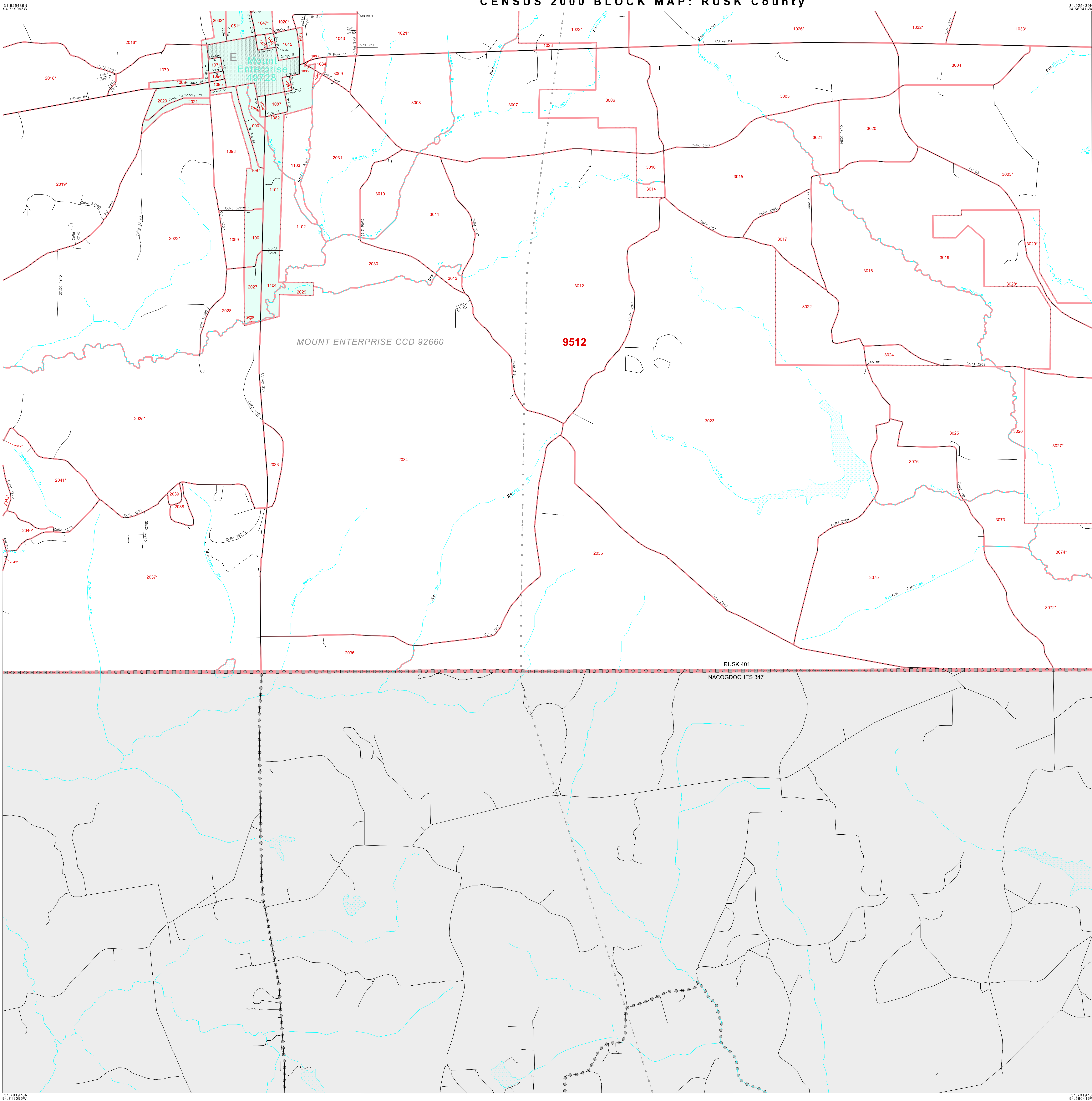


CENSUS 2000 BLOCK MAP: RUSK County
