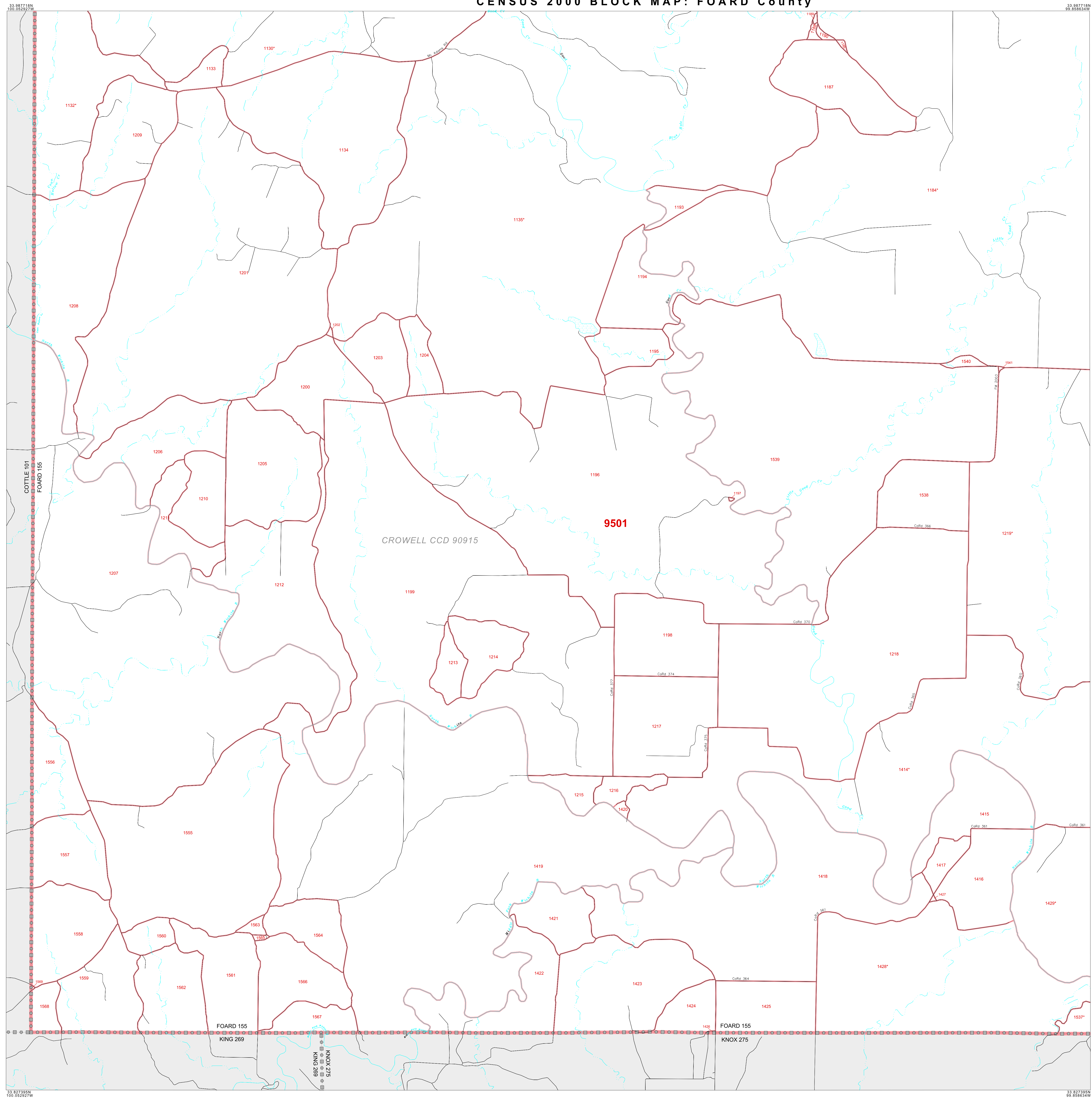


CENSUS 2000 BLOCK MAP: FOARD County
