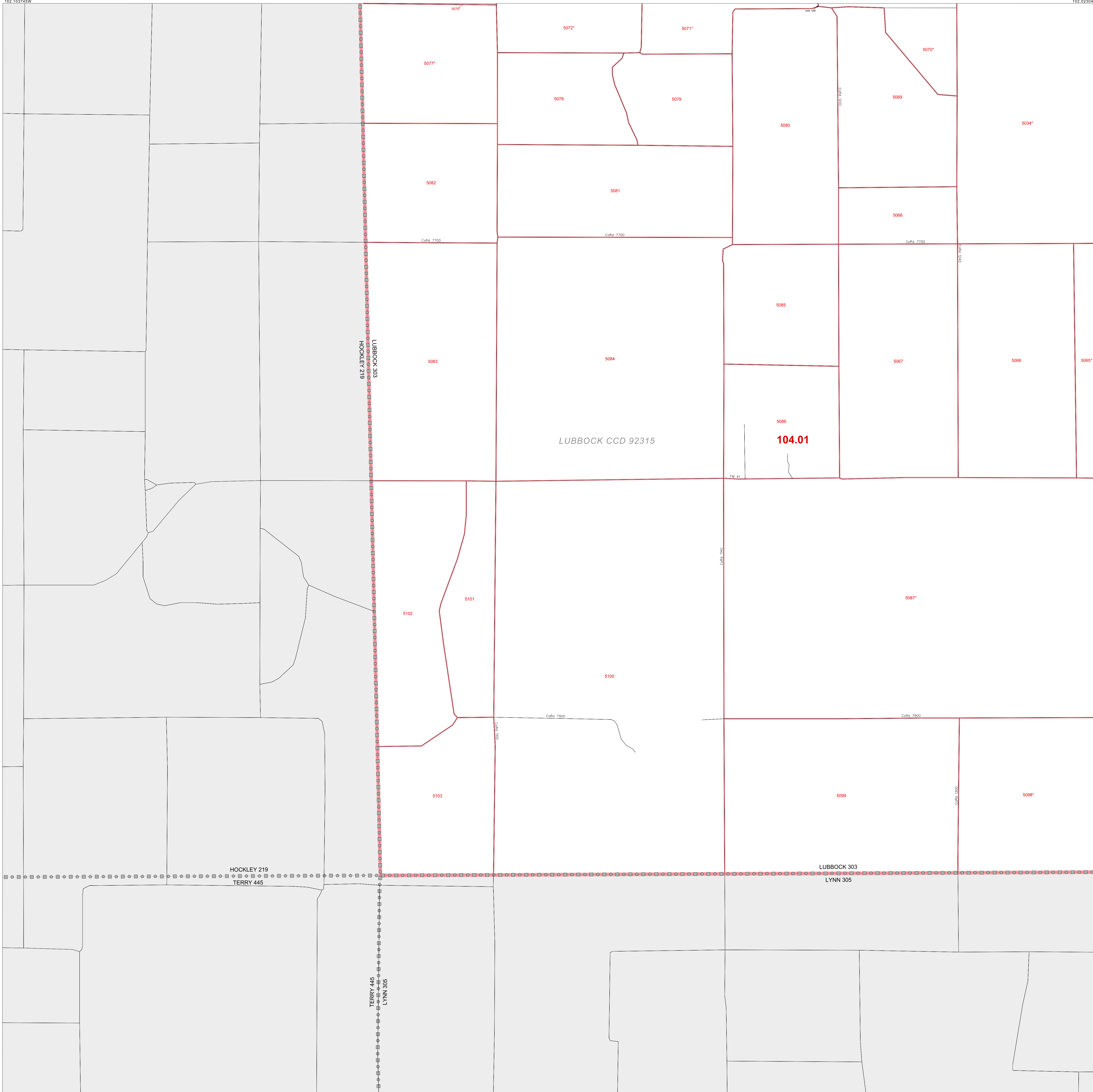


CENSUS 2000 BLOCK MAP: LUBBOCK County

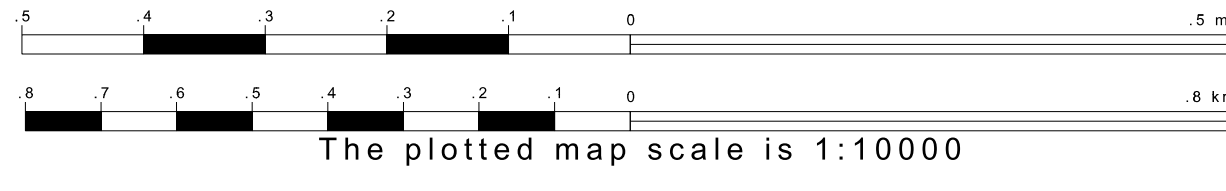
