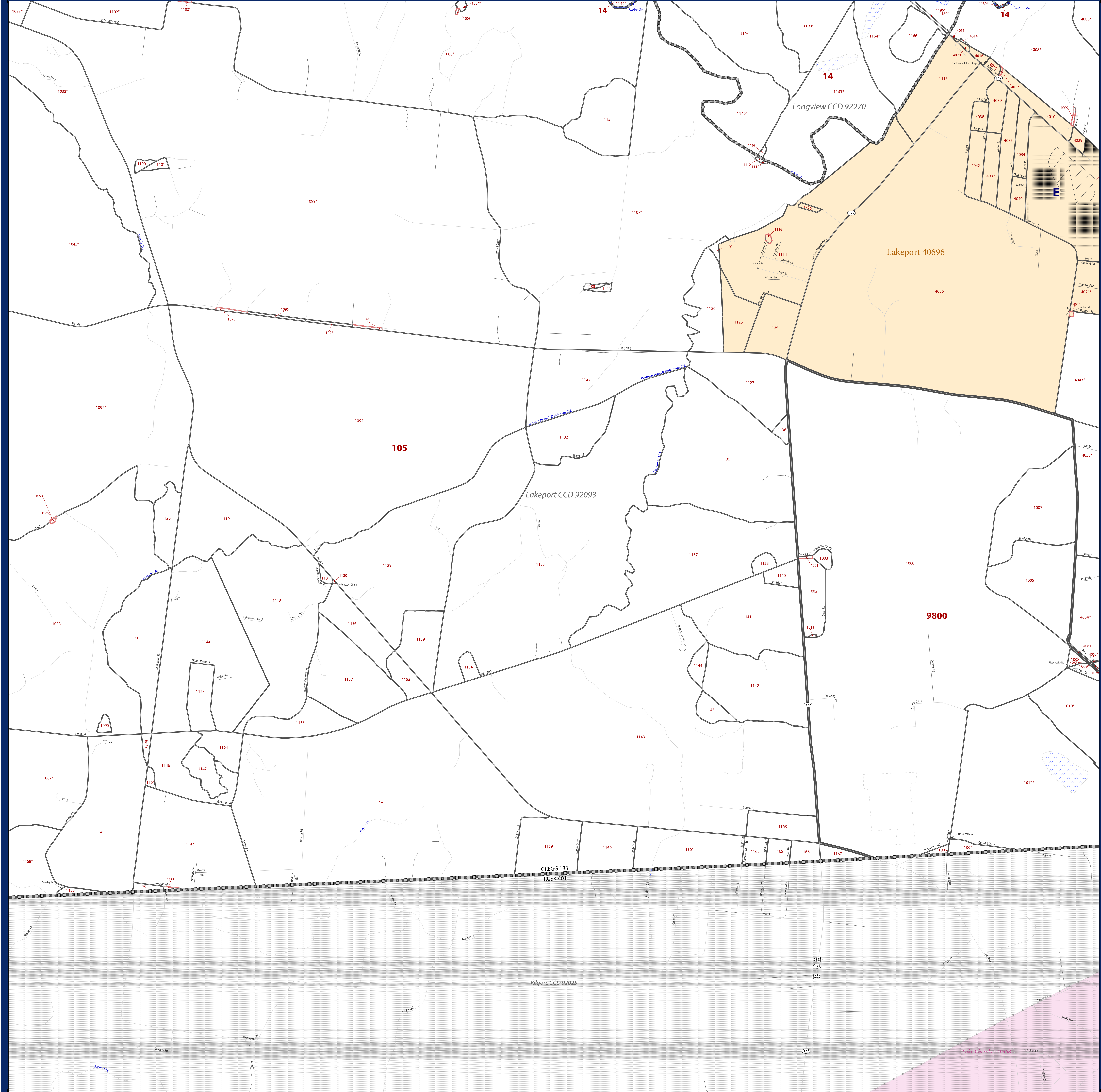


2010 CENSUS - CENSUS BLOCK MAP: Gregg County, TX

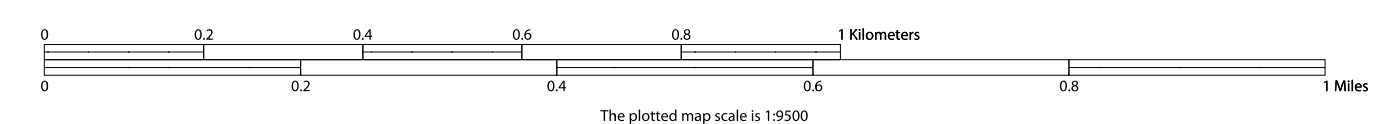
2 Place label color correlates to the place fill color.

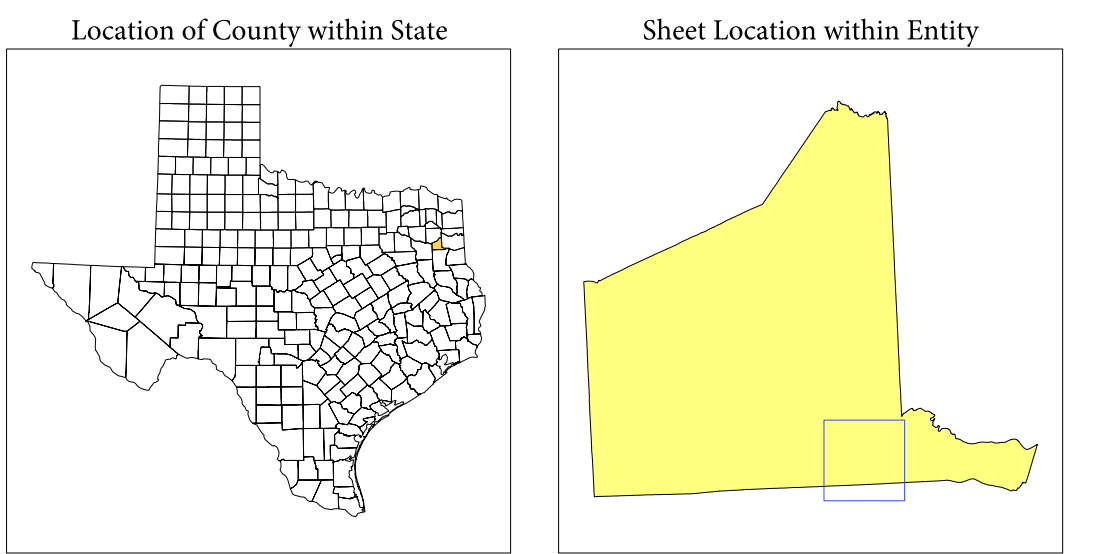
