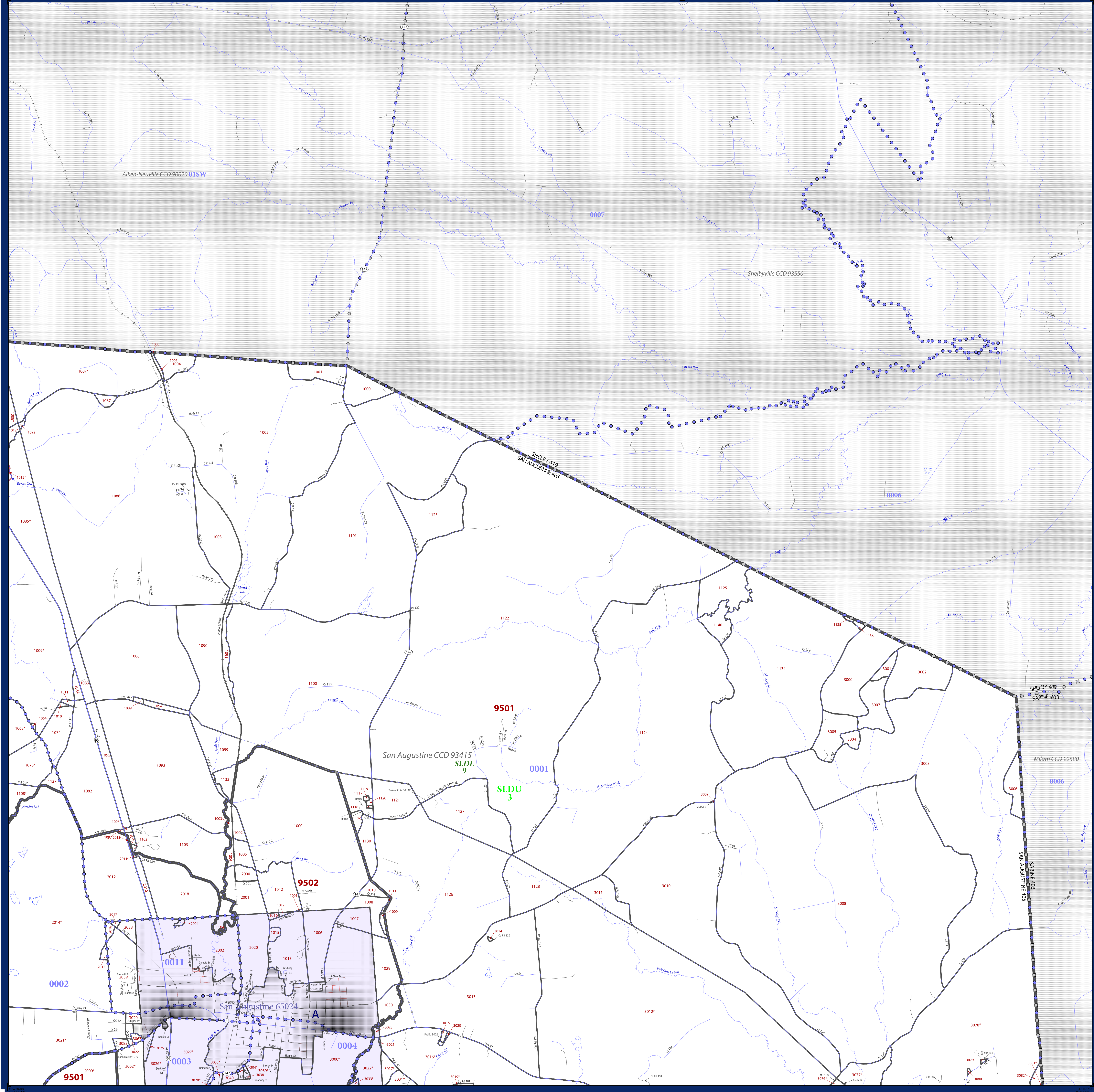


P.L. 94-171 COUNTY BLOCK MAP (2010 CENSUS): San Augustine County, TX

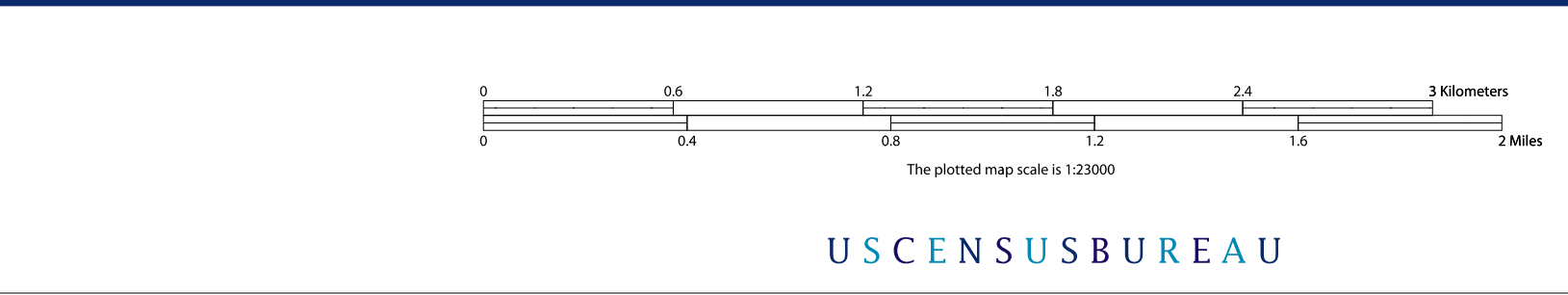
2 Place label color correlates to the place fill color.

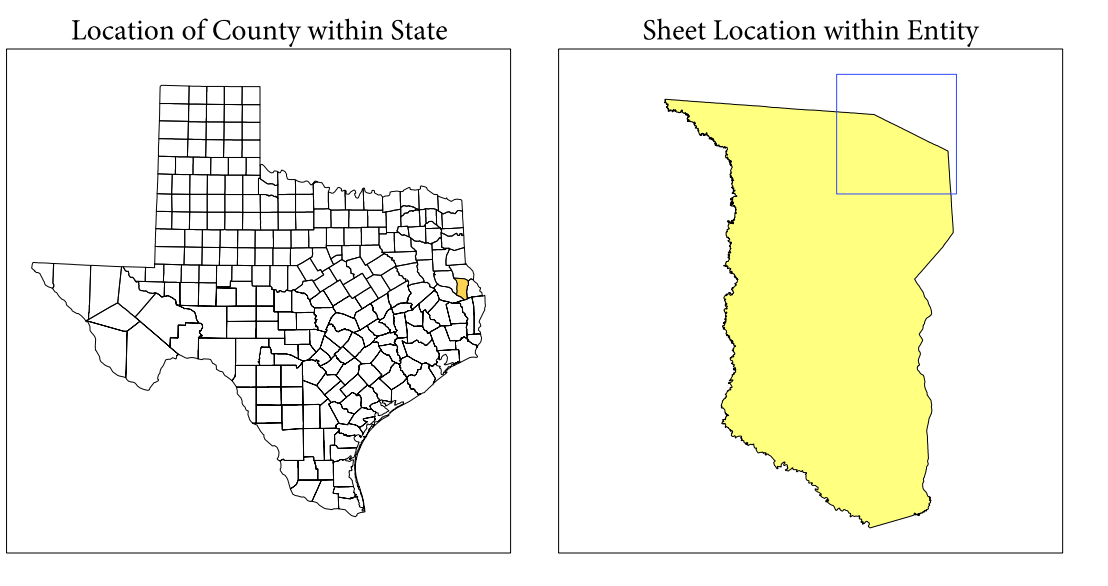
