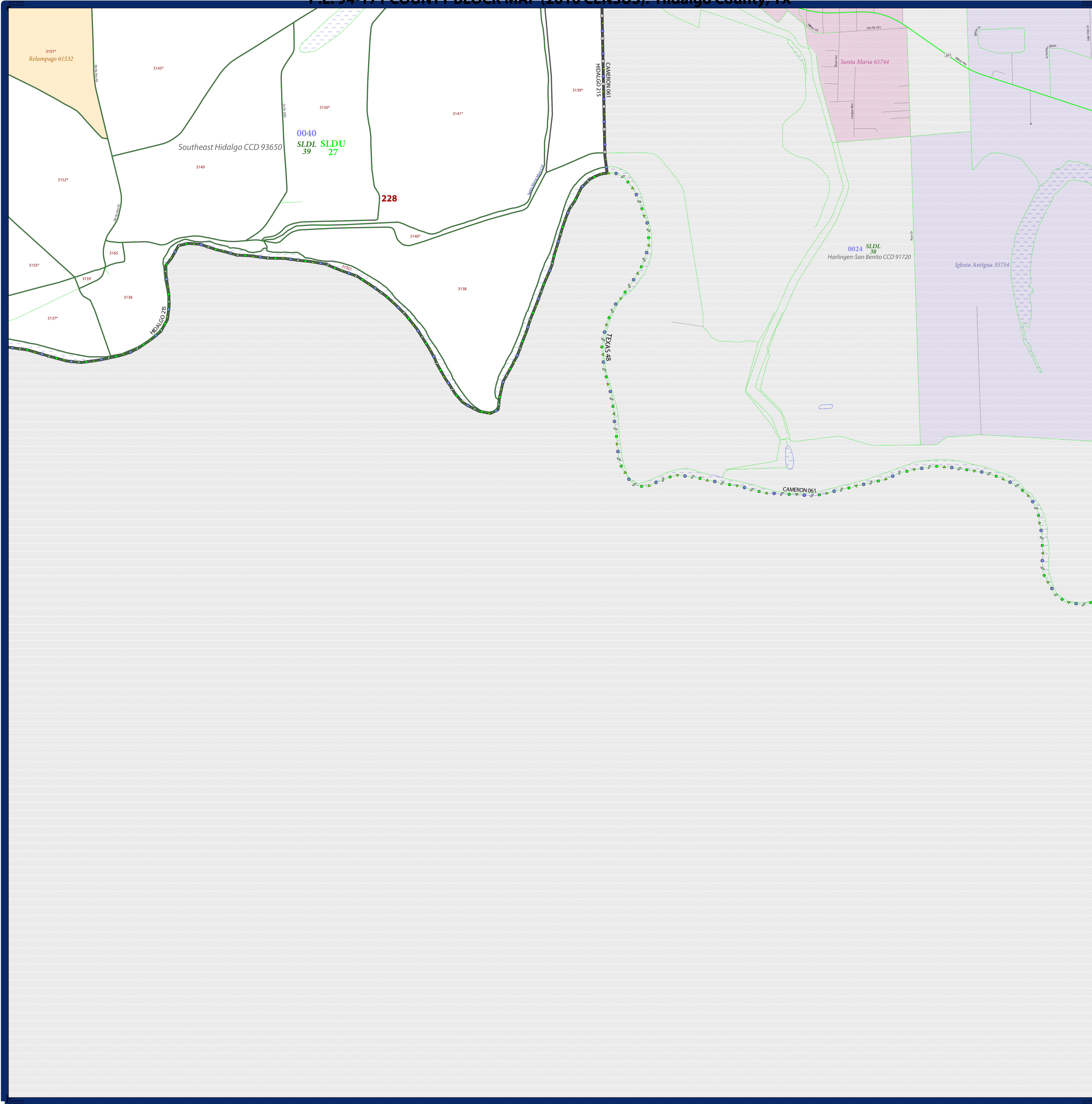


P.L. 94-171 COUNTY BLOCK MAP (2010 CENSUS): Hidalgo County, TX

² Place label color correlates to the place fill color.

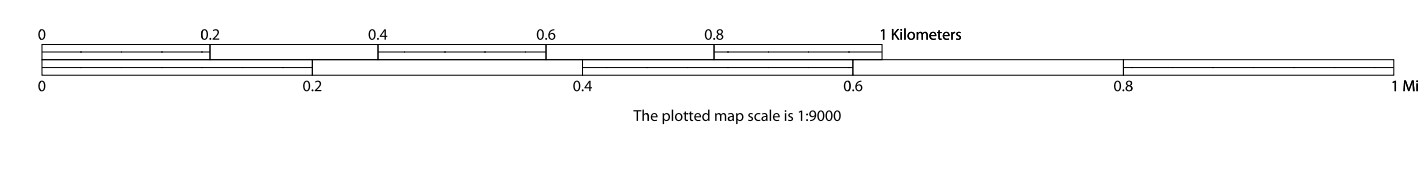
³ A " " following a block number indicates that the block number is repeated elsewhere in the block.

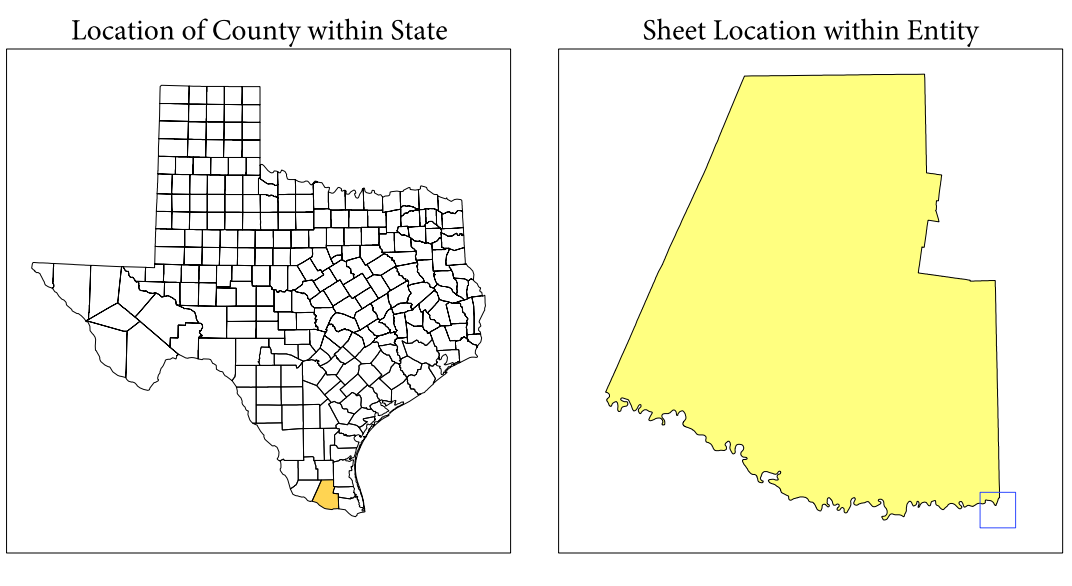
