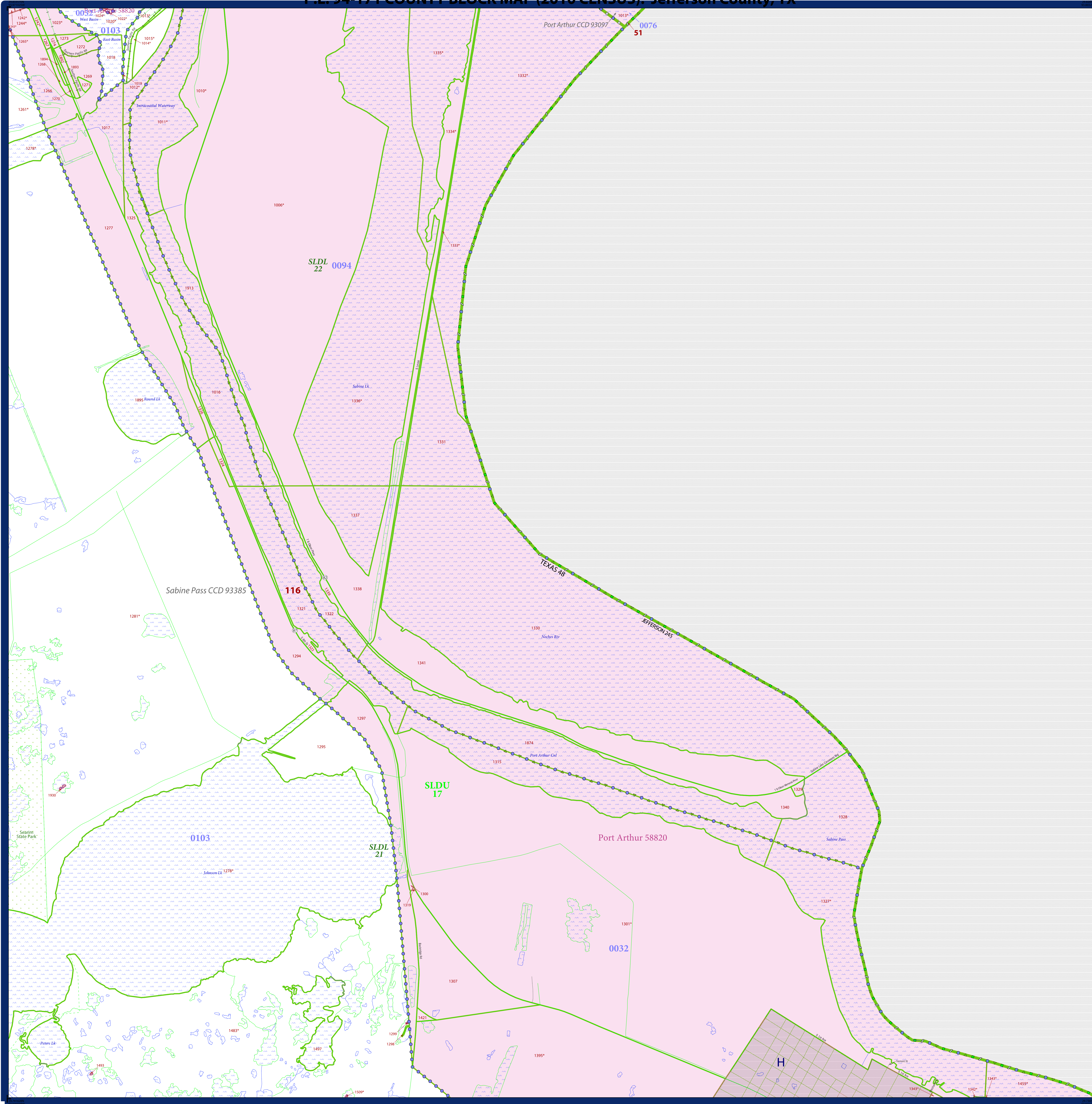


P.L. 94-171 COUNTY BLOCK MAP (2010 CENSUS): Jefferson County, TX
