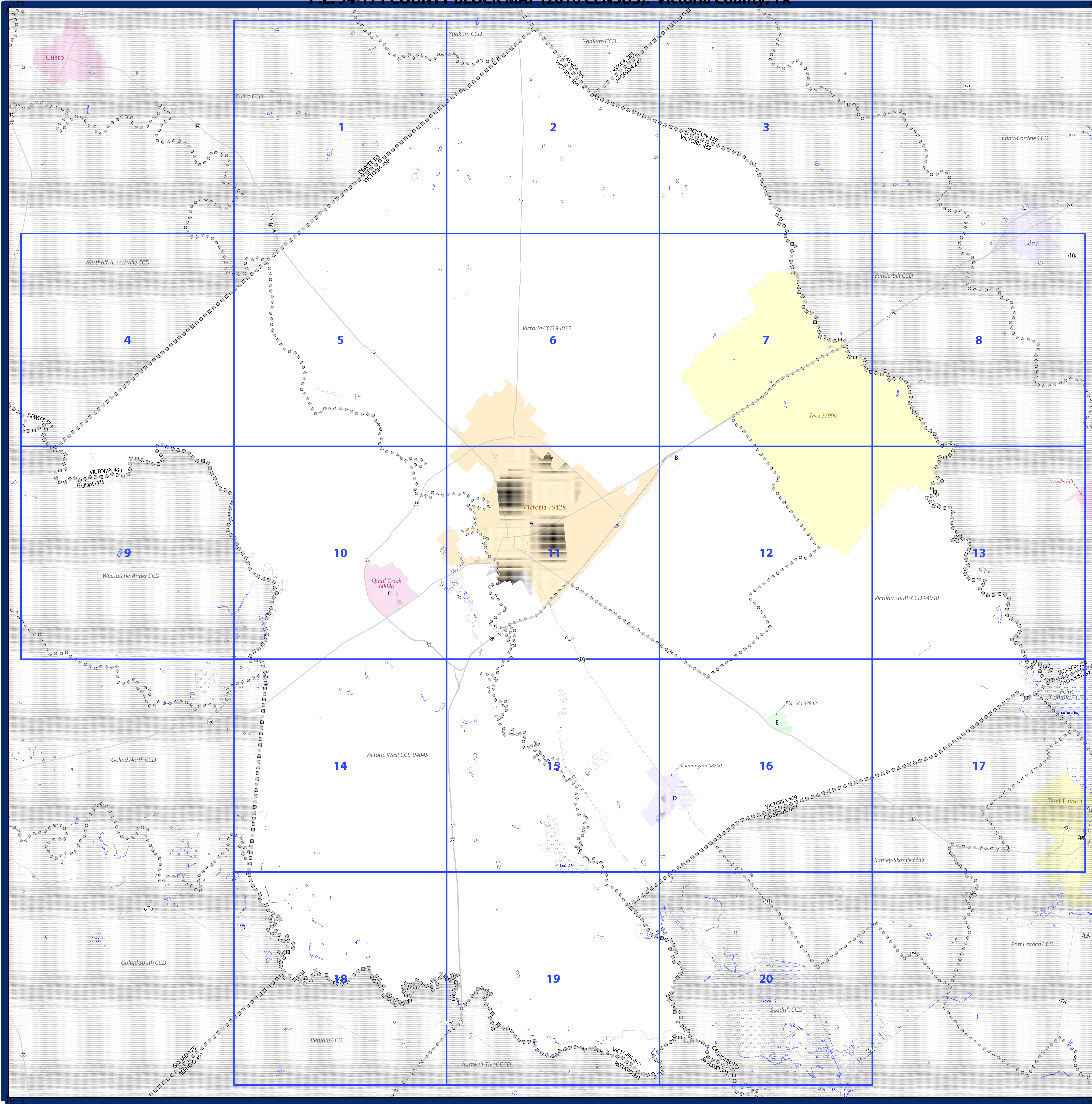


# P.L. 94-171 COUNTY BLOCK MAP (2010 CENSUS): Victoria County, TX

3 A \* following a block number indicates that the block number is repeated elsewhere in the block.

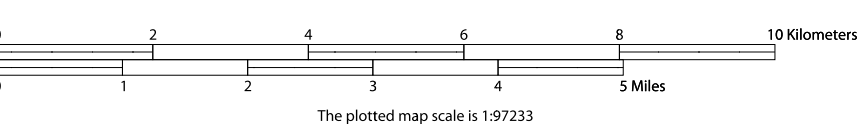
