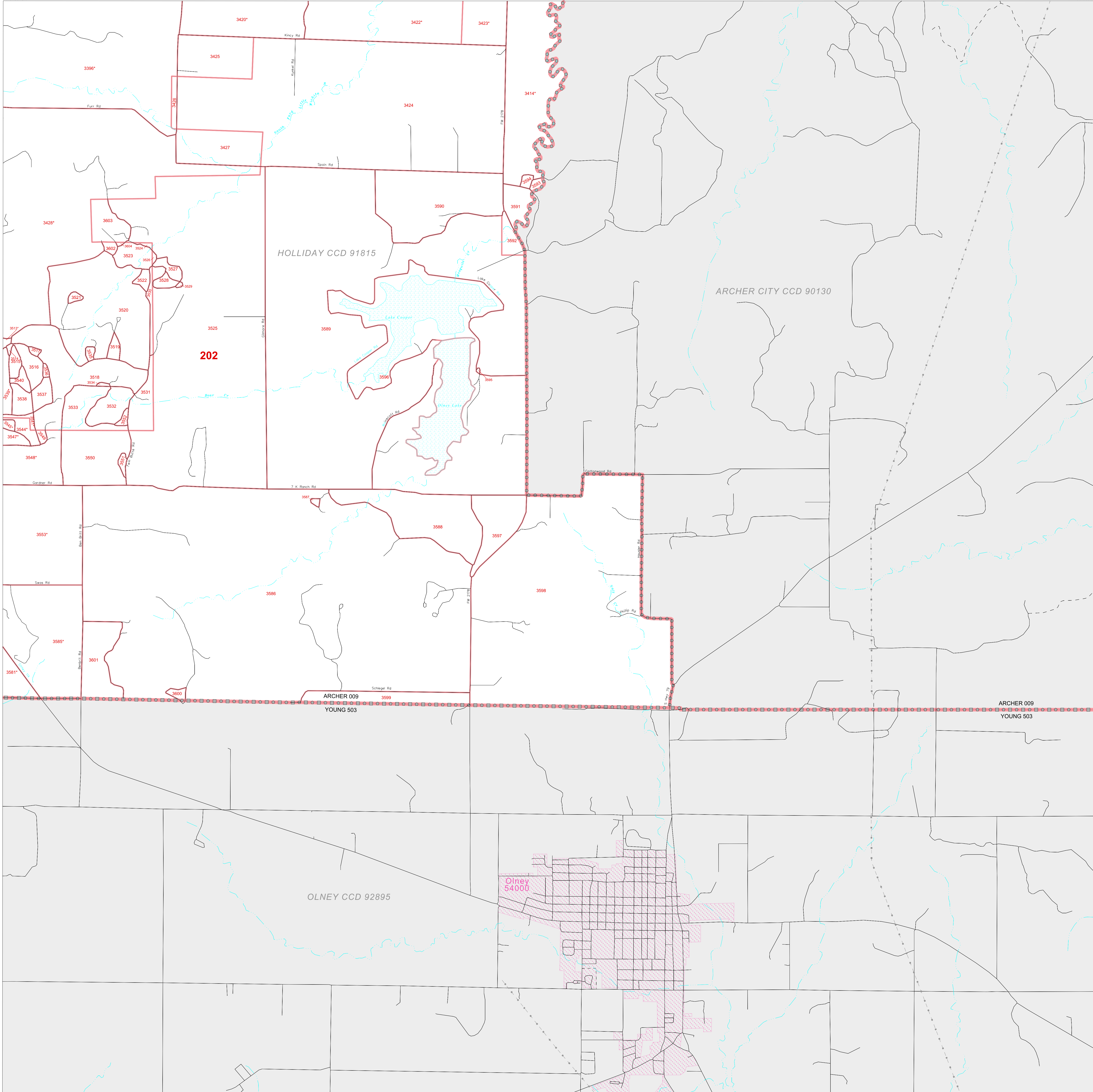


CENSUS 2000 BLOCK MAP: HOLLIDAY CCD

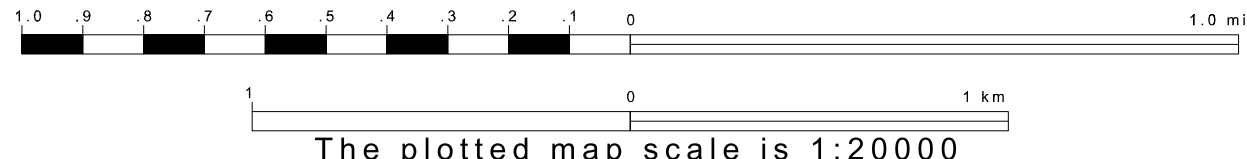
