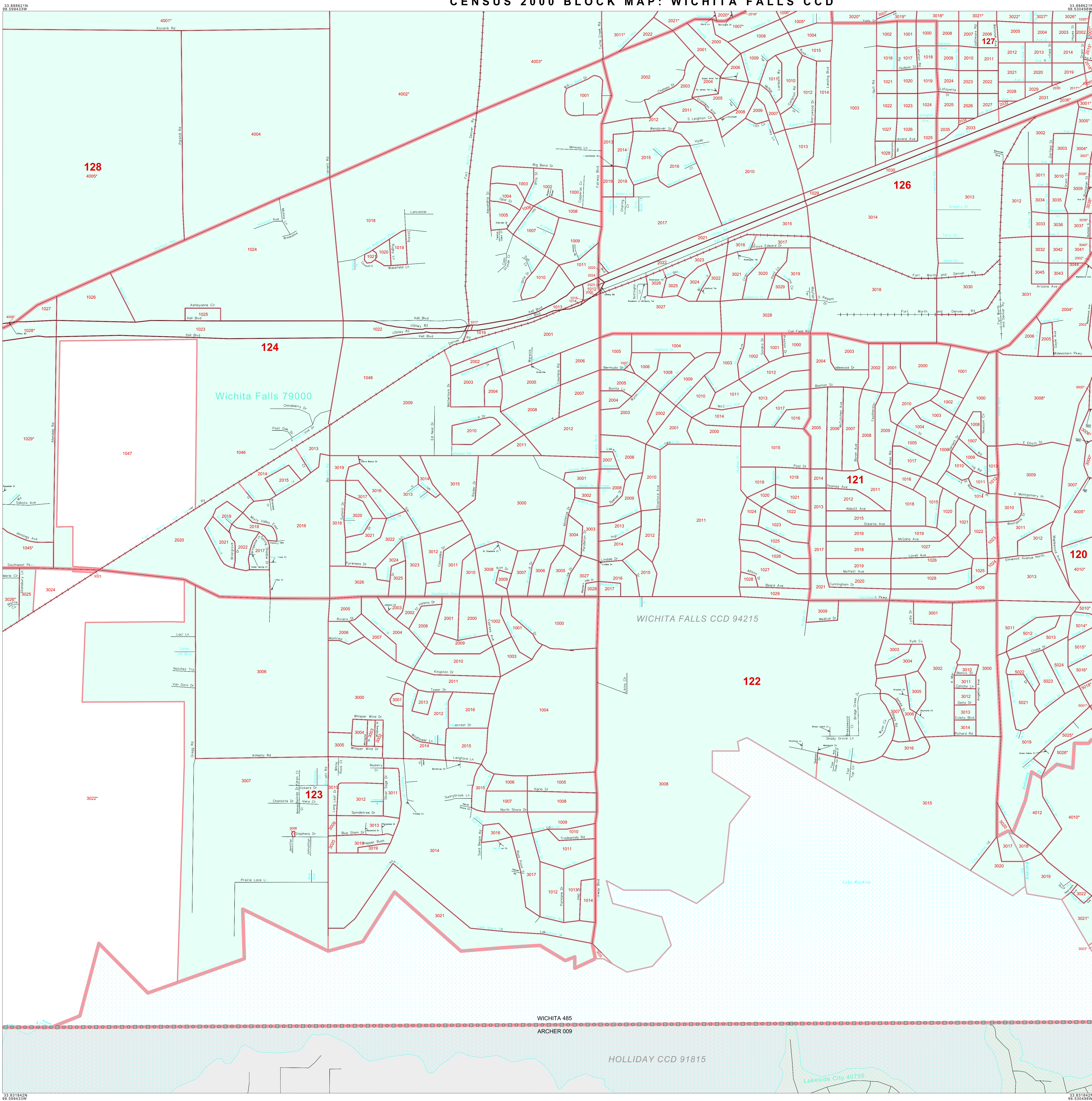


CENSUS 2000 BLOCK MAP: WICHITA FALLS CCD
