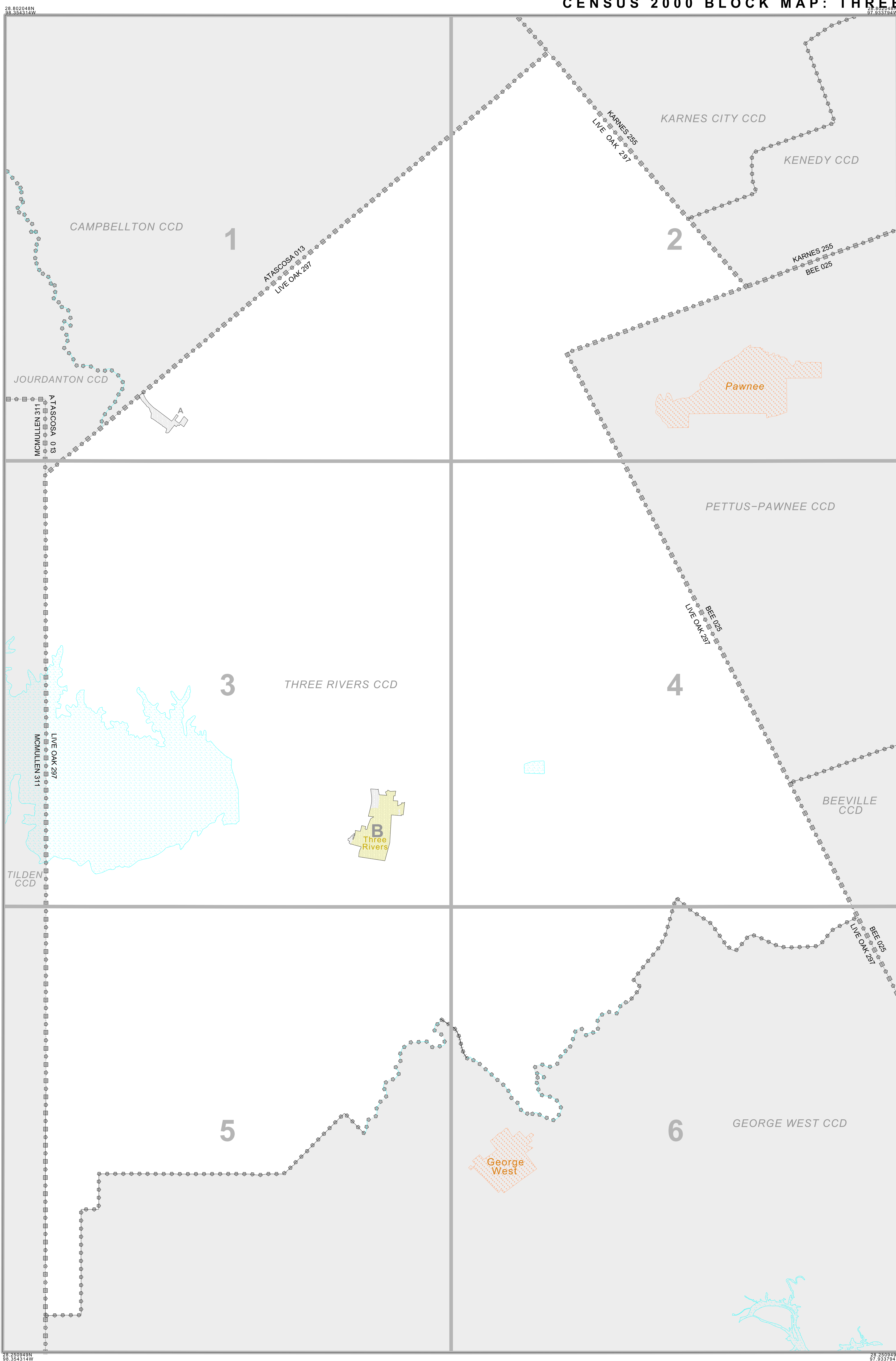


# CENSUS 2000 BLOCK MAP: THREE RIVERS CCD

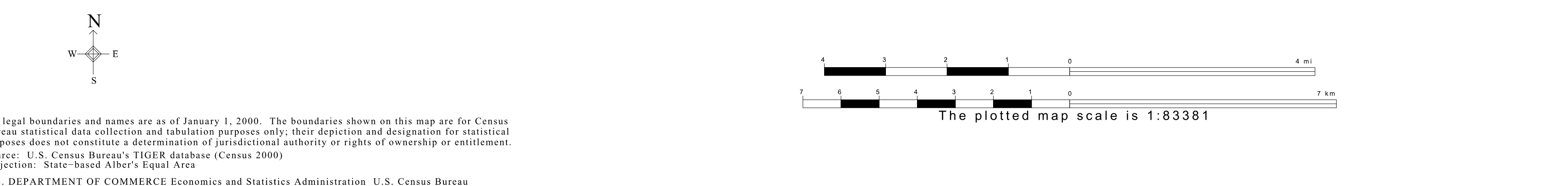
