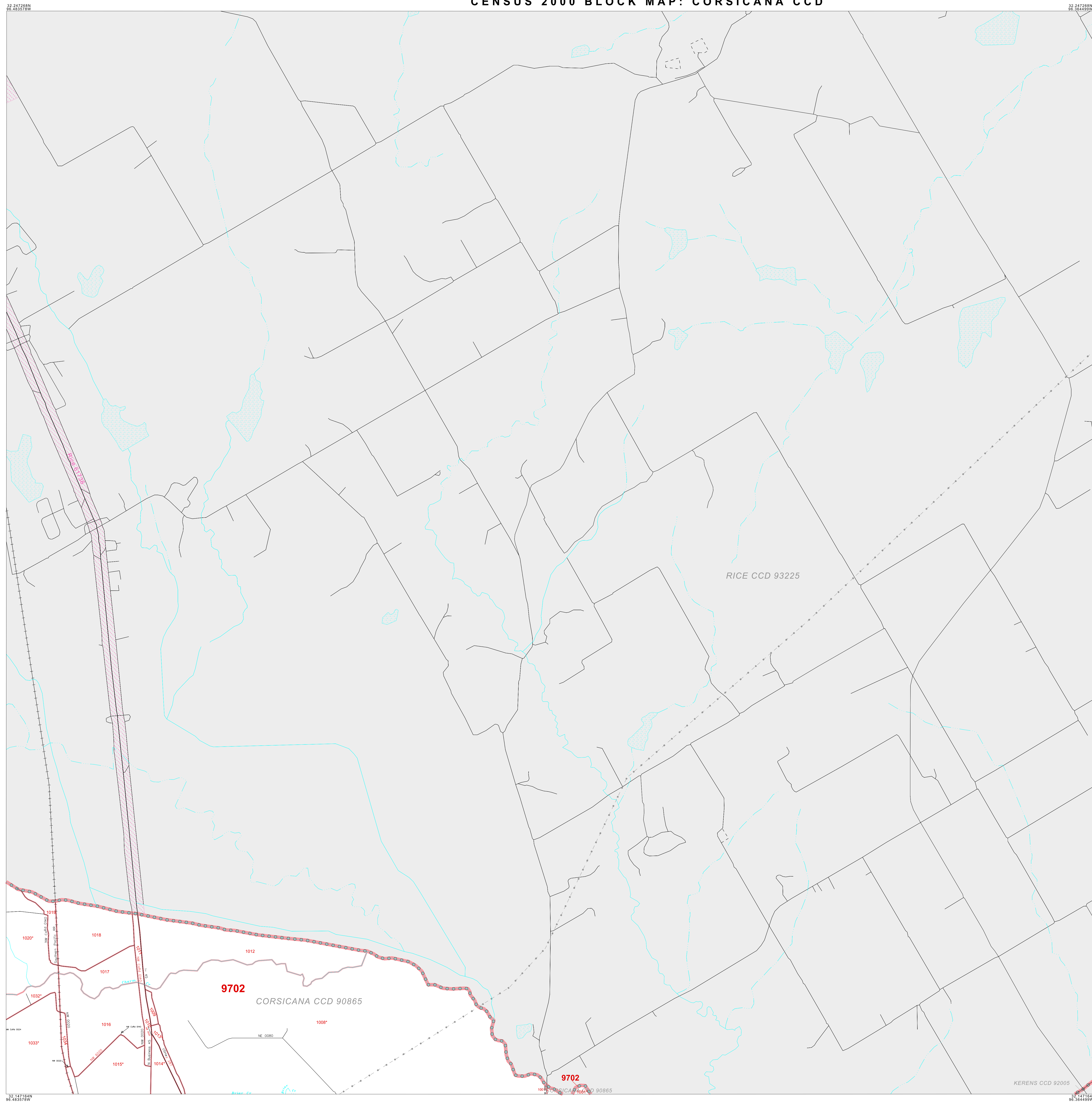


CENSUS 2000 BLOCK MAP: CORSICANA CCD
