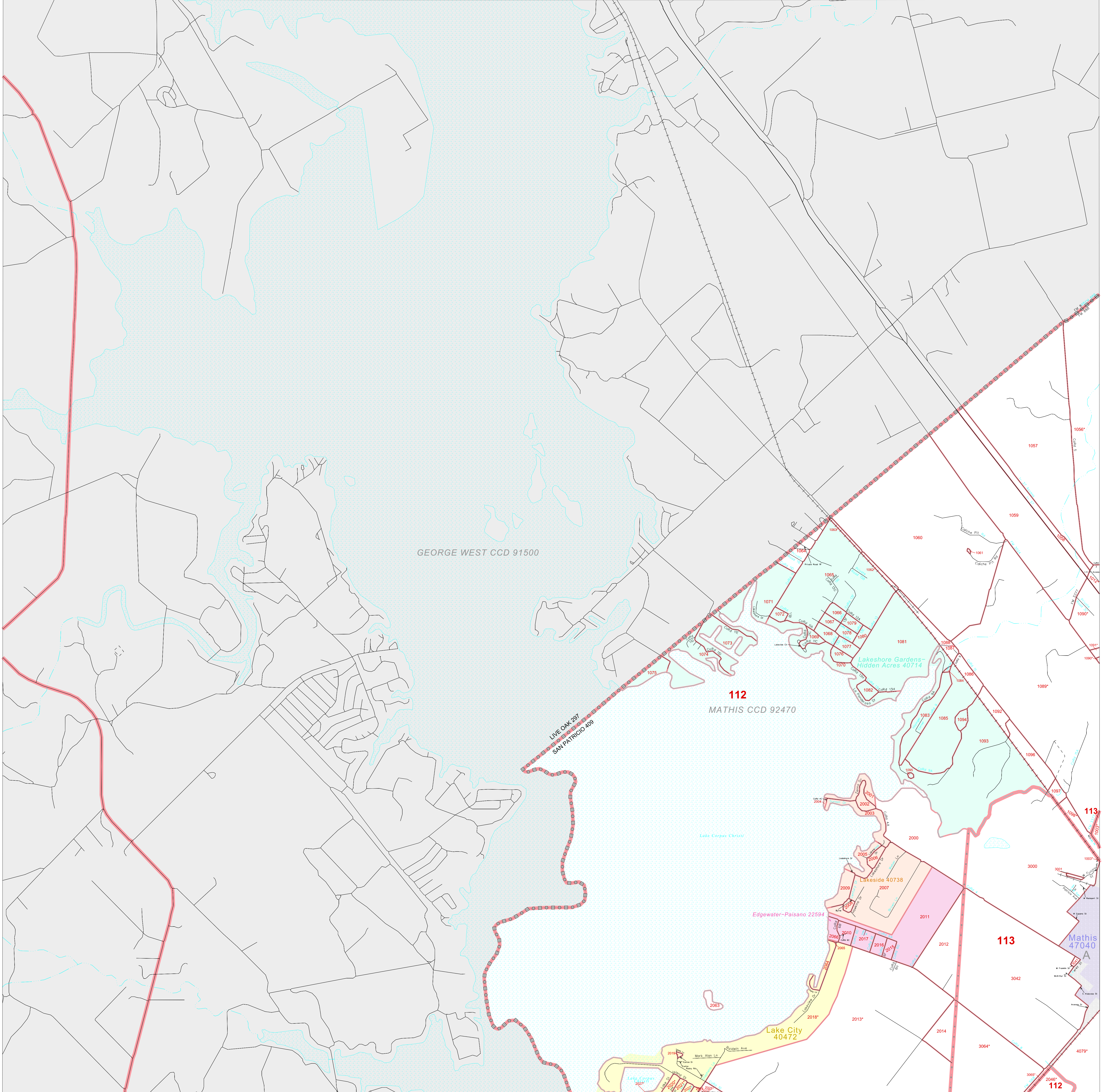


CENSUS 2000 BLOCK MAP: MATHIS CCD

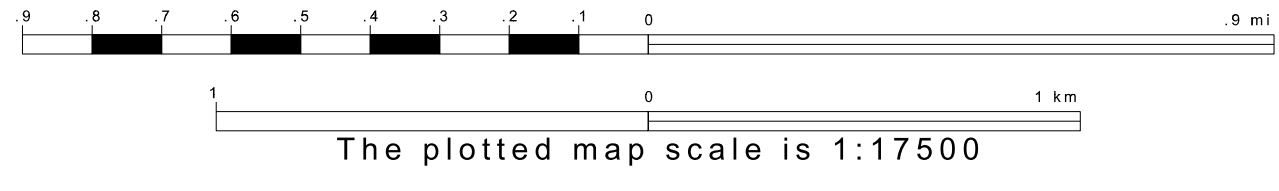
