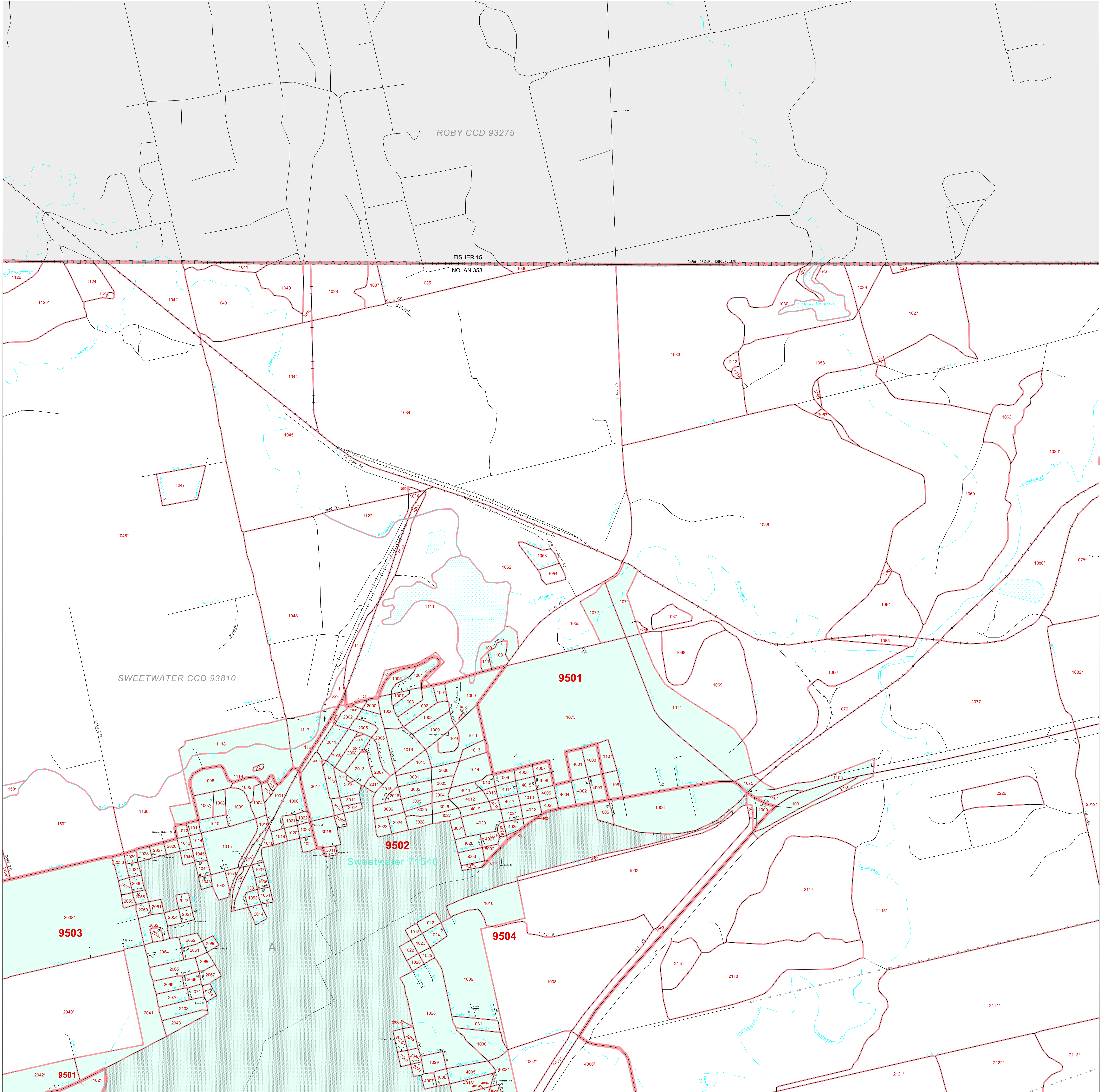


CENSUS 2000 BLOCK MAP: SWEETWATER CCD
