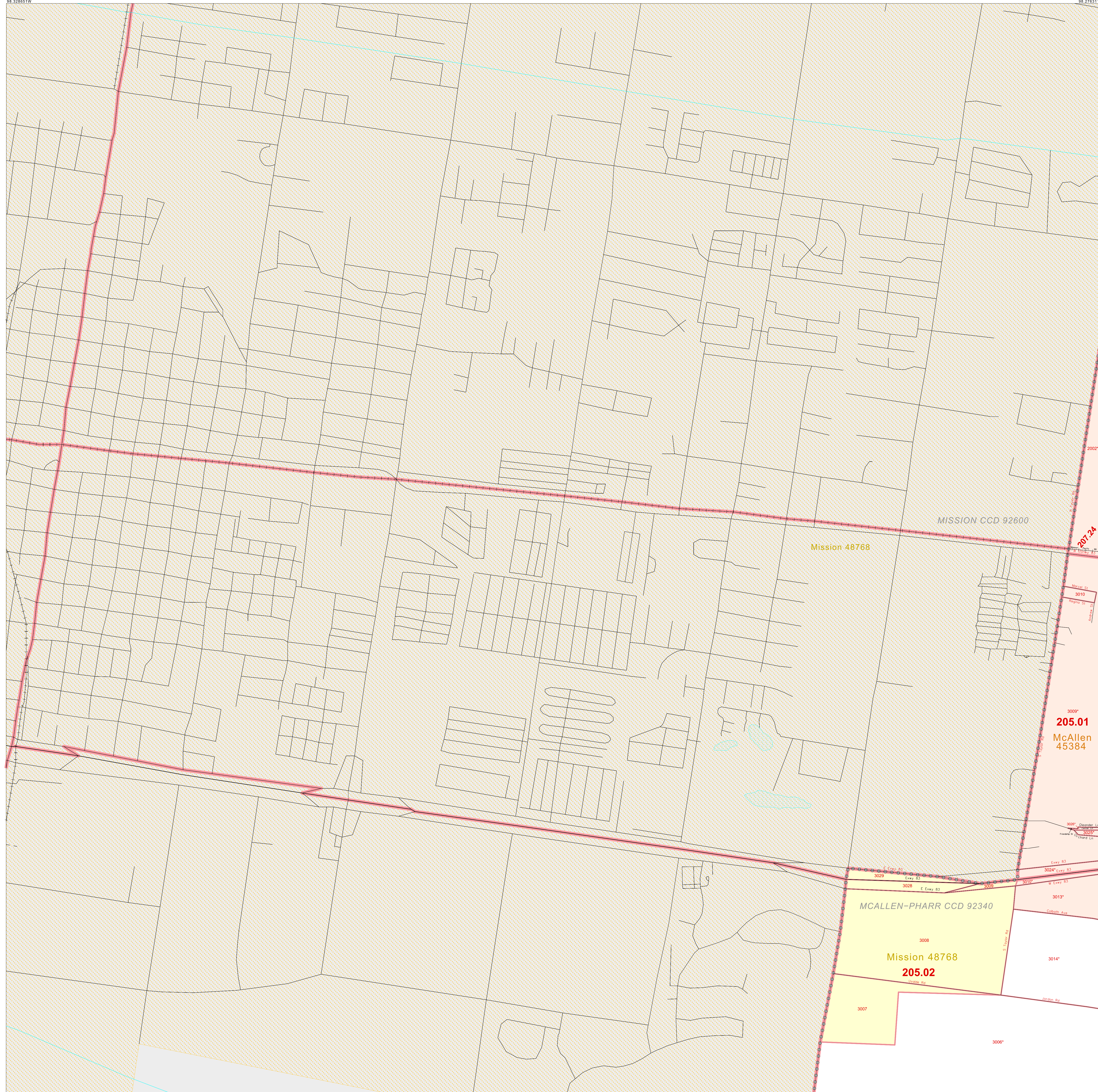


CENSUS 2000 BLOCK MAP: MCALLEN-PHARR CCD

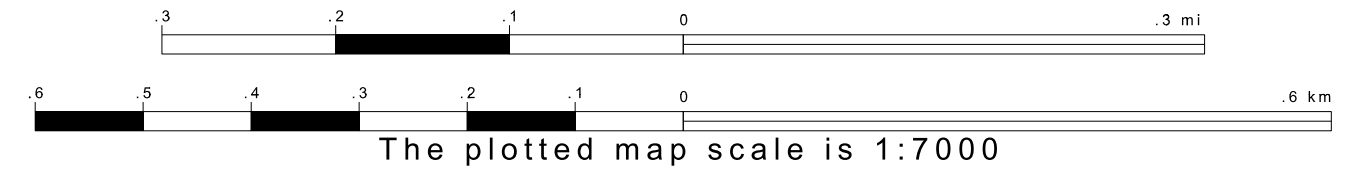
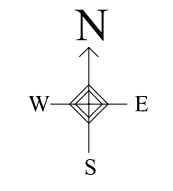
