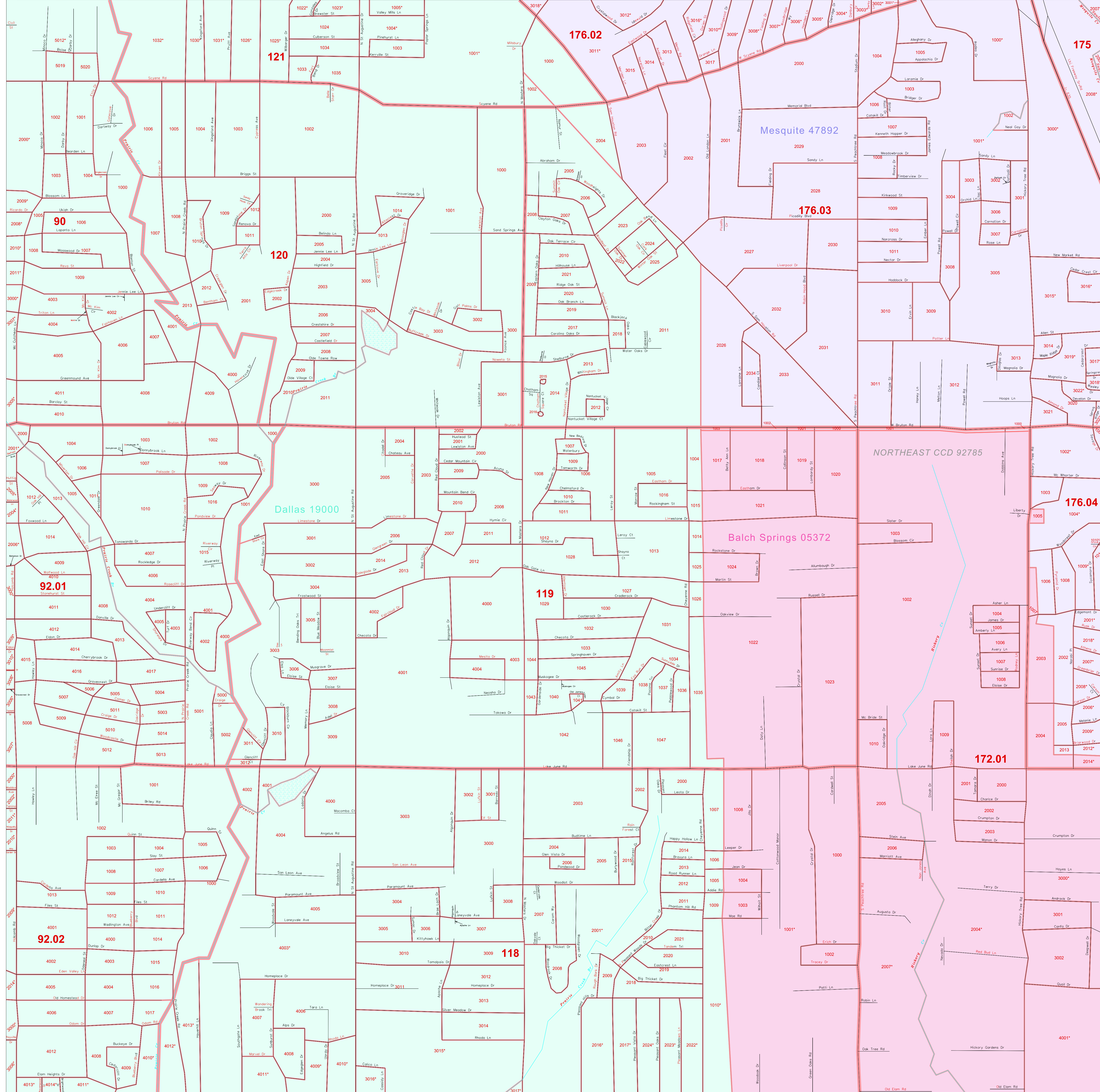


CENSUS 2000 BLOCK MAP: NORTHEAST CCD

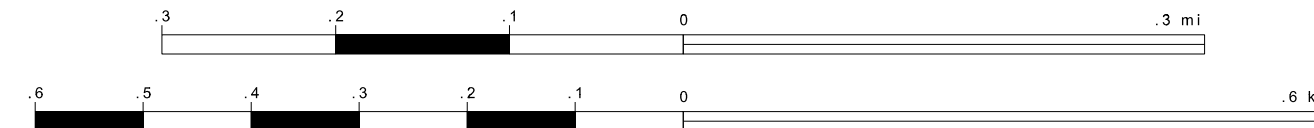
