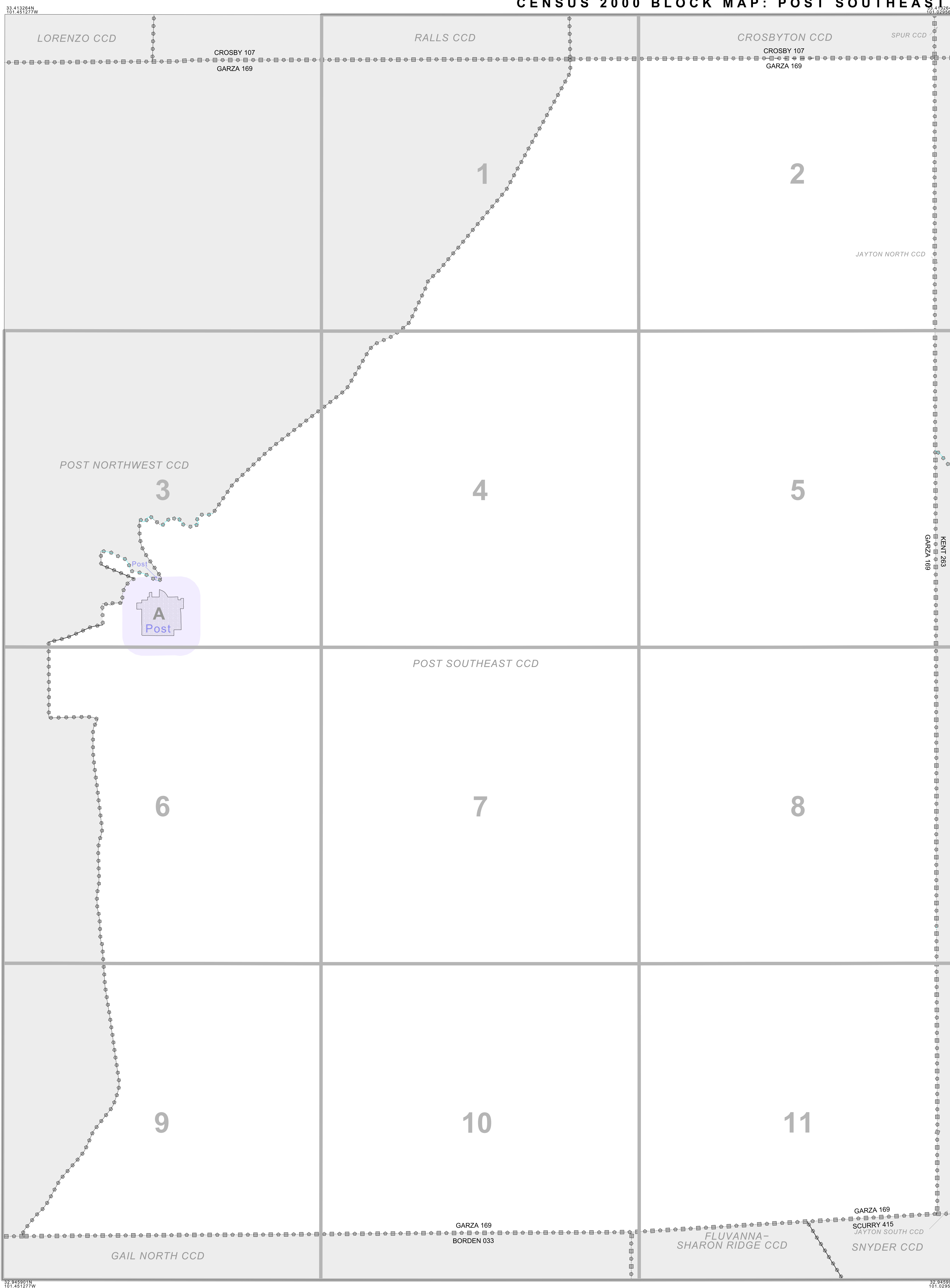


CENSUS 2000 BLOCK MAP: POST SOUTHEAST CCD
