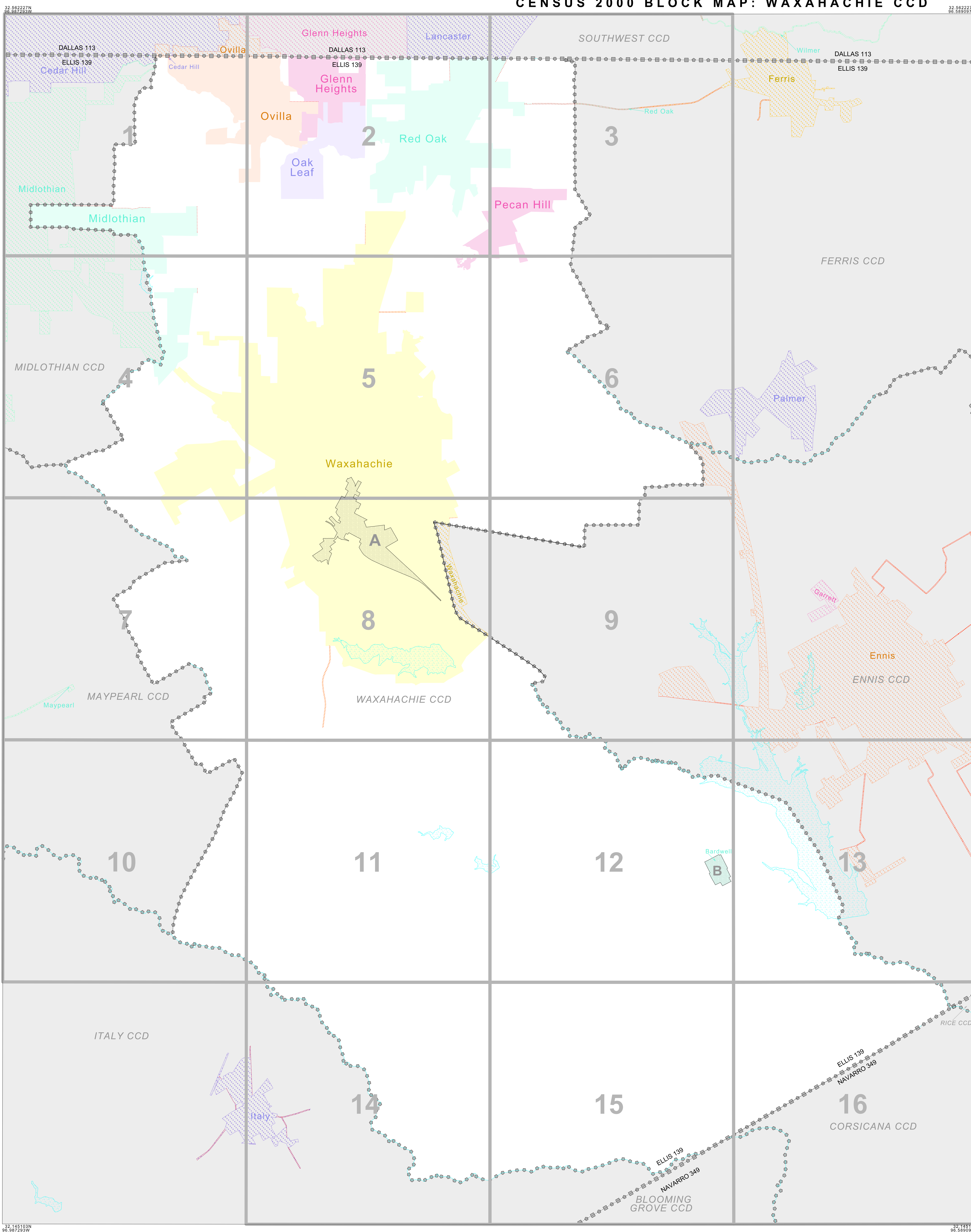


CENSUS 2000 BLOCK MAP: WAXAHACHIE CCD

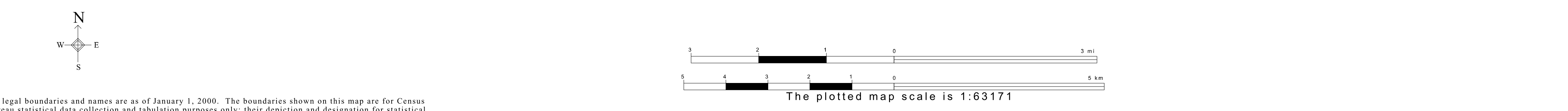
