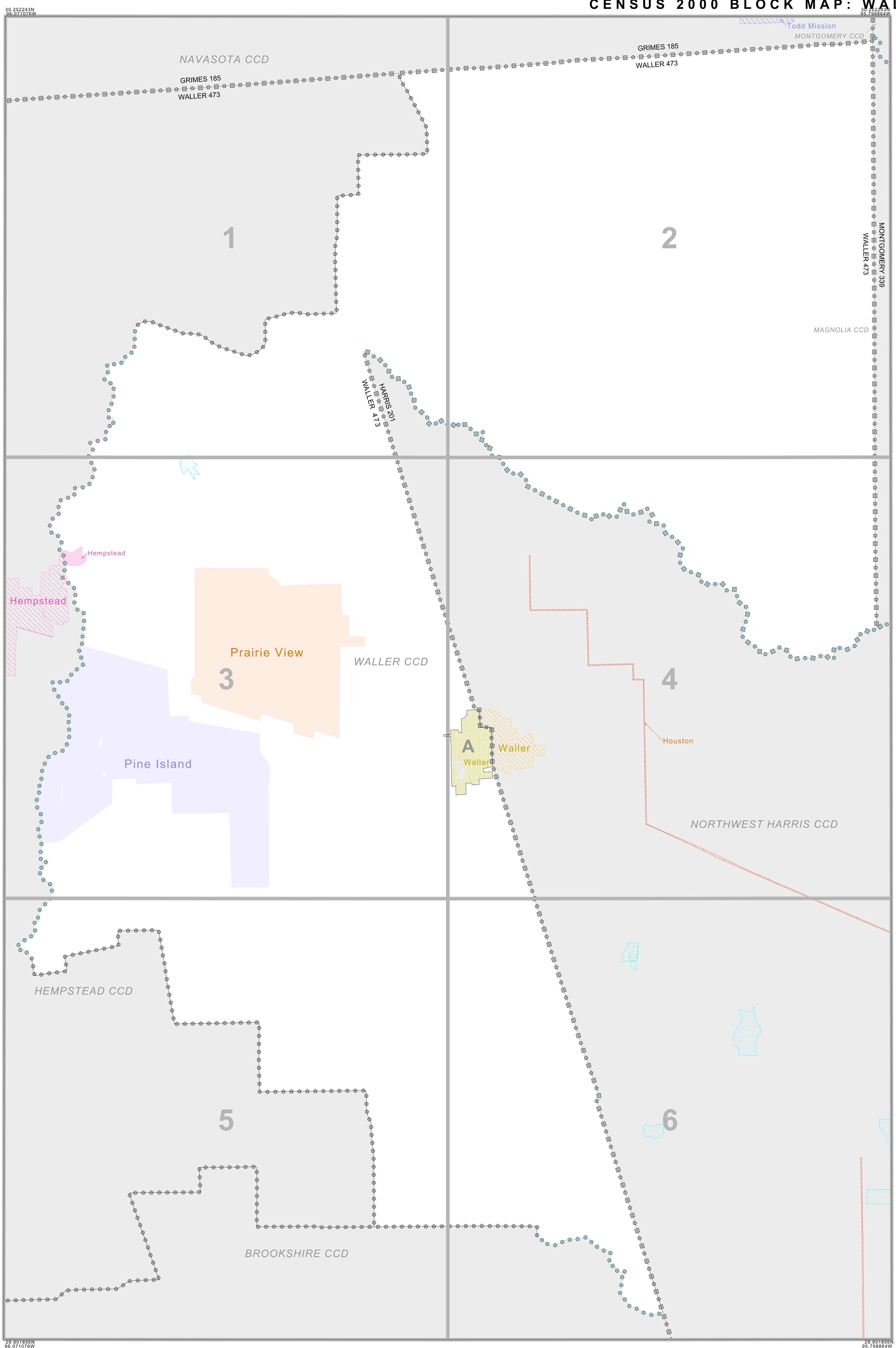


CENSUS 2000 BLOCK MAP: WALLER CCD

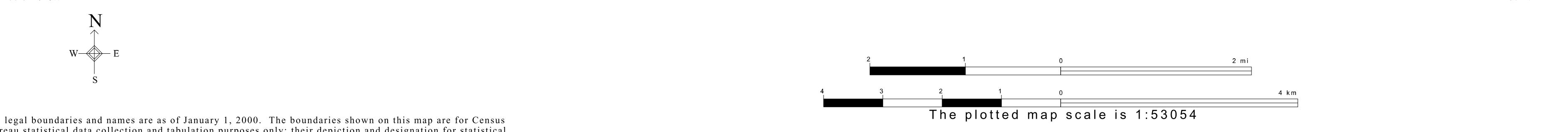
