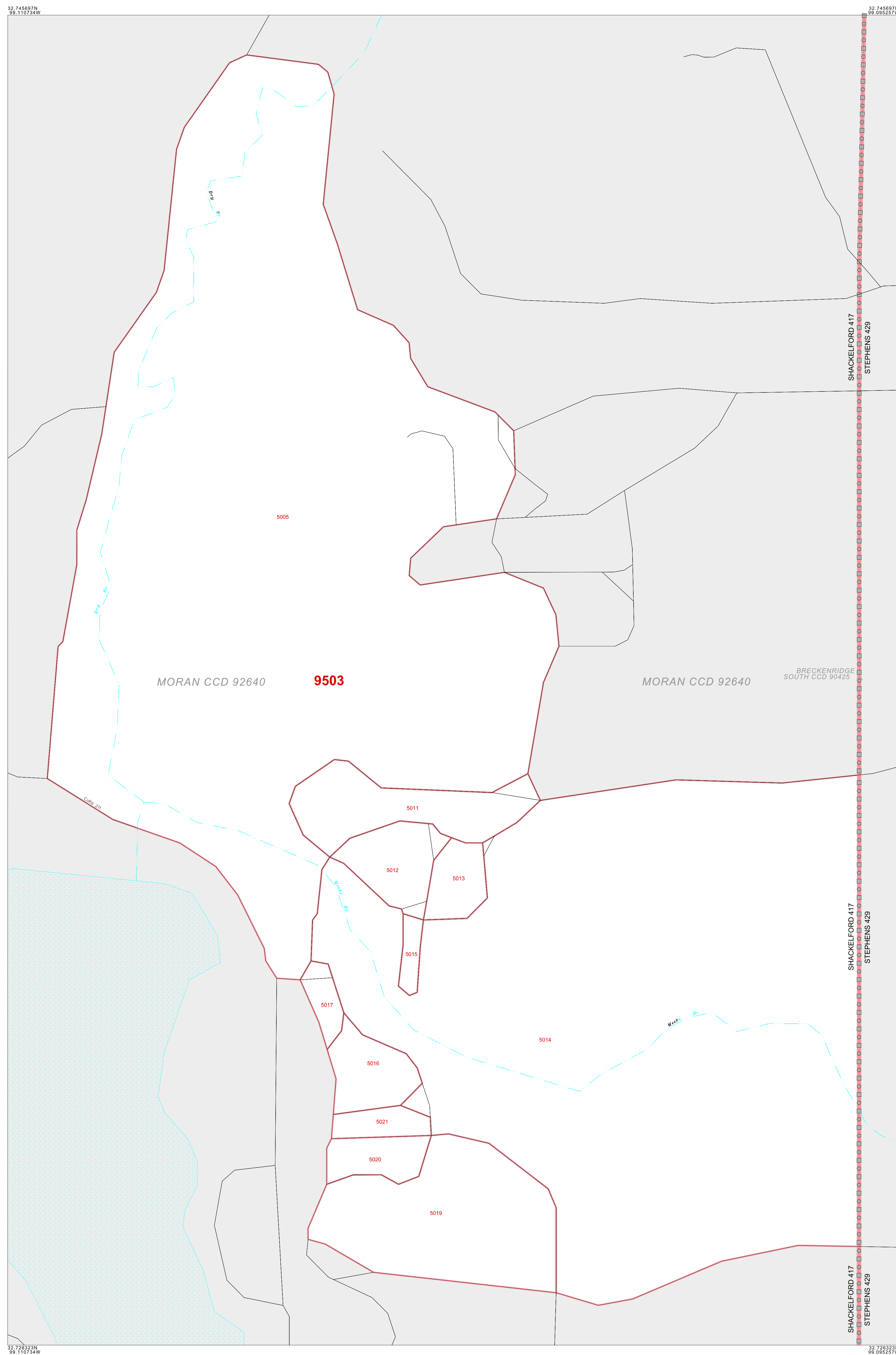


CENSUS 2000 BLOCKMAP: MORAN CCD
