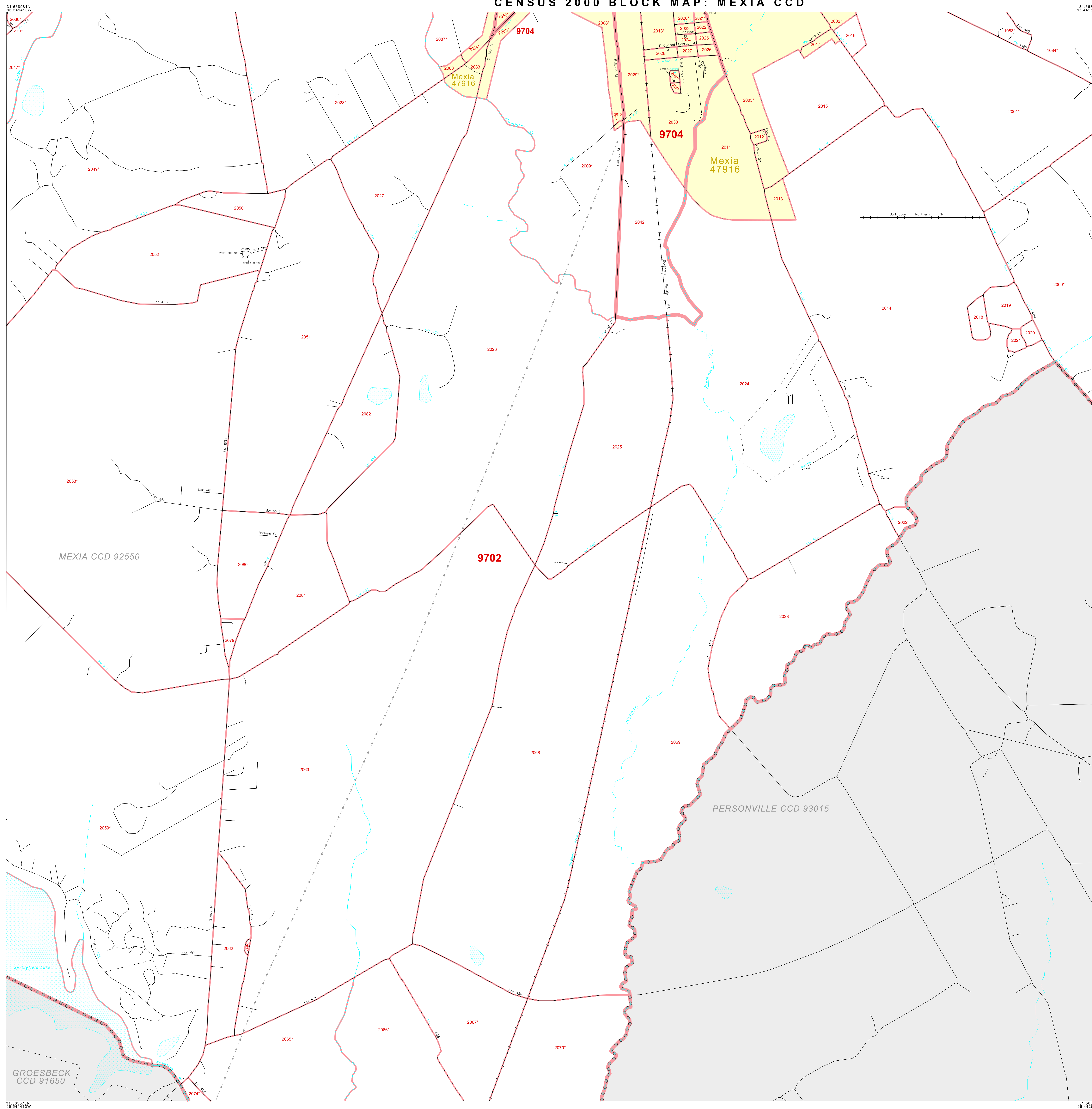


CENSUS 2000 BLOCK MAP: MEXIA CCD
