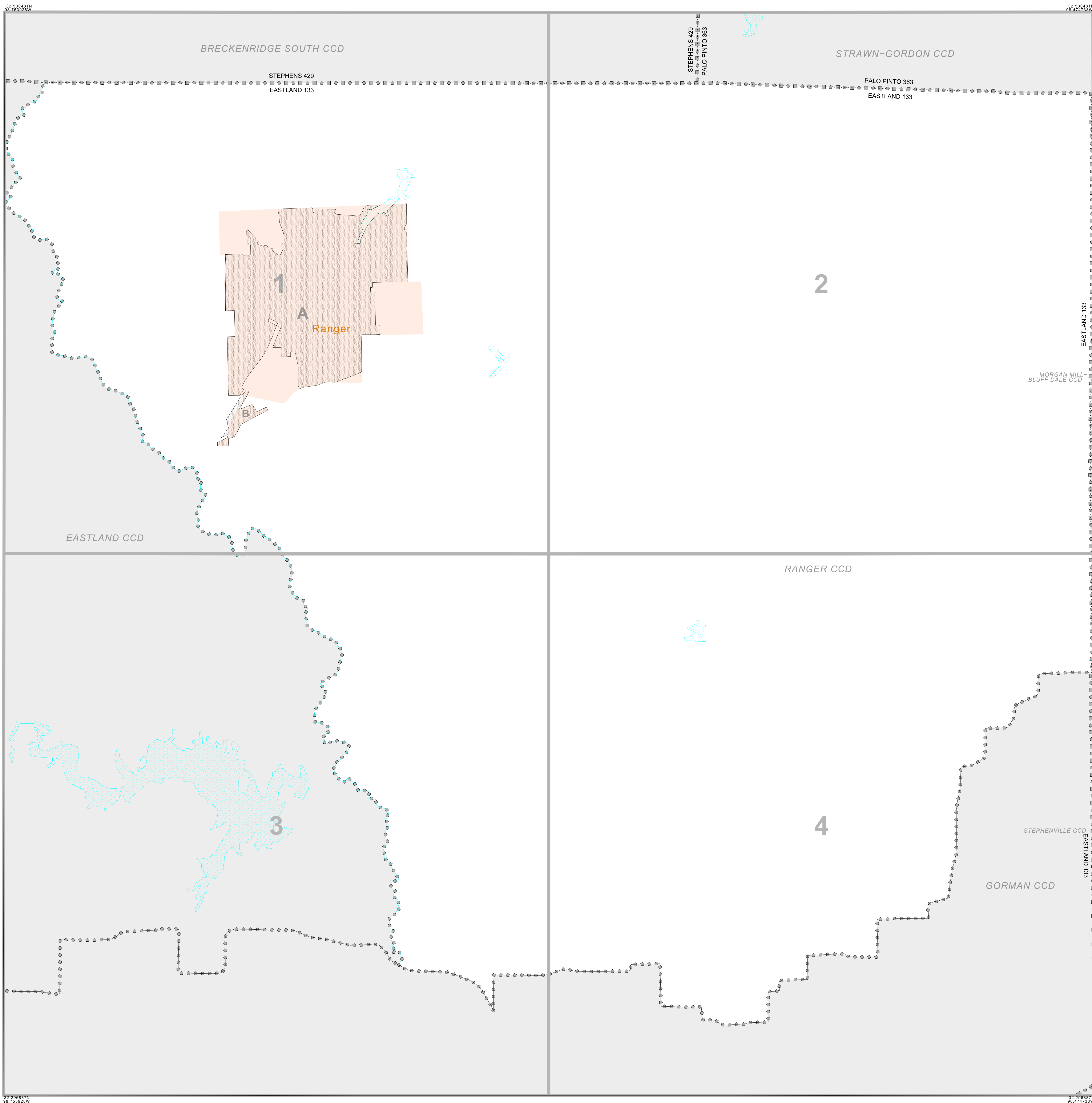


CENSUS 2000 BLOCK MAP: RANGER CCD

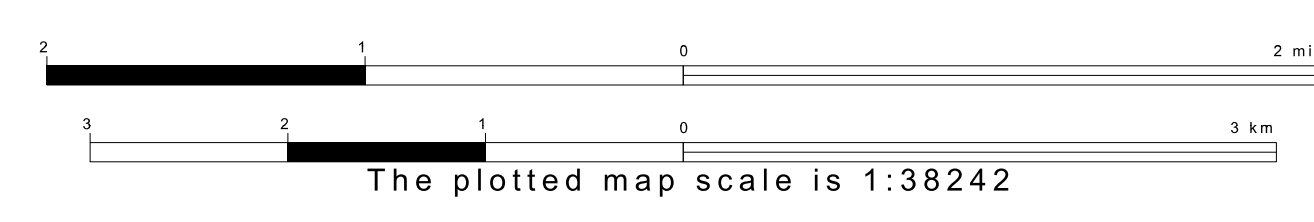
