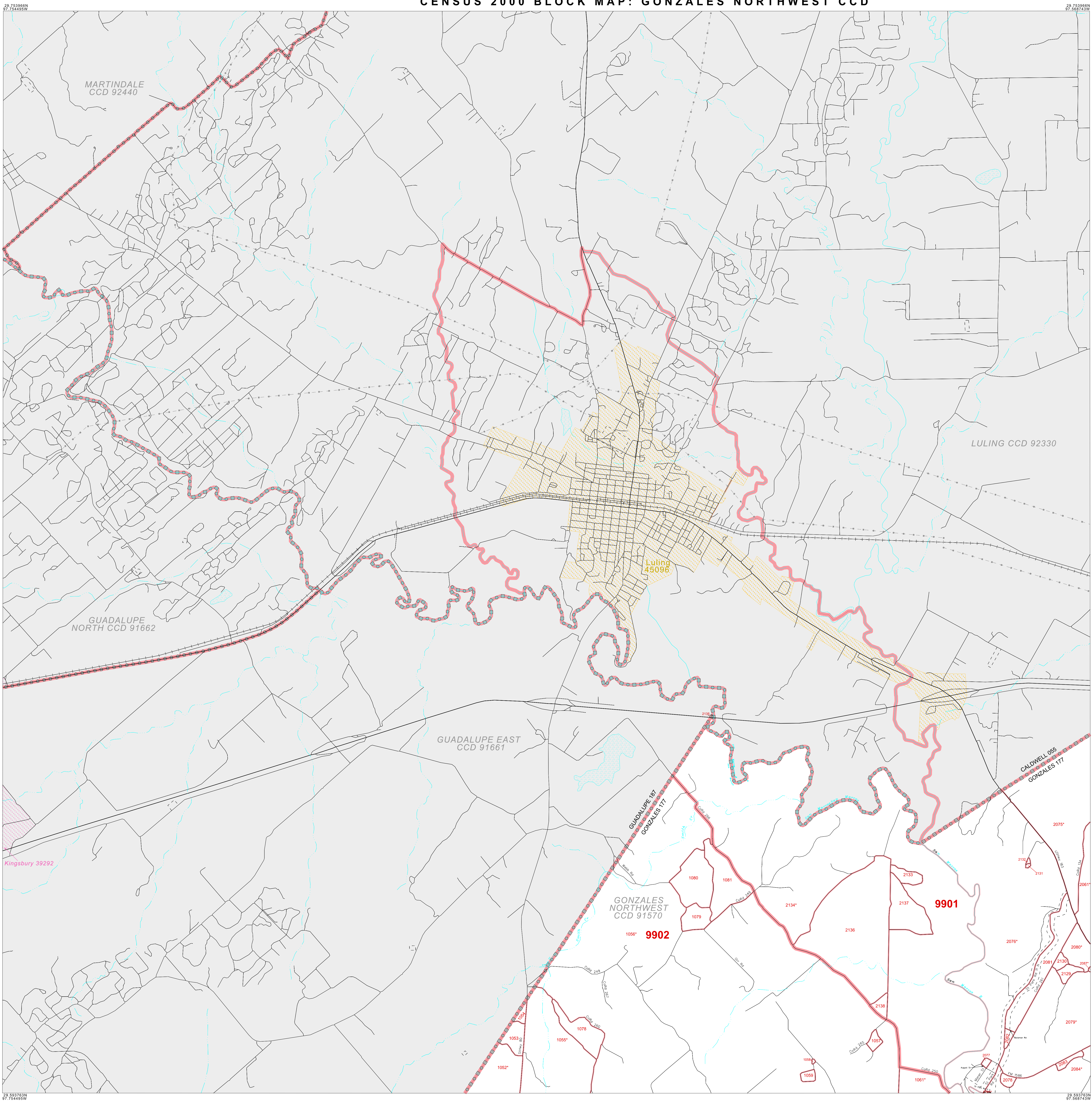


CENSUS 2000 BLOCK MAP: GONZALES NORTHWEST CCD
