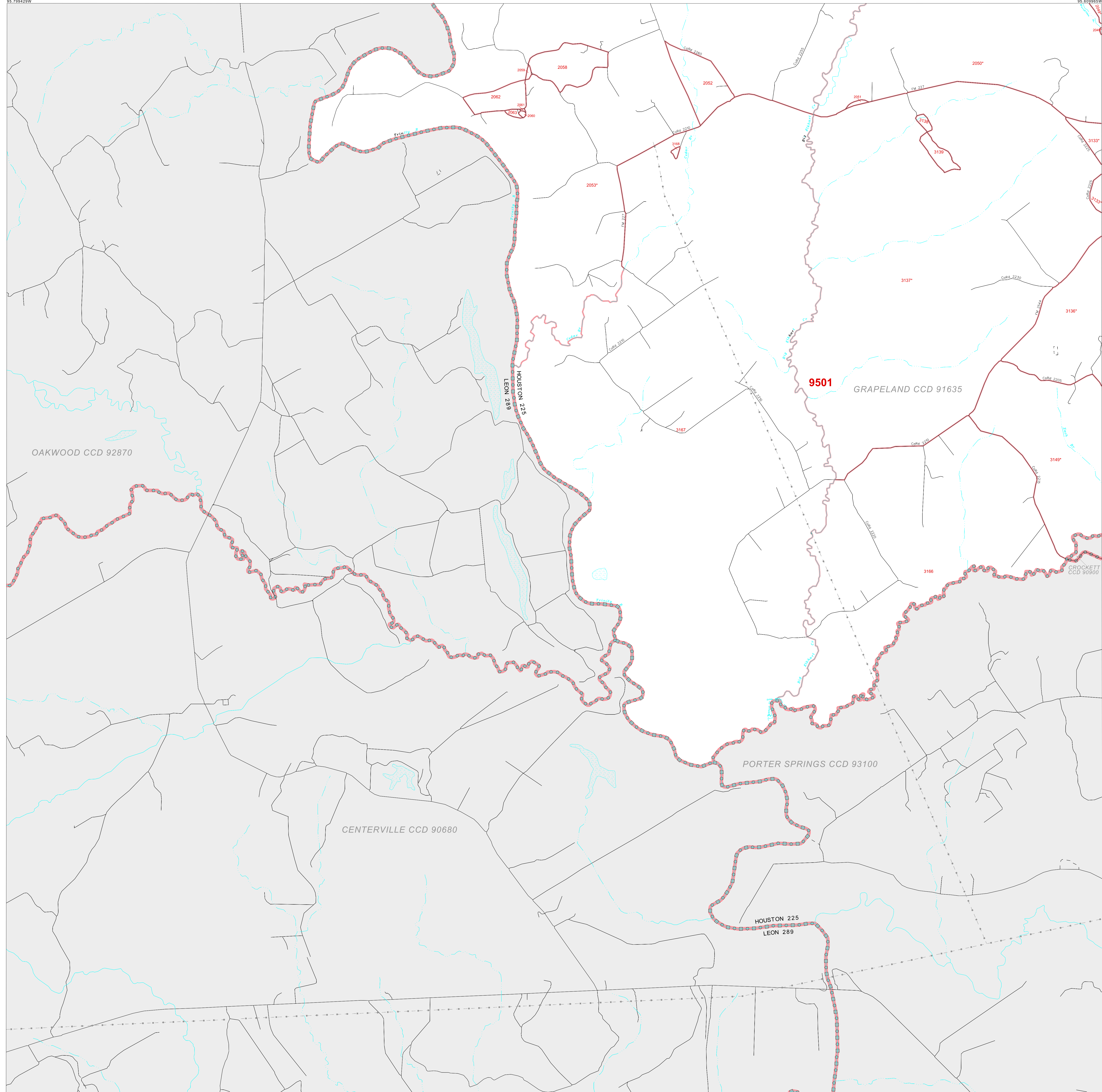


CENSUS 2000 BLOCK MAP: GRAPELAND CCD

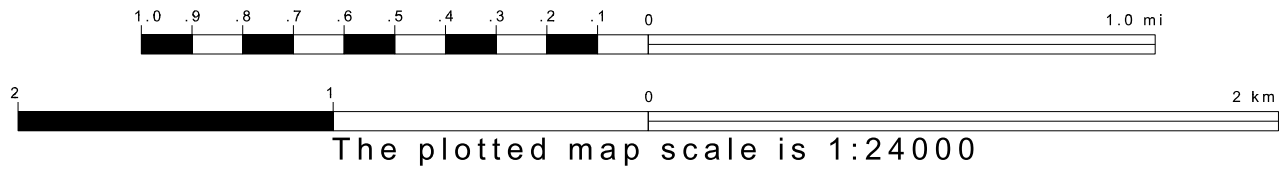
