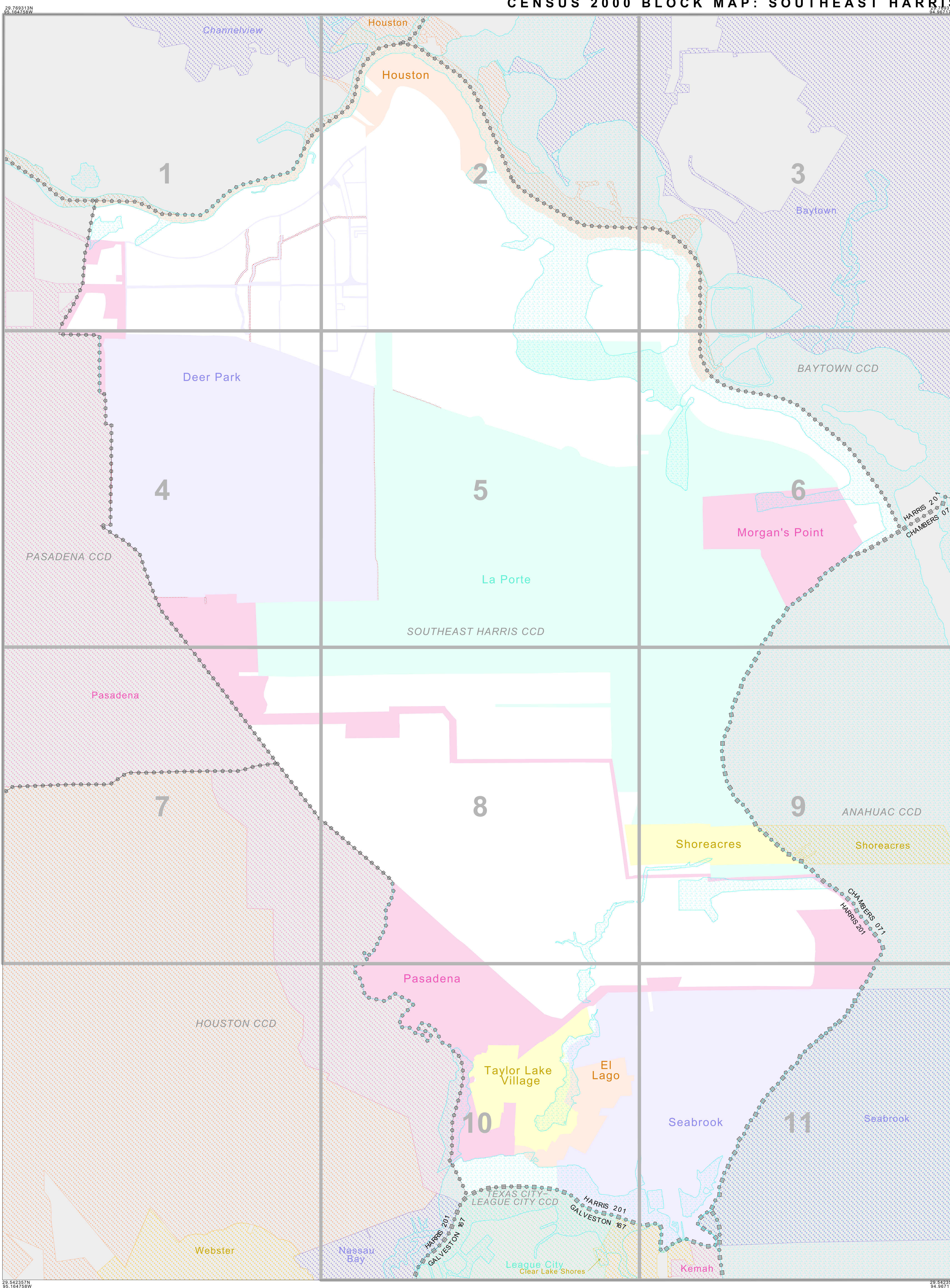


CENSUS 2000 BLOCK MAP: SOUTHEAST HARRIS CCD

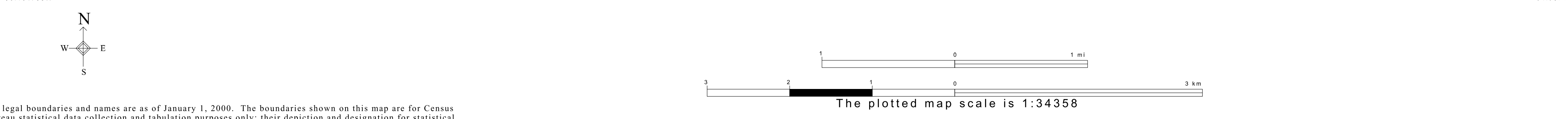
