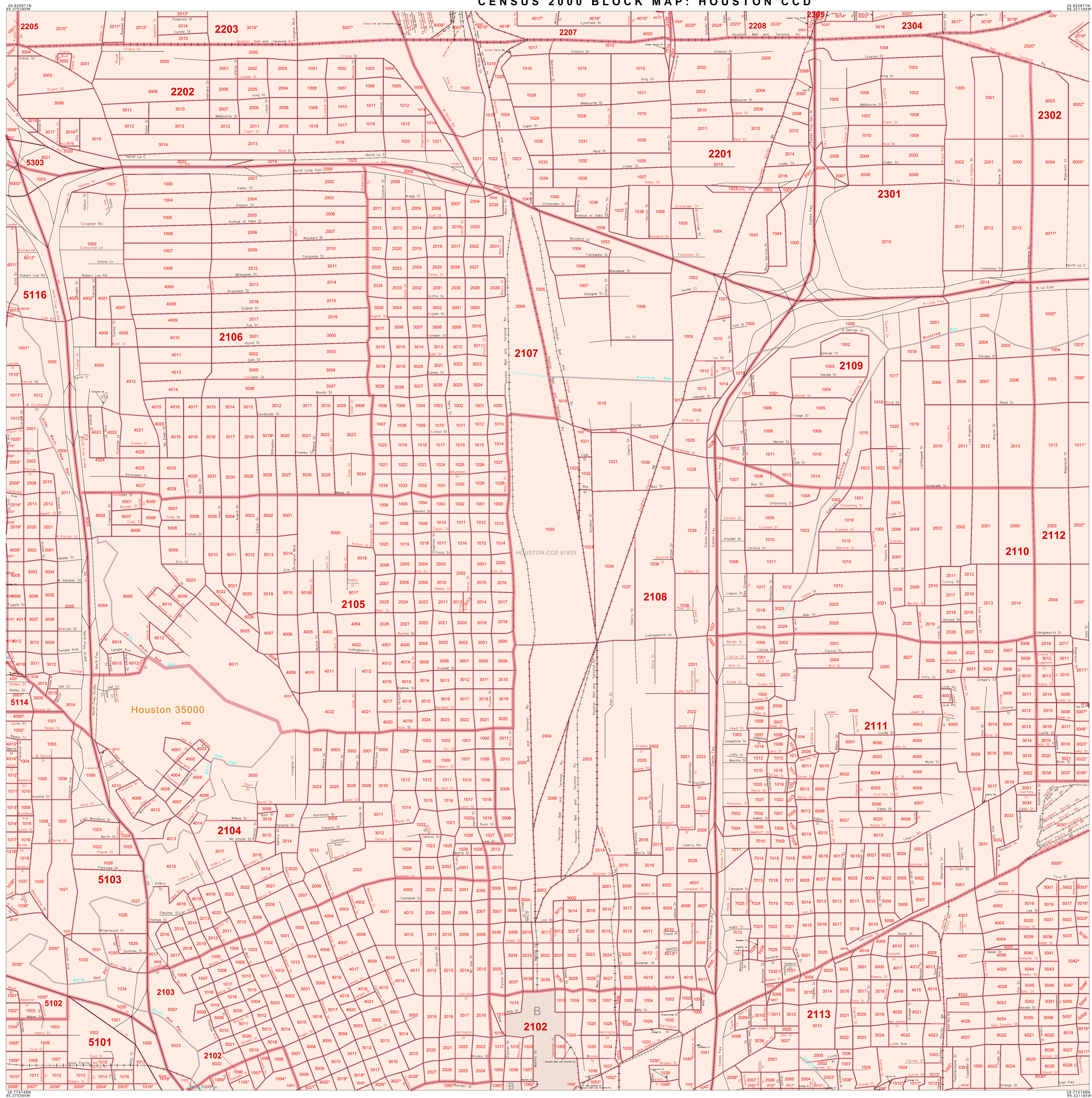


CENSUS 2000 BLOCK MAP: HOUSTON CCD

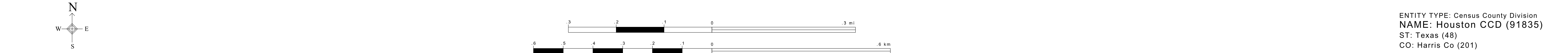
