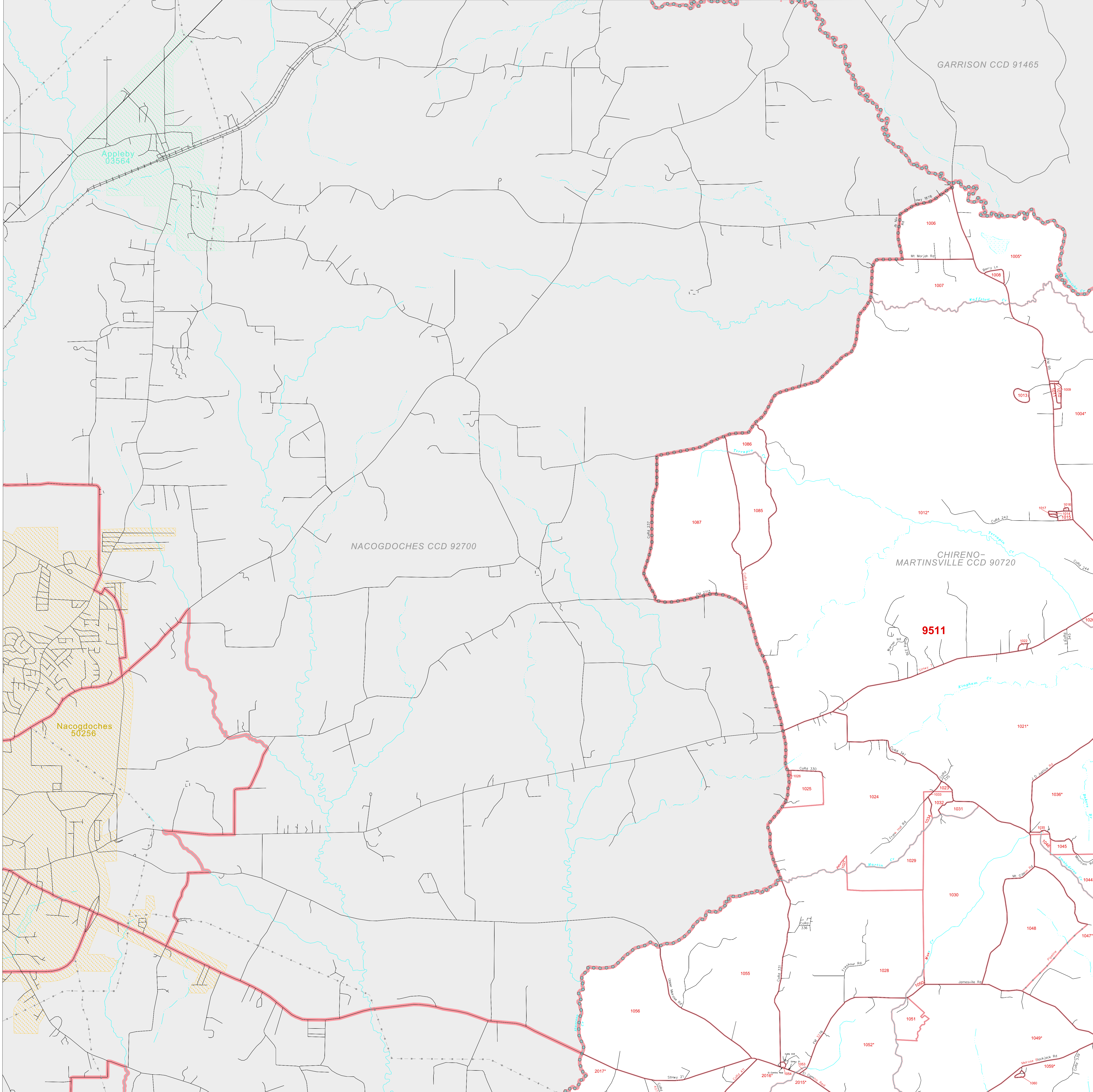


CENSUS 2000 BLOCK MAP: CHIRENO-MARTINSVILLE CCD

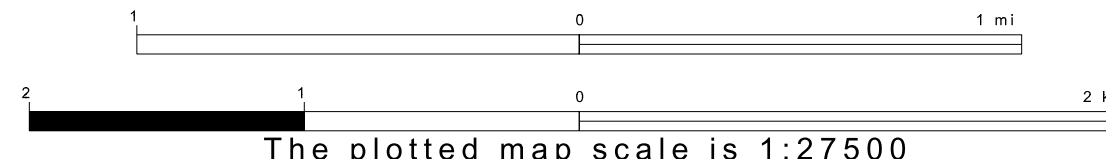
