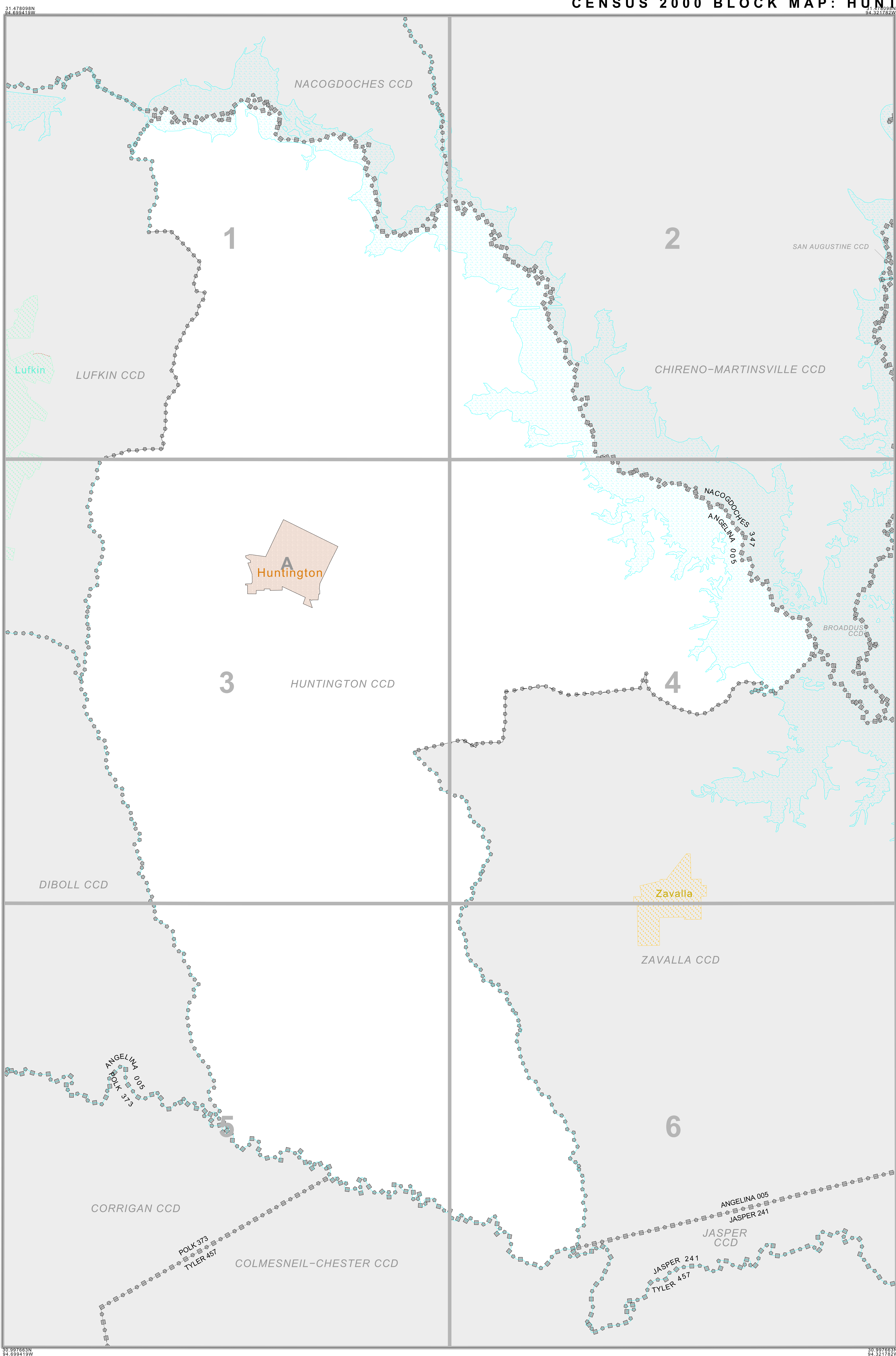


CENSUS 2000 BLOCK MAP: HUNTINGTON CCD
