A JOINT RESOLUTION

- 1 proposing a constitutional amendment to authorize a political
- 2 subdivision of this state to extend the number of days that aircraft
- 3 parts that are exempt from ad valorem taxation due to their location
- 4 in this state for a temporary period may be located in this state
- 5 for purposes of qualifying for the tax exemption.
- 6 BE IT RESOLVED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 7 SECTION 1. Section 1-j, Article VIII, Texas Constitution,
- 8 is amended by amending Subsection (a) and adding Subsection (d) to
- 9 read as follows:
- 10 (a) To promote economic development in the State, goods,
- 11 wares, merchandise, other tangible personal property, and ores,
- 12 other than oil, natural gas, and other petroleum products, are
- 13 exempt from ad valorem taxation by a political subdivision of this
- 14 State if:
- 15 (1) the property is acquired in or imported into this
- 16 State to be forwarded outside this State, whether or not the
- 17 intention to forward the property outside this State is formed or
- 18 the destination to which the property is forwarded is specified
- 19 when the property is acquired in or imported into this State;
- 20 (2) the property is detained in this State for
- 21 assembling, storing, manufacturing, processing, or fabricating
- 22 purposes by the person who acquired or imported the property; and
- 23 (3) the property is transported outside of this State
- 24 not later than:

- 1 (A) 175 days after the date the person acquired
- 2 or imported the property in this State; or
- 3 (B) if applicable, a later date established by
- 4 the governing body of the political subdivision under Subsection
- 5 (d) of this section.
- 6 (d) The governing body of a political subdivision, in the
- 7 manner provided by law for official action, may extend the date by
- 8 which aircraft parts exempted from ad valorem taxation under this
- 9 <u>section must be transported outside the State to a date not later</u>
- 10 than the 730th day after the date the person acquired or imported
- 11 the aircraft parts in this State. An extension adopted by official
- 12 action under this subsection applies only to the exemption from ad
- 13 valorem taxation by the political subdivision adopting the
- 14 extension. The legislature by general law may provide the manner by
- 15 which the governing body may extend the period of time as authorized
- 16 by this subsection.
- 17 SECTION 2. The following temporary provision is added to
- 18 the Texas Constitution:
- 19 TEMPORARY PROVISION. (a) This temporary provision applies
- 20 to the constitutional amendment proposed by the 83rd Legislature,
- 21 Regular Session, 2013, to authorize a political subdivision of this
- 22 state to extend the number of days that aircraft parts that are
- 23 exempt from ad valorem taxation due to their location in this state
- 24 for a temporary period may be located in this state for purposes of
- 25 qualifying for the tax exemption.
- 26 (b) The amendment to Section 1-j(a), Article VIII, of this
- 27 constitution and the addition of Section 1-j(d), Article VIII, to

- 1 this constitution take effect January 1, 2014, and apply only to a
- 2 tax year that begins on or after that date.
- 3 (c) This temporary provision expires January 1, 2015.
- 4 SECTION 3. This proposed constitutional amendment shall be
- 5 submitted to the voters at an election to be held November 5, 2013.
- 6 The ballot shall be printed to permit voting for or against the
- 7 proposition: "The constitutional amendment to authorize a
- 8 political subdivision of this state to extend the number of days
- 9 that aircraft parts that are exempt from ad valorem taxation due to
- 10 their location in this state for a temporary period may be located
- 11 in this state for purposes of qualifying for the tax exemption."
