21	early identification of juveniles who are victims of sex
22	trafficking for the purpose of developing a recommended set of best
23	practices that may be used by a juvenile probation department to
24	improve the juvenile probation department's ability to identify a

- 2 (c) Best practices may include:
- 3 (1) examining a juvenile's referral history, including
- 4 whether the juvenile has a history of running away from home or has
- 5 been adjudicated for previous offenses;

- 7 sexual abuse;
- 8 (3) assessing a juvenile's need for services,
- 9 including counseling through a rape crisis center or other
- 10 counseling; and
- 11 (4) asking the juvenile a series of questions designed

- 13 of sex trafficking.
- SECTION 3. Subchapter A, Chapter 221, Human Resources Code,

- 16 Sec. 221.0061. TRAUMA-INFORMED CARE TRAINING. The
- 17 department shall provide trauma-informed care training during the
- 18 preservice training the department provides for juvenile probation
- 19 officers, juvenile supervision officers, juvenile correctional
- 20 officers, and juvenile parole officers. The training must provide
- 21 knowledge, in line with best practices, of how to interact with
- 22 juveniles who have experienced traumatic events.
- SECTION 4. Subsection (b), Section 242.009, Human Resources
- 24 Code, is amended to read as follows:
- 25 (b) The department shall provide each juvenile correctional
- 26 officer employed by the department with at least 300 hours of
- 27 training, which must include on-the-job training, before the

- 9 SECTION 5. Section 414.005, Government Code, is amended to

- 14 (2) foster the detection of crime and encourage
- 15 persons to report information about criminal acts;

- 1 (A) encourages individuals to report sex
- 2 offenders who have failed to register under Chapter 62, Code of

- 7 (C) financially rewards each individual who
